Whereas, On June 29, 2008, the Council of the City of New York (the "City Council") adopted the

Fiscal 2009 Expense Budget with various programs and initiatives (the "Adopted Fiscal 2009 Budget"); and

Whereas, The City Council is hereby implementing and furthering the appropriations set forth in the

Adopted Fiscal 2009 Budget by approving Safe Horizon as a fiscal conduit for the Community-Based

Organizations receiving funds through the Domestic Violence Empowerment (DoVE) Initiative within the

Miscellaneous Budget; and

Whereas, The City Council is hereby implementing and furthering the appropriations set forth in the

Adopted Fiscal 2009 Budget by approving the new designation and changes in the designation of certain organizations receiving local, aging and youth discretionary funding, and by approving the addition of fiscal conduits for certain organizations receiving funding pursuant to certain initiatives in accordance therewith; and
