WHEREAS, the Landmarks Preservation Commission filed with the Council on January 23, 2009 a copy of its designation dated January 13, 2009 (the "Designation"), of the New York Public Library, 125th Street Branch, located at 224 East 125th Street, Community District 11, Borough of Manhattan, as a landmark and Block 1789, Lot 37, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on March 6, 2009 its report on the Designation dated March 4, 2009 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on March 31, 2009; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
