WHEREAS, the Landmarks Preservation Commission filed with the Council on February 17, 2009 a copy of its designation dated February 10, 2008 (the "Designation"), of Consolidated Edison Building, located at 4 Irving Place a.k.a. 2-12 Irving Place, 121-147 East 14th Street, 120-140 East 15th Street, Community District 6, Borough of Manhattan, as a landmark and Tax Map Block 870, Lot 24 in part, as its landmark site pursuant to Section 3020 of the New York City Charter;
