WHEREAS, the New York City School Construction Authority submitted to the Council on June 18, 2009, a site plan dated June 18, 2009 pursuant to Section 1732 of the New York State Public Authorities Law for the proposed site selection for Middle College High School at LaGuardia Community College, located on the block bounded by Van Dam Street, Queens Boulevard, 32<sup>nd</sup> Place and 47<sup>th</sup> Avenue (Tax Block 249, Tax Lot 1), Community Board No. 2, Borough of Queens, Community School District No. 24 (the "Site Plan");
