WHEREAS, the Landmarks Preservation Commission filed with the Council on November 25, 2009 a copy of its designation dated November 17, 2009 (the "Designation"), of the Paramount Hotel, located at 235-245 West 46<sup>th</sup> Street, Community District 5, Borough of Manhattan, as a landmark and Tax Map Block 1018, Lot 6, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on January 8, 2010 its report on the Designation dated January 6, 2010 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 26, 2010; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
