## THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 137

Resolution affirming the designation by the Landmarks Preservation Commission of the Perry Avenue Historic District, Borough of the Bronx, Designation List No. 424, LP-2339; (L.U. No. 45; 20105275 HKX; N 100193 HKX).

WHEREAS, the Landmarks Preservation Commission filed with the Council on December 28, 2009 a copy of its designation dated December 15, 2009 (the "Designation"), of the Perry Avenue Historic District. The district boundaries are: property bounded by a line beginning at the intersection of the northwestern curbline of Perry Avenue with a line extending southeasterly from the northeastern property line of 2987 Perry Avenue, northwesterly along said property line to the northwestern property line of 2987 Perry Avenue, southwesterly along said property lines of 2985 through 2971 Perry Avenue to the southwestern property line of 2971 Perry Avenue, southeasterly along said property line to the northwestern curbline of Perry Avenue, northeasterly along said curbline to the point of the beginning, as an historic district, Borough of the Bronx, pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on February 12, 2010, its report on the Designation dated February 10, 2010 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on March 9, 2010; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
