WHEREAS, the New York City School Construction Authority submitted to the Council on March 10, 2011, a site plan dated March 10, 2011, pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 757-Seat Primary/Intermediate School Facility, known as P.S./I.S. 314, to be located at 88-08 164<sup>th</sup> Street (Tax Block 9813, Tax Lot 33), in the Jamaica section of Queens, serving students from pre-kindergarten through eighth grade in Community School District No. 28, Borough of Queens, Community Board No. 12 (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on March 15, 2011;

WHEREAS, the Council has considered the relevant environmental issues and the Negative Declaration issued on March 8, 2011 (SEQR Project Number 11-003); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Site Plan;
