A Local Law to amend the administrative code of the city of New York, in relation to limiting the use of adhesive stickers on motor vehicles in the enforcement of alternate side of the street parking rules.

Be it enacted by the Council as follows:

Section 1. Subchapter 2 of chapter 1 of title 19 of the administrative code of the city of New York is

amended by adding a new section 19-163.2 to read as follows:

<u>§ 19-163.2</u> Limitation on the use of adhesive stickers in the enforcement of alternate side of the street parking rules. Neither the department nor the department of sanitation shall affix an adhesive sticker to any motor vehicle solely in connection with the enforcement of alternate side of the street parking rules.

§ 2. This local law shall take effect immediately.
