**Whereas,** Bills have been introduced in the New York State Legislature by the Senate Rules Committee, S.5527, and Assembly Member Silver, A.7763, "AN ACT to amend the tax law, the administrative code of the city of New York, chapter 877 of the laws of 1975, chapter 884 of the laws of 1975 and chapter 882 of the laws of 1977, relating to the imposition of certain taxes in the city of New York, in relation to postponing the expiration of certain tax rates and taxes in the city of New York".
