FISCAL YEAR 2026 PRELIMINARY BUDGET

MARCH 10, 2025

Good afternoon, Chair Gutiérrez and members of the City Council Committee on Technology. My name is Matthew Fraser, and I am the Chief Technology Officer of the City of New York. With me are Edwin Pemberton, the Office of Technology and Innovation's (OTI) Deputy Commissioner for Management and Budget, and Chantal Senatus, OTI's Deputy Commissioner for Legal Matters. Thank you for the opportunity today to speak about OTI's Fiscal Year 2026 Preliminary Budget, our recent accomplishments, and our priorities for the coming year.

Since day one of this administration, I have led the city's vast tech portfolio under Executive Order 3, which convened the city's previously disparate technology offices under one roof with a clear vision: to make government run better and expand digital equity. As the city's Chief Technology Officer, I am proud to spearhead citywide projects that democratize access to technology, improve the public's interactions with city government, and help our fellow agencies leverage tech to accomplish their missions.

One area where we have significantly improved the lives of New Yorkers is through our digital equity initiatives. Under this administration, New York City provides more residents with free internet than any other city in the nation, and supplies equitable access to devices, digital skills training, and additional support programs to ensure New Yorkers across the five boroughs are equipped to use the internet. Big Apple Connect, the nation's largest municipal subsidized broadband program, continues to provide free broadband and basic cable access to over 330,000 New Yorkers in 220 NYCHA sites.

Just last week, we unveiled the NYC Digital Equity Roadmap, a dedicated program of initiatives and investments designed to ensure safe and equitable access to broadband internet service, and the skills and support to use it. This thoughtfully researched report, which includes contributions from several other agencies, fully takes stock of the resources the city has to tackle the digital divide, while proposing short- and long-term initiatives to build on existing programs. Notably, we are making a \$2.4 million investment to upgrade technology in older adult centers, libraries, and the NYCHA Digital Van program. Additionally, we intend to release a request for expressions of interest (RFEI) to further explore how public infrastructure can improve digital equity outcomes. We will also leverage existing partnerships to expand programs that provide devices and skills training, and will create opportunities for robust coordination through a Digital

Equity Working Group led by a new Chief Digital Equity Officer at OTI. I look forward to partnering with the Council to accomplish these goals.

Our commitment to setting milestones and fulfilling them is evident through the progress made through the NYC Artificial Intelligence (AI) Action Plan, the nation's first broad AI governance plan. This pioneering effort provides city agencies the necessary framework to evaluate AI tools and associated risks, helps city government employees build knowledge and skills, and supports implementation of these tools to benefit New Yorkers. Within a year of its launch, we exceeded our own expectations by starting or completing 31 of 37 actions. We have published guiding policy documents, and established an AI Steering Committee and an AI Advisory Network of experts from private industry, higher education, and non-profits. These efforts ensure that our city agencies have the framework to responsibly and effectively use AI to better serve New Yorkers.

This month, we will celebrate the second anniversary of the launch of MyCity, our one-stop shop for essential city services and benefits. The site features impactful, public-facing programs including a simplified child care subsidy application, a redesigned JobsNYC website, and an improved Business site. We also have created a common services portal within MyCity that will allow other city agencies to integrate systems into the MyCity umbrella. Most recently, we launched a benefits screening tool that allows account holders to opt-in for screening for eligibility for additional services.

In addition, we are pursuing innovative opportunities to save taxpayer dollars. Our recent announcement of T-Mobile as the major wireless carrier for the City of New York leverages the city's bulk purchasing power, rather than individual agencies negotiating their own contracts, to achieve millions of dollars in annual savings on the cost of city-issued mobile devices. This deal will also bolster the city's public safety network and will make mobile plans more affordable for city employees.

Before I get into the budget numbers, I want to highlight OTI's success in promoting Minority and Women-owned Business Enterprises (M/WBEs). In Fiscal Year 2024, OTI processed 246 M/WBE procurements totaling more than \$83.4 million in contracts. We also made the most frequent use of any agency of the M/WBE Noncompetitive Small Purchase method, capitalizing on the evolution of citywide policies and initiatives in recent years to diversify the businesses and business owners receiving contracts from city agencies.

Finally, I'd like to briefly summarize OTI's budget. OTI's Fiscal Year 2026 Preliminary Budget allocates approximately \$743.2 million in expense funds. Of this, approximately \$176.9 million

are for Personnel Services (PS) to support 1,545 full-time positions; and \$566.3million are for Other than Personnel Services (OTPS).

This Preliminary Budget had a net increase of \$75.7 million for Fiscal Year 2026. The PS Expense budget increased by 35 positions and the OTPS Expense budget increase was largely attributed to the Asylum Seeker program, Childcare Programs map and grant funding. Our Capital funding for Fiscal Year 2026 totals \$203 million for projects related to IT Modernization, Cyber Security, 311 and Emergency Communication system upgrades. The Fiscal Year 2026 Preliminary Budget revenue plan is approximately \$141.4 million.

Testimony on Broadband Affordability and Public Computer Access

Chairperson Gutiérrez and Members of the New York City Council Committee on Technology,

My name is Kevin Ly, and I am a resident of Forest Hills, Queens. I appreciate the opportunity to submit written testimony on two pressing digital equity issues affecting New Yorkers:

1. Broadband Affordability and Accessibility

Broadband internet is no longer a luxury—it is a necessity. However, many New Yorkers, including myself, are facing disproportionately high costs for high-speed internet services. As a loyal Verizon customer, I currently pay \$99 per month for a 1GB broadband plan for my family of four. Despite repeated complaints and inquiries, there has been no effort to reduce costs, expand service offerings, or ensure equitable access across all five boroughs. This issue disproportionately impacts families who rely on high-speed internet for work, education, and daily needs.

New York City must do more to ensure that all residents have access to affordable, high-quality broadband. I urge this Committee to investigate why the city is not receiving its fair share of 1GB and 2GB broadband services at competitive rates, and to take steps to regulate pricing or negotiate better service options for all residents.

2. Insufficient Public Computer Access at Queens Public Library - North Forest Park Branch

Public libraries are a critical resource for digital access, particularly for families, students, and older adults who may not have computers at home. However, the North Forest Park Branch of the Queens Public Library (98-27 Metropolitan Ave, Forest Hills, NY 11375) lacks sufficient computers for public use. This shortage is particularly concerning for toddlers and young children who rely on early exposure to digital learning tools.

I urge the Committee to allocate additional funding for public computer stations at this and other underserved branches to ensure that all children and families have access to the technology they need to succeed.

Conclusion

Access to affordable broadband and public digital resources is essential for closing the digital divide in New York City. I respectfully urge this Committee to take action by:

1. Investigating and addressing the affordability and accessibility of high-speed broadband across the five boroughs.
2. Allocating funding to increase the number of computers available at public libraries, particularly in underserved communities.

Thank you for your time and consideration. I look forward to your leadership in addressing these critical issues.

DIRECTED ENERGY WEAPONS:

—such as lasers—use energy fired at the speed of light. These weapons can produce force that ranges from deterrent, to damaging, to destructive. Many countries, including the U.S., are researching their use.

Because they use energy instead of bullets or missiles, directed energy weapons could be less expensive per shot and have virtually unlimited firing power.

However, the long-term health effects of these weapons are unclear. They also generally have a shorter range than conventional weapons, and weather conditions—such as fog and storms—can make certain directed energy weapons less effective

The Technology

What is it? Directed energy weapons (DEW) use concentrated electromagnetic energy to combat enemy forces and assets. These weapons include high energy lasers and other high power electromagnetics—such as millimeter wave and high power microwave weapons. Unlike weapons that fire bullets or missiles, DEWs can respond to a threat in different ways. For example, they can temporarily degrade electronics on a drone or physically destroy it.

How does it work? Each type of DEW uses a different region of the electromagnetic spectrum. This spectrum describes all of the kinds of light—including those the human eye cannot see—and classifies them according to wavelength. Different types of electromagnetic energy have different properties. For example, the wavelength affects what the directed energy can penetrate—such as metal or human skin.

All DEWs emit energy at the speed of light, and are often discussed in terms of their power output—the amount of electromagnetic energy transferred over time. While DEWs use electromagnetic energy similar to everyday items, such as household microwaves, their power output is vastly higher, as described below.

High energy lasers produce a very narrow beam of light, usually in the infrared to visible region, and are typically used on one target at a time. The beam can be pulsed or continuous, generating a power output of at least 1 kilowatt. This output is 200,000 times greater than a typical laser pointer and is capable of melting steel.

Millimeter wave weapons have wavelengths between 1 and 10 millimeters and generate more than 1 kilowatt of power. Millimeter wave weapons have a larger beam size than high energy lasers and therefore can affect multiple targets at once.

High power microwave weapons produce microwaves, which have longer wavelengths

than high energy lasers and millimeter wave weapons. These weapons can produce more than 100 megawatts of power, which is nearly 150,000 times more powerful than the average household microwave. Like millimeter wave weapons, they can also affect multiple targets because of their larger beam size.

Each DEW can produce a range of effects from nonlethal to lethal, depending on factors such as the time on target, the distance to the target, and even the part of the target on which the DEW is focused. DEWs can use this range of effects to graduate responses to a threat. A graduated response could start with temporarily preventing use of an asset or its access to an area and increase to destruction of the asset if necessary. DEWs can deny entrance to an area or prevent enemy forces or assets from functioning within an area. DEWs used for denial do not cause long-term damage to targets, and when enemy forces or assets leave the area, they typically regain function or the effect is mitigated. For example, the Department of Defense's (DOD) Active Denial System uses millimeter waves that interact with the water and fat molecules in a person's skin to create a heating sensation. During testing, the discomfort persuaded individuals to move away from the area.

DEWs can also degrade the efficacy of an enemy's assets. For example, high energy lasers can temporarily overwhelm a person or a sensor's ability to see or sense by emitting a glare—called dazzling. Dazzling can act as a non-verbal warning before resorting to increased force.

If a greater amount of force is required, DEWs can also damage or destroy enemy assets. To do this, a high energy laser can emit electromagnetic energy with a wavelength the target material absorbs most effectively, melting the material. The laser could focus on a sensor and damage a drone, or focus on a fuel tank or battery and destroy it.

How mature is it? DEWs range in maturity from research projects to prototypes tested in the field. DOD named DEWs as a technology critical to enabling the 2018 National Defense Strategy and reported spending about \$1 billion annually for the last 3 years on research and development. The U.S. military has tested a variety of DEW prototypes since 2014, primarily for counter-drone missions. For example, the Air Force's prototype Tactical High Power Microwave Operational Responder (THOR) recently completed 2 years of testing. DOD is researching ways to increase the power output of DEWs to engage more powerful targets—like missiles. However, as GAO recently reported, the U.S. military faces challenges bridging the gap between DEW development and acquisition, potentially limiting widespread use. Why now? DEW research and development has been ongoing for decades in many countries—including the U.S.—and is currently experiencing a surge worldwide. This surge stems in part from advances in technology and a desire to maintain competitiveness on the battlefield. Technological innovations, such as the development of smaller lasers that are safer to operate, enable modern DEWs to be much more portable and practical. For example, a four-wheel all-terrain vehicle can now hold a high energy laser powerful enough to damage drones. The U.S. and 30 other nations are developing DEWs, most for counter-drone missions, according to a 2021 Air Force report. Complement to conventional weapons. DEWs use energy fired at the speed of light, making them faster and potentially less costly per shot than missiles. Some DEWs have virtually unlimited ammunition and can fire as long as they have power.

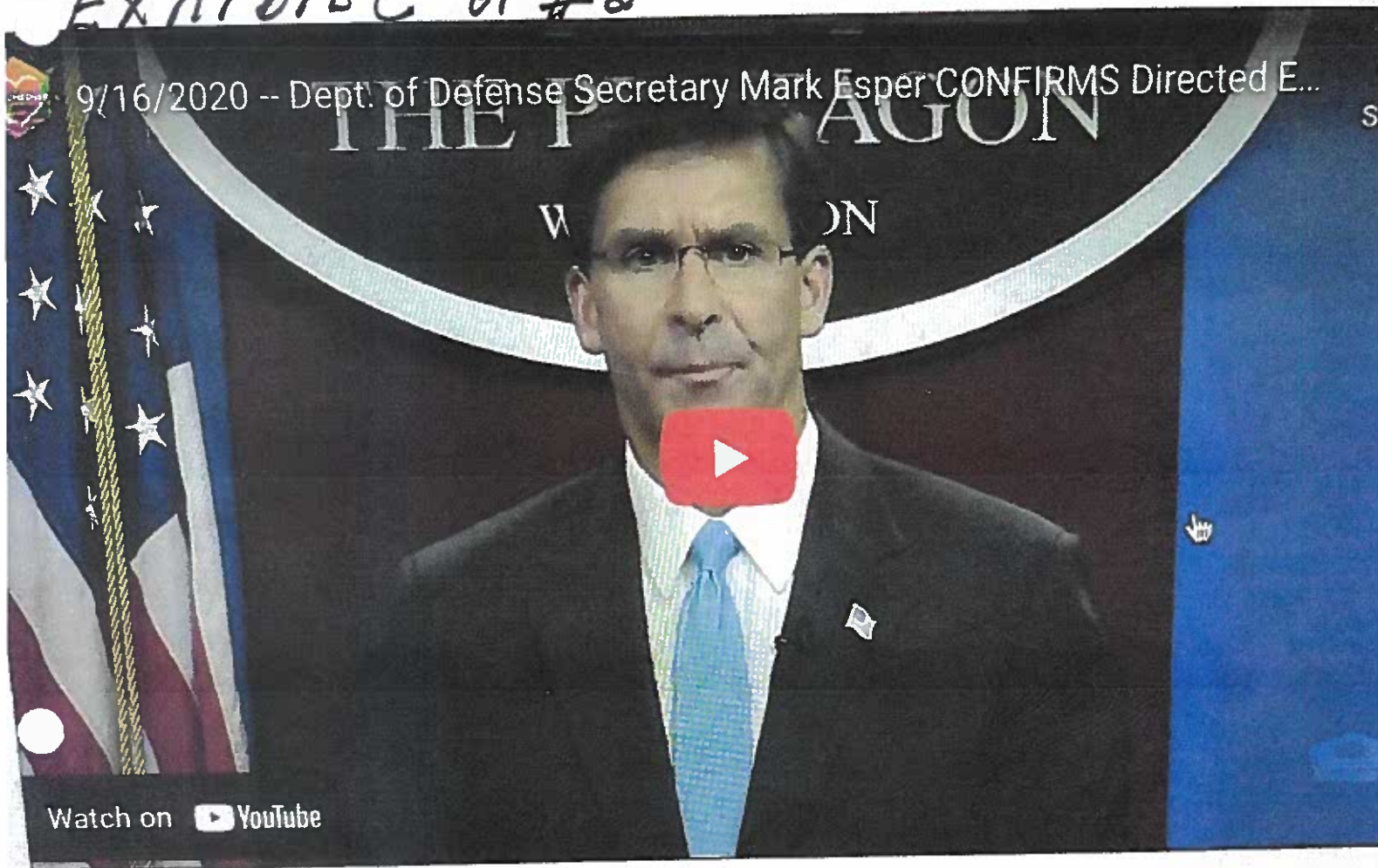
Ease of graduated response. DOD can tailor DEWs to meet mission needs from nonlethal

to lethal responses. For example, the longer a laser is focused on target, the more damage or destruction will occur.

Advancing other uses. Research and development for DEWs could also benefit civilian uses. For example, the development of higher energy lasers could help projects that use directed energy to transport or "beam" power to remote and disadvantaged locations.
