Introduced by Council Members Maloney and Eisland (by request of the Mayor); also Council Members Alter, Friedlander, Harrison, Michels, Horwitz, Albanese and McCaffrey. (Passed under a Message of Necessity from the Mayor.)

A LOCAL LAW

To amend the Administrative Code of the City of New York, and local law 46 for the year 1989, relating to a demonstration program for traffic-control signal violations, in relation to reporting the results and providing for the expiration of such program.

Be it enacted by the Council as follows:

Section 1. Subdivision o of section 19-210 of the administrative code of the city of New York, as added by local law number 46 for the year 1989, is amended to read as follows:

- (o) The commissioner shall submit to the governor, the temporary president of the senate, speaker of the assembly and the council a report on the results of the use of a traffic-control signal violation-monitoring system on or before March first, nineteen hundred [ninety-one] ninety-three. Such report shall include, but not be limited to:
- 1. a description of the locations where traffic-control signal photo monitoring systems were used:
- 2. the number of violations recorded at each intersection and in the aggregate on a daily, weekly and monthly basis;
 - 3. the total number of notices of liability issued;
 - 4. the number of fines and total amount of fines paid after first notice of liability;
- 5. the number of violations adjudicated and results of such adjudications including breakdowns of dispositions made;
 - 6. the total amount of revenue realized by such city; and
 - 7. quality of the adjudication process and its results.
- § 2. Section two of local law number 46 for the year 1989 is amended to read as follows.
- § 2. This local law shall take effect immediately and shall expire on December 26, [1991] 1993.
- § 3. This local law shall take effect [immediately] on December 26, 1991, except that if it shall have become a law subsequent to such day, this local law shall be retroactive to December 26, 1991.
