**Proposed Intro No. / Title:** *Int. 1243 / Creating uniform emergency response maps for city properties*

**Sponsors:** Salamanca, Ariola and Banks

**Committee:** Fire and Emergency Management

**Summary of Legislation:** This legislation would require the Office of Emergency Management (NYCEM) to create uniform emergency response maps for all city properties. Maps for each designated city property shall be prepared, maintained and viewable in formats that integrate with emergency response software platforms and applicable technologies. Such properties may be exempted, where deemed impracticable or unduly burdensome and/or public safety impacts are unsubstantial.

**Effective Date:** Immediately upon enactment

**First Fiscal Year Legislation Takes Effect:** Fiscal Year 2026

**First Fiscal Year with Full Impact:** Fiscal Year 2026

**Agencies Impacted:** Office of Emergency Management
