18 Member Sanchez, Council Member Riley, Council Member
19 Feliz, Council Member Farias, Council Member
20 Dinowitz.

21 This public meeting is the Delegation
22 convening pursuant of Section 103 of the Public
23 Officers Law to conduct the following business.

24 Pursuant to Section 2301 of New York City
25 Charter, we will vote to recommend Yves Filius for

2 appointment by the Mayor of New York City to the Taxi
3 and Limousine Commission. If nominated by the Mayor,
4 the appointee Filius will be subject to advance a
5 consent of full Council.

6 Before our vote, I will invite my
7 Colleagues to offer statements on the nomination
8 before us.

9 There being no more Members of the
10 Delegation who wish to speak, the Clerk can now call
11 the roll.

9 roll open at request of the Co-Chairs.
