Summary of Legislation: Requires the New York Police Department (NYPD) to have towing capacity sufficient to meet the department's enforcement needs. Such towing capacity shall reflect the rate of violations that are subject to towing, and the rate of vehicle impoundment necessary to deter illegal conduct. NYPD is also required to issue annual reports on tow facility capacity and the department's utilization of vehicle towing in response to violations of traffic laws. The reports must be issued within 30 days of the start of each calendar year.

Effective Date: 180 days after enactment
