Proposed Intro No. / Title: Int 483 / Program to provide public access to wireless networks

Sponsors: Won, Menin, Gutiérrez, Restler, Brewer, Hanif, Louis and Brooks-Powers

Committee: Technology

Summary of Legislation: This bill would require the Mayor's Office of Operations to coordinate with the Department of Citywide Administrative Services, the Office of Cyber Command, and the Department of Information Technology and Telecommunications to submit a report on wireless networks used by city agencies and establish a program whereby city agencies provide wireless network access for the public. The plan would identify agencies that are capable of providing secure wireless network access and are able to provide space in a publicly accessible area for individuals. Each agency identified in the plan must indicate at least one location in a publicly accessible area that can be used by individuals to access the agency's secure wireless network, steps the agency will take to ensure the wireless network connection is secure and accessible; any changes or updates that have been or will be made to the agency's wireless network that could impact its security or accessibility; and any obstacles to providing public access to the wireless network used by the agency. With 60 days of finalization, implicated agencies must implement the plan to provide wireless network access.
