Proposed Intro No. / Title: *Int. 1345 / Providing notice to home and business owners regarding new bus stops*

Sponsors: Brooks-Powers, Banks, Louis and Brannan

Committee: Transportation and Infrastructure

Summary of Legislation: This legislation would require the Department of Transportation (DOT) to coordinate with the Metropolitan Transportation Authority to provide notice to homeowners and businesses when a bus stop will be created or removed within 50 feet of them, as practicable. DOT must provide the notice by sending a letter to the relevant homes and business owners, posting a flyer on the front door of each home and business, and posting signage at the location of where the new bus stop will be located or the existing bus stop will be removed, as practicable.
