3 morning everybody and welcome to the Subcommittee
4 on Planning, Dispositions and Concessions. This
5 is a Subcommittee of the Land Use Committee of the
6 New York City Council. My name is Dan Garodnick
7 and I have the privilege of chairing the Planning
8 Subcommittee. I'm joined by Subcommittee members
9 Inez Dickens and Sara Gonzalez as well as other
10 distinguished members of the--I'm sorry Vinnie
11 Ignizio, other distinguished members of the full
12 Land Use Committee who will be introduced in a

15 of this Land Use Subcommittee because we only have
16 one item and we've already had the hearing on the
17 subject. This is Land Use numbers 1109, just Land
18 Used 1109, non-ULURP number 20095572HAM. This is
19 a 63 Thompson Street in Manhattan. It is part of
20 the substantial rehabilitation program of HPD. We
21 heard from HPD at our last meeting. And this of
22 course is project in the District of Speaker
23 Christine Quinn who has indicated her support of
24 this project. And unless there are any comments
25 from colleagues, I will ask the Counsel to call
