

TESTIMONY OF THE LANDMARKS PRESERVATION COMMISSION BEFORE THE CITY COUNCIL SUBCOMMITTEE ON LANDMARKS, PUBLIC SITING AND MARITIME USES ON THE MODIFICATION OF THE DESIGNATION OF THE NEW YORK AND LONG ISLAND COIGNET STONE COMPANY BUILDING IN BROOKLYN.

April 3, 2012

Good morning Council Members. My name is Jenny Fernández, Director of Intergovernmental and Community Relations for the Landmarks Preservation Commission. I am here today to testify on the Commission's modification of the designation of the New York and Long Island Coignet Stone Company Building in Brooklyn.

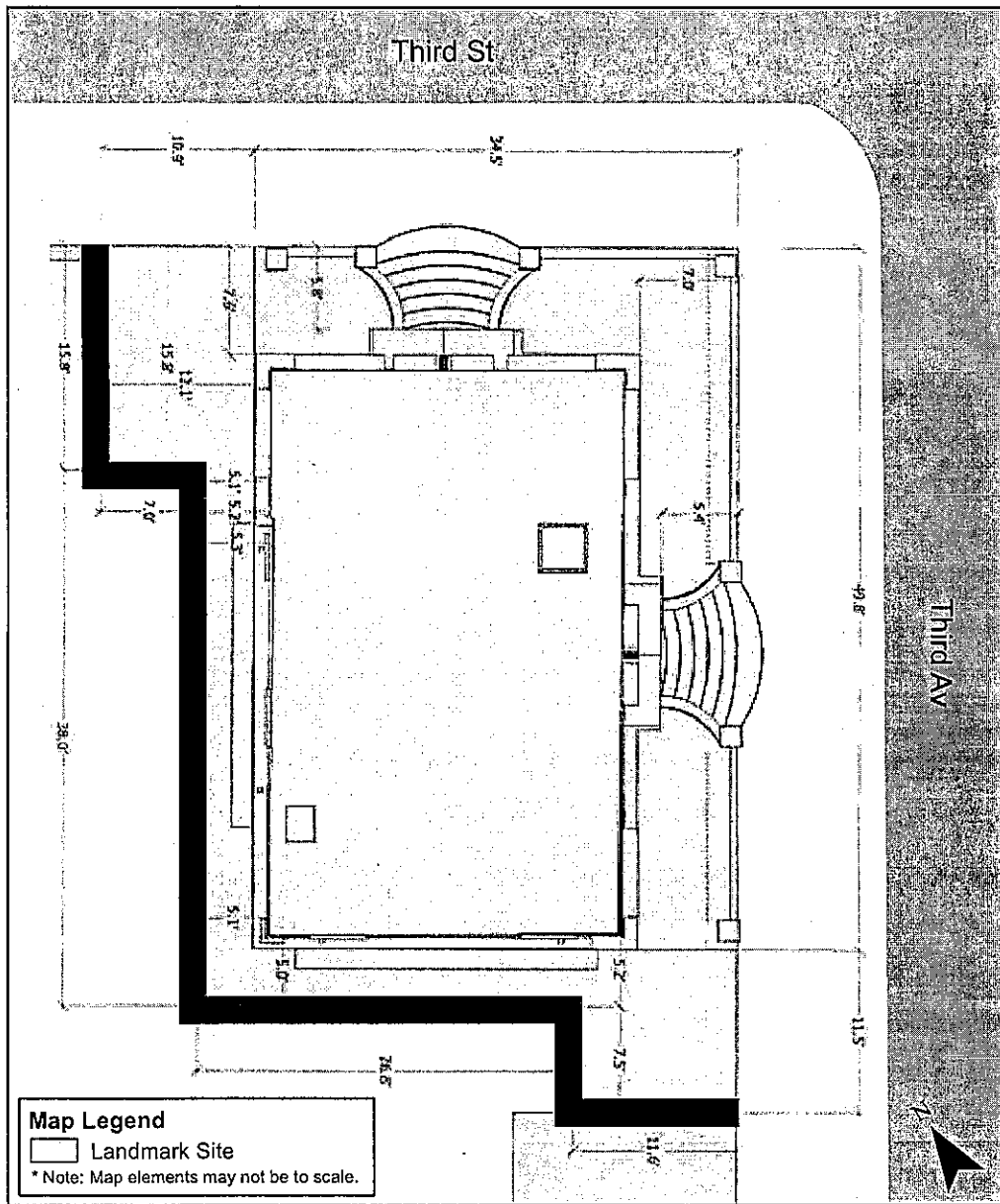
On June 27, 2006 the Landmarks Preservation Commission designated as a Landmark the New York and Long Island Coignet Stone Company Building, located at 360 Third Avenue in Brooklyn. The landmark site was the existing Lot 7. Lot 7 was, and is, part of a much larger site that Whole Foods was planning on developing as a supermarket. Subsequently, the Commission received a request from Whole Foods to modify the boundaries of the landmark site to make it consistent with the proposed supermarket design. Without the modification, a part of the Whole Foods building would be constructed on the landmark site. This would result in the LPC having to review and approve the design of the new building as well as future work occurring throughout the supermarket.

On December 20, 2011, the Landmarks Preservation Commission held a public hearing to consider the reduction of the boundaries of the Landmark site. Seven people testified in opposition to the boundary modification, including representatives of FROGG (Friends and Residents of Greater Gowanus), the Historic Districts Council, and the Society for the Architecture of the City. One person, representing the owner, spoke in support of the modification. The Commission also received a letter from Brooklyn Borough President Marty Markowitz supporting modification. On January 24, 2012, based on a discussion, nine commissioners voted unanimously to modify the Landmark Site, from Brooklyn Borough Tax Map Block 978, Lot 7, to Borough of Brooklyn Tax Map Block 978, Lot 7 in part.

Some neighborhood and preservation groups have opposed the modification. However, it is not unusual for the Commission to designate only part of a large lot, if regulation of the lot is unnecessary for preserving the building being designated. Usually, however, the request to designate only a portion of a lot is considered at the time of the original designation. Here, as Whole Foods explained at the LPC hearing, because it had tentative approval for a lot subdivision Whole Foods didn't realize that the LPC was proposing to designate the existing lot 7 instead of the smaller tentatively approved lot 7. Once it realized the mistake Whole Foods made its request to the LPC.

The Commissioners found that the proposed boundaries would preserve the setting of the building as a stand alone structure, would permit views of the side facades and would provide adequate space to ensure that the building could be maintained. A map of the new landmark site is appended hereto.

The Commission urges you to affirm this modification.



NEW YORK AND LONG ISLAND COIGNET STONE COMPANY BUILDING (LATER OFFICE OF BROOKLYN IMPROVEMENT COMPANY) (LP-2202), 360 Third Avenue (aka 370 Third Avenue, 230 Third Street). Landmark Site: Formerly Borough of Brooklyn Tax Map Block 978, Lot 7, now Lot 7 in part, consisting of that portion of said lot bounded by a line beginning at the northeast corner of the lot and extending northwesterly along the lot line for approximately 45 feet 3 inches, southwesterly at an angle of 90 degrees approximately 15 feet 8 inches, easterly at an angle of 90 degrees for approximately 7 feet, southwesterly at an angle of 90 degrees for approximately 38 feet, easterly at an angle of 90 degrees for approximately 26 feet 8 inches, southwesterly at an angle of 90 degrees for approximately 7 feet 5 inches, easterly at an angle of 90 degrees to the lot line fronting on Third Avenue, northeasterly along said lot line to the point of beginning.

RE: Summary of proposed landmark designation amendment at 3rd Avenue and 3rd Street in Brooklyn

The New York City Council is now considering the Landmarks Preservation Commission's proposed modification of their designation of the New York and Long Island Coignet Stone Company Building (the "Coignet Building") located at the corner of 3rd Avenue and 3rd Street in Brooklyn. This modification has already been unanimously approved by the full Landmarks Preservation Commission, is supported by Councilmember Sara M. Gonzalez and Brooklyn Borough President Marty Markowitz and was unanimously approved by Community Board #6. It also has the support of community groups including the Gowanus Alliance and the Gowanus Canal Community Development Corporation.

Specifically, the LPC will be reducing the land area covered by the landmark designation from the current whole tax lot 7 (which includes the building and surrounding open land under separate ownership) to the tentative tax lot 7 and a small open area surrounding the building. They took this extraordinary action to allow the development of the proposed Whole Foods Market to proceed.

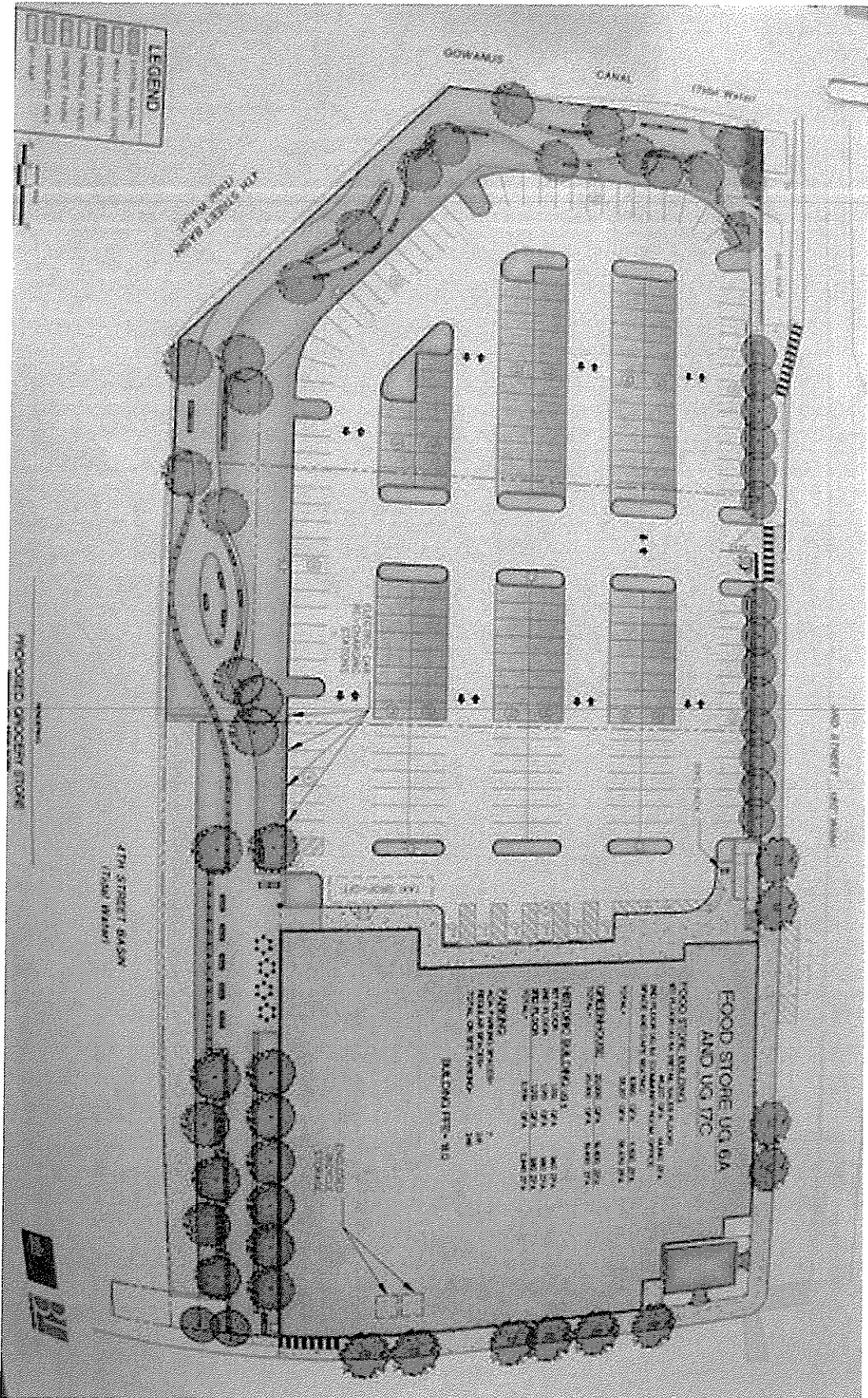
History

Whole Foods began working on this project in the early 2000's and had agreements to purchase portions of the land upon which the Coignet Building is located. In order to effectuate the property transfer, the tax lot was required to be subdivided along the proposed property lines. An application was filed and approved with the Department of Finance in September of 2004 to create new tax lots, reducing the area of Lot 7 and merging portions of Lot 7 and Lot 1 with Lots 16 and 19. This application created a new tentative lot 7 (p/o the original lot 7) and tentative lot 16 (p/o lots 1, 7, 16 and 19) and tentative lot 1 (p/o original lot 1). The tentative tax lots were approved by the Department of Finance on September 24, 2004. As is customary with projects undergoing development, the tax lots were not finalized and remained in a tentative form. This condition generally lasts until the Department of Buildings signs off on the Certificate of Occupancy for a new project. As this project was under development, the tax lot subdivisions were not finalized.

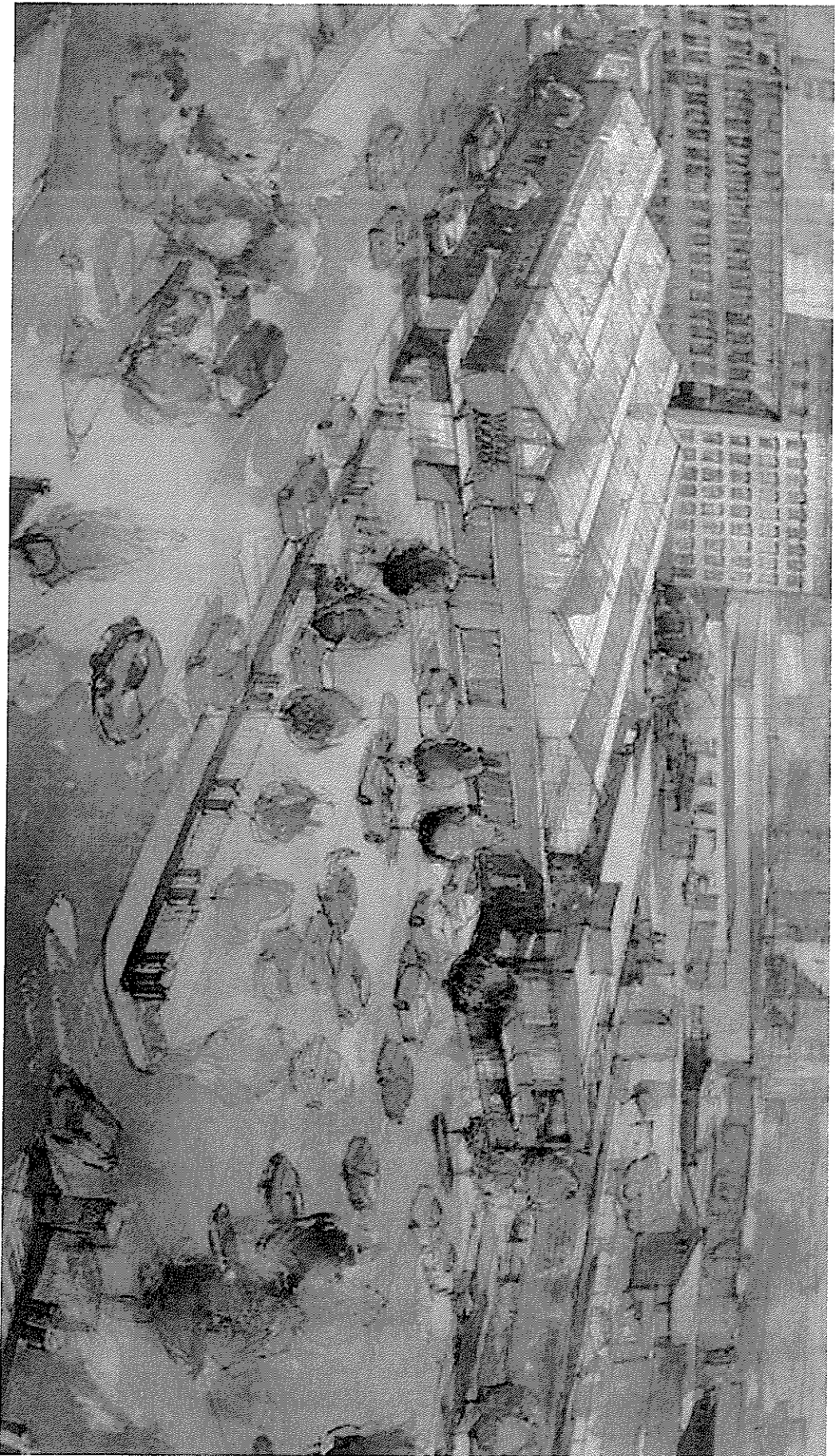
WFM purchased the properties with the tentative tax lot designation (p/o lots 1 and 7, 16 and 19 – tentative Lot 16) in May 2005 and project development continued. The Coignet Building remained on the reduced tentative tax lot 7. LPC designated the New York and Long Island Coignet Stone Company Building as a NYC Landmark in June of 2006, listing the designation on the whole tax lot 7 which includes land owned by WFM and will be occupied by the WFM building.

Conclusion

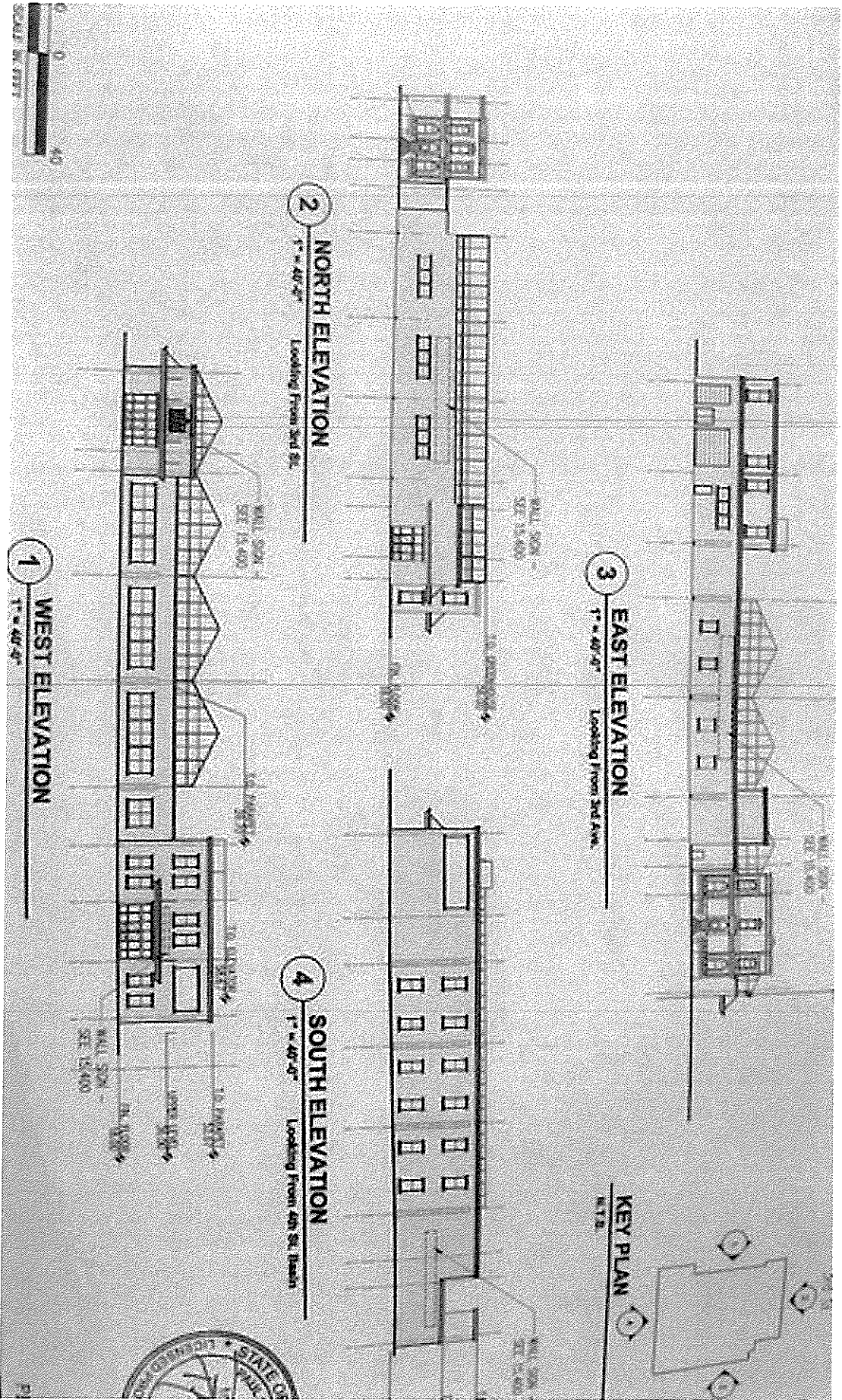
Therefore, the above-detailed modification is essentially a technical "clean up" of the landmarking designation, which occurred because of the unique and unanticipated sequence of activities outlined above. This modification will have absolutely no impact on the landmark protection of the Coignet Building, and, in fact, extends the boundary/buffer around the building an additional five feet beyond the plans originally received so positively by the community.

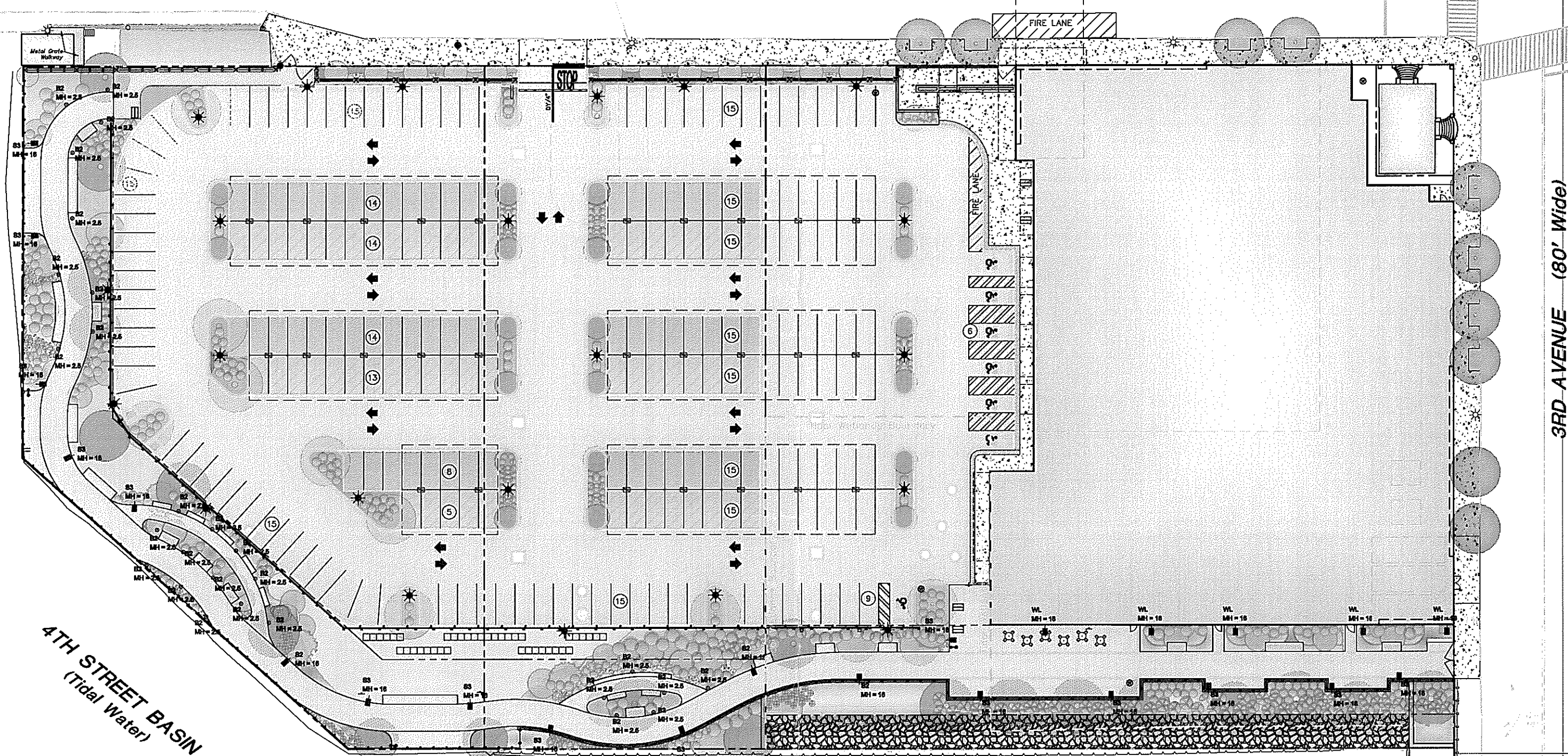

Letter: Greetings,

I just signed the following petition addressed to: New York City Council.

Preserve the Landmark Designation of the Coignet Building

The owner of the property, Whole Foods, is asking to be granted a special dispensation from the New York City Landmarks Law that governs the landmark Coignet Building on the intersection of Third Street and Third Avenue in Gowanus.

Whole Foods wants to annex part of the Coignet building site so that they could build the big-box retail store on it without any consideration given to how that new structure will impose itself on the designated landmark building.

The Coignet building must be given the proper protection it currently has under the Landmarks Law. Whole Foods should comply with this law just as any owner of a landmark is required to. Whole Foods must make a proper Landmarks Public Hearing that shows just how their proposed development will relate to the Coignet Building.

If Whole Foods is allowed to alter the landmark site in order to avoid the normal Landmarks Preservation Commission review process, this will opens the way for all who want to build upon a landmarked site and avoid any LPC oversight. Maybe St Bart's Church can request a "Whole Foods" ruling and start building that glass tower they wanted to cantilever on their landmark church site 30 years ago.

We ask that City Council not damage Landmark Law by allowing any developer to manipulate and thus avoid the law in this manner.
