Impact Statement for the proposed Gun Hill Road
Electric Bus Depot Charging Facility.

Proposed Introduction Number 1105-A would 5 require the Department of Transportation to provide a 6 7 description of all planned street plan projects whenever they submit their annual update and create a 8 9 tracker to monitor the progress of these projects throughout the year. This bill will dramatically 10 11 improve transparency and help ensure that the administration meets its legal mandates. 12

Proposed Introduction Number 1114-A, would require the Commissioner of Transportation to create and maintain an online capital project tracker to provide detailed information on their pending capital projects.
