2 CHAIRPERSON AVELLA: Good morning
3 everyone. I'd like to reconvene this meeting of
4 the Subcommittee on Zoning and Franchises. We had
5 recessed the meeting in order to give the Speaker
6 more time to discuss the Hudson Yards Text
7 Amendment. The Speaker's asked that it be laid
8 over again to, what meeting is that, the August
9 meeting? The August meeting. So at this point I
10 will gavel in and get--

12 CHAIRPERSON AVELLA: August 13th
13 meeting. And before I close the meeting out, I'd
14 like to call on Mike McMann to cast his vote for
15 the previous items.

16 MR. MARTIN: Council Member McMann.

17 COUNCIL MEMBER MCMANN: Thank you
18 Mr. Chairman, I vote aye.

19 CHAIRPERSON AVELLA: By a vote of
20 seven in the affirmative, none in the negative, no
21 abstentions, all items are referred to the full
22 Land Use Committee.

23 CHAIRPERSON AVELLA: That closes
24 this meeting of the Subcommittee on Zoning and
25 Franchises.

2 CHAIRPERSON KATZ: If everyone can
3 hang around, we will do Land Use as soon as we
4 can. We need a quorum and also on of the items in
5 the Speaker's District, we are still discussing.
6 So we'll be back in a few minutes. Thanks.

7 [Pause]

8 CHAIRPERSON KATZ: One item that is
9 still going to be postponed until tomorrow, that
10 is the Hudson Square North rezoning. The member
11 whose District is it in, who happens to be Speaker
12 Quinn, has asked for it to be postponed until
13 tomorrow. So we will do that.

14 Number two, we are closing the
15 meeting today and reopening another--

16 [Gavel banging]

17 CHAIRPERSON KATZ: --and reopening
18 another meeting for tomorrow. So if there's
19 anybody in the vicinity that thinks they're going
20 to vote tomorrow and you know that they're around,
21 please text message them or let them know, they
22 will not be able to vote tomorrow on today's
23 agenda for some technical reasons of resolutions
24 for tomorrow. So we are closing the meeting
25 today. We'll reopen it tomorrow for the Hudson

2 Square North rezoning which has to be voted on
3 either way tomorrow. All right?

4 So today, Hudson Square North
5 rezoning C070575 CMM will be postponed until
6 tomorrow's vote, which by the way we're figuring
7 out what time now according to availability.

8 Pier A lease is in Council Member
9 Gerson's District. It is a lease agreement for
10 the redevelopment of Pier A. LU Number 773 is the
11 Heritage House; it is in Council Member Dickens'
12 District. It is a UDAAP project to facilitate the
13 development of a 6-story building with 40 rentals.
14 LU Number 826, Council Member Gerson's District,
15 is an East River Waterfront; it is a text
16 amendment to facilitate the development of the
17 East River Waterfront Park.

18 LU Number 828 is in Council Member
19 Arroyo's District. It is St. Ann's Avenue
20 Development, a zoning map change in the Bronx for
21 mixed use buildings, 618 residential units.
22 Council Member de Blasio's District has a text
23 amendment for Carol Gardens in Brooklyn, modifying
24 the narrow streets requirements. LU Number 835 is
25 the Leader House. It is in Council Member

2 Brewer's District to facilitate a 29-story mixed
3 use building on 93rd Street.

4 The rest are all UDAAPs. Council
5 Member Viverito's District has one, LU Number 775.
6 There are three Preconsidered; one is in Council
7 Member Foster's District at 665 Jefferson Place in
8 Bronx. Another in Council Member Foster's
9 District at 665 Jefferson Place. One in Council
10 Member Weprin's District, 7604 Little Neck Parkway
11 and one in Council Member Comrie's District at
12 21814 103rd Avenue.

13 Any discussion? No. Okay. Just
14 remember we'll let you know what time the
15 Committee is tomorrow. It's at 10:00 A.M. here in
16 the Committee room. And there will be no
17 Subcommittees tomorrow, just Land Use. And we'll
18 just vote on the Hudson Square Text Amendment.
19 Call the roll.
