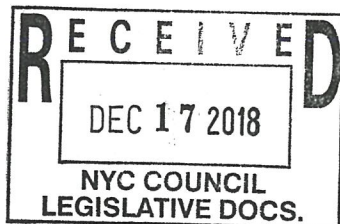

On behalf of Mayor de Blasio, I am herewith transmitting copies of a local law in relation to the date of submission by the mayor of a preliminary management report and the date prior to which the council shall conduct public hearings and the date by which the council shall submit a report or reports pertaining thereto, the date of submission by the director of management and budget and the director of city planning of a draft ten-year capital strategy, the date of submission by the city planning commission of a report on the draft ten-year capital strategy, the date of submission by the mayor of the preliminary certificate regarding debt and reserves and appropriations and expenditures for capital projects, the date of submission by the mayor of the preliminary budget, the date of publication by the director of the independent budget office of a report on revenues and expenditures, the date of submission by the community boards of statements in regard to the preliminary budget, the date of submission by the commissioner of finance of an estimate of the assessed valuation of real property and statement of real property taxes due, expected to be received, and uncollected, the date of submission by the mayor of a tax benefit report, the date of submission by the borough boards of statements on budget priorities, the date of submission by the council of estimates of the financial needs of the council, the date of submission by the borough presidents of proposed modifications of the preliminary budget, the date of publication by the director of the independent budget office of a report analyzing the preliminary budget, the date by which the council shall hold hearings and submit recommendations in regard to the preliminary budget, and the date of submission by the campaign finance board of estimates of the financial needs of the campaign finance board, relating to the fiscal year two thousand twenty.

The Mayor would appreciate the introduction of this legislation at the earliest possible date.

## A LOCAL LAW

In relation to the date of submission by the mayor of a preliminary management report and the date prior to which the council shall conduct public hearings and the date by which the council shall submit a report or reports pertaining thereto, the date of submission by the director of management and budget and the director of city planning of a draft ten-year capital strategy, the date of submission by the city planning commission of a report on the draft ten-year capital strategy, the date of submission by the mayor of the preliminary certificate regarding debt and reserves and appropriations and expenditures for capital projects, the date of submission by the mayor of the preliminary budget, the date of publication by the director of the independent budget office of a report on revenues and expenditures, the date of submission by the community boards of statements in regard to the preliminary budget, the date of submission by the commissioner of finance of an estimate of the assessed valuation of real property and statement of real property taxes due, expected to be received, and uncollected, the date of submission by the mayor of a tax benefit report, the date of submission by the borough boards of statements on budget priorities, the date of submission by the council of estimates of the financial needs of the council, the date of submission by the borough presidents of proposed modifications of the preliminary budget, the date of publication by the director of the independent budget office of a report analyzing the preliminary budget, the date by which the council shall hold hearings and submit recommendations in regard to the preliminary budget, and the date of submission by the campaign finance board of estimates of the financial needs of the campaign finance board, relating to the fiscal year two thousand twenty

Be it enacted by the Council as follows:

1

Section 1. During the calendar year 2019 and in relation to the 2020 fiscal year:

1           1. Notwithstanding any inconsistent provisions of section 12 of the New York city  
2 charter, as amended by vote of the electors on November 7, 1989, the mayor shall pursuant to  
3 such section submit a preliminary management report as therein described not later than  
4 February 21, 2019, and the council shall conduct public hearings on such report prior to April 30,  
5 2019 and submit to the mayor and make public not later than April 30, 2019, a report or reports  
6 of findings and recommendations.

7           2. Notwithstanding any inconsistent provisions of section 228 of the New York  
8 city charter, as added by vote of the electors on November 7, 1989, the director of management  
9 and budget and the director of city planning shall pursuant to such section jointly submit a draft  
10 ten-year capital strategy as therein described not later than February 7, 2019.

11           3. Notwithstanding any inconsistent provisions of section 234 of the New York  
12 city charter, as added by vote of the electors on November 7, 1989, the city planning commission  
13 shall pursuant to such section submit a report on the draft ten-year capital strategy as therein  
14 described not later than March 7, 2019.

15           4. Notwithstanding any inconsistent provisions of section 235 of the New York  
16 city charter, as added by vote of the electors on November 7, 1989, the mayor shall pursuant to  
17 such section submit and publish a preliminary certificate regarding debt and reserves and  
18 appropriations and expenditures for capital projects as therein described not later than February  
19 7, 2019.

20           5. Notwithstanding any inconsistent provisions of section 236 of the New York  
21 city charter, as amended by local law number 218 for the year 2017, the mayor shall pursuant to  
22 such section submit a preliminary budget as therein described not later than February 7, 2019.

1           6. Notwithstanding any inconsistent provisions of section 237 of the New York  
2 city charter, as added by vote of the electors on November 7, 1989, the director of the  
3 independent budget office shall publish a report on revenues and expenditures as therein  
4 described on or before February 22, 2019.

5           7. Notwithstanding any inconsistent provisions of section 238 of the New York  
6 city charter, as added by vote of the electors on November 7, 1989, each community board shall  
7 pursuant to such section submit a statement and recommendations in regard to the preliminary  
8 budget as therein described not later than March 8, 2019.

9           8. Notwithstanding any inconsistent provisions of section 239 of the New York  
10 city charter, as added by vote of the electors on November 7, 1989, the commissioner of finance  
11 shall pursuant to such section submit an estimate of the assessed valuation of real property and a  
12 certified statement of all real property taxes due as therein described not later than March 8,  
13 2019.

14           9. Notwithstanding any inconsistent provisions of section 240 of the New York  
15 city charter, as added by vote of the electors on November 7, 1989, the mayor shall pursuant to  
16 such section submit a tax benefit report as therein described not later than March 8, 2019.

17           10. Notwithstanding any inconsistent provisions of section 241 of the New York  
18 city charter, as added by vote of the electors on November 7, 1989, each borough board shall  
19 pursuant to such section submit a statement of budget priorities as therein described not later  
20 than March 19, 2019.

21           11. Notwithstanding any inconsistent provisions of section 243 of the New York  
22 city charter, as added by vote of the electors on November 7, 1989, the council shall pursuant to

1 such section approve and submit estimates of the financial needs of the council as therein  
2 described not later than April 1, 2019.

3           12. Notwithstanding any inconsistent provisions of section 245 of the New York  
4 city charter, as added by vote of the electors on November 7, 1989, each borough president shall  
5 pursuant to such section submit any proposed modifications of the preliminary budget as therein  
6 described not later than April 1, 2019.

7           13. Notwithstanding any inconsistent provisions of section 246 of the New York  
8 city charter, as added by vote of the electors on November 7, 1989, the director of the  
9 independent budget office shall pursuant to such section publish a report analyzing the  
10 preliminary budget as therein described on or before April 5, 2019.

11           14. Notwithstanding any inconsistent provisions of section 247 of the New York  
12 city charter, as added by vote of the electors on November 7, 1989, the council shall pursuant to  
13 such section hold hearings and submit recommendations as therein described not later than April  
14 16, 2019.

15           15. Notwithstanding any inconsistent provisions of subdivision c of section 1052  
16 of the New York city charter, as added by vote of the electors on November 3, 1998, the  
17 campaign finance board shall pursuant to such subdivision submit estimates of the financial  
18 needs of the campaign finance board as therein described not later than April 1, 2019.

19           § 2. This local law takes effect immediately and is retroactive to and deemed to  
20 have been in full force and effect as of November 1, 2018.
