15 Dorothy Lewandowski, she was there and did beautiful
16 work in all of the parks in my District and
17 throughout the borough of Queens. Dorothy, is all I
18 can say is that we are really going to miss you so
19 much. So, please come up here. And all of our
20 friends from Parks please come up here. (applause).
21 Commissioner Silver, here you are, how are you?
22 Please, please, please, give us a very good
23 Commissioner, we are used to having good
24 Commissioners and we want to continue that. So, can
25 we please read the proc.

2 CLERK: Council, City of New York
3 Proclamation. The New York City Council is very
4 proud to honor Dorothy Lewandowski upon her
5 retirement for her visionary leadership as Queensboro
6 Parks Commissioner and her career defined by
7 outstanding achievements and enduring contributions
8 that have benefited millions of her fellow New
9 Yorkers and whereas in addition to their tremendous
10 economic health and environmental benefits, Parks are
11 one of the most tangible ways we perceive the quality
12 of life in our communities. Commissioner Lewandowski
13 has spent her entire professional career with the New
14 York City Department of Parks and Recreation and for
15 the last four decades she has built an incredible
16 legacy for others to protect and to build upon. And
17 whereas after earning her degree in Horticulture from
18 SUNY Farmingdale, the only time she ever lived
19 outside of her native Queens. She launched her
20 career on May 28, 1979 as an original member of the
21 Urban Park Rangers, a group that has played a key
22 role in the renaissance of New York City's natural
23 environment. In the 1980s, she went on to major in
24 Public Administration at Baruch College and earned
25 her BBA in Business. She continued to hone her

3 and in 1987 Director of Beach and Pool Operations in
4 the Bronx and whereas in the early 1990s Commissioner
5 Lewandowski continued to rise through the ranks as
6 Administrative Parks and Recreation Manager and
7 Deputy Chief of Operations in Queens. Between 1994
8 and 2004 she served the Bronx as Chief of Operations
9 for 8 years and borough Commissioner for two. In
10 these roles, she built lasting partnerships that
11 helped revitalized Bronx Parks and orchestrated the
12 renaissance of Orchard Beach into one of the City's
13 top recreation facilities and whereas since being
14 appointed Queensboro Commissioner in 2004, Dorothy
15 Lewandowski has overseen more than 7,700 acres of
16 parkland. Having with the Parks Department throughout
17 her career, she has gone into loyal support of its
18 tireless workforce and has been an inspiring mentor
19 to generations of Parkees. Under her leadership,
20 they have worked tirelessly to keep Parks clean,
21 green and safe to help improve the quality of life
22 for millions. Commissioner Lewandowski's
23 distinguished career exemplifies public service at
24 its best and she has earned the esteem of all New
25 Yorkers. Now, therefore be it known that the New

20 power of Parks and it is through your support that
21 our open spaces have been able to grow and flourish
22 and I can't thank you enough. I am joined here today
23 on my left and the right by my fellow Parkees who
24 daily bring a passion, commitment, creativity and
25 expertise to each task. As a team we continually

14 be retiring in January so it is time for he and I to
15 open up the next book in that chapter of our life and
16 enjoy the adventures. But I should in closing, I do
17 just want to say that I am enormously grateful to the
18 City Council. Over the years we have done many
19 things together that have truly made New York City
20 better and each of you had had my cellphone number at
21 those times when things weren't as well as you would
22 like them to be, I did get those phone calls and we
23 answered and we worked on them together to make them

10 all for being here with us this Tuesday. We have a
11 busy agenda ahead of us. I want to start with some
12 very, very sad news, very sad news about one of our
13 own here at the New York City Council. Our
14 incredible Community Engagement Director Jenny Low
15 was hit by a car on Friday night and seriously,
16 seriously injured. She has a long road of recovery
17 ahead of her but all of us who know her, know that
18 Jenny is a fighter and she is strong enough to make
19 it through it. I visited her in the hospital in the
20 intensive care unit at Bellevue on Sunday afternoon.
21 I was relieved to see that even though she is very
22 badly injured she was still the same Jenny. Jason
23 Goldman and I visited her and it was extraordinarily
24 difficult to see her in that hospital. She given
25 what happened on Friday night, she is fortunate to be

2 alive and uhm I know that the Community Engagement
3 Staff are really struggling with what happened to uhm
4 one of the nicest, most generous, kindest people not
5 just here at the City Council but people we get to
6 know in New York City. I had the pleasure of seeing

8 room on Sunday. They are taking care of her so that
9 they know that she is in good hands. Bellevue is
10 doing an incredible job taking care of her so I am
11 extremely grateful to the surgeons and doctors and
12 nurses and staff at Bellevue for taking such good
13 care of our Jenny, Jenny Low so I am going to ask you
14 all to please keep Jenny in your thoughts and
15 prayers. We love her tremendously and we can't wait
16 to have her back. Please also keep in your thoughts
17 and prayers the NYPD Officer who was hospitalized
18 after a standoff with a suspect on Staten Island on
19 Sunday night. The brave men and women of the NYPD
20 put their lives on the line to keep us safe and we
21 thank them every day for that. I also want to
22 remember some of those that we lose in the weeks
23 since our last Stated Meeting; Construction Worker,
24 Over Paredes was killed at an on-site accident in
25 Council Member Cornegy's District in Brooklyn. Mr.

2 Paredes family on behalf of the entire City Council
3 we want to extend our deepest condolences, fire
4 fighter Fizo Codo (SP?) was killed in a horrible act
5 of violence, a road rage, a road rage incident while
6 he was off duty in Brooklyn. He was taken from the
7 FDNY in a senseless act of violence. To Mr. Codo's
8 family I want to send my condolences and those of the
9 entire City Council. He was a brave man who deserved
10 to live a full and happy life and I am grateful that
11 law enforcement has brought the perpetrator to
12 justice swiftly. Uhm we have also lost sadly, as I
13 always say, it's like Ground Hog Day at these Stated
14 Meetings we have lost several more 9-1-1 First
15 Responders since the last Stated Meeting due to
16 illnesses that they developed during their time at
17 Ground Zero. I will forever be grateful to these
18 individuals for their bravery and service and I think
19 that it is important that we remember them every time
20 one of them sadly loses the lives and we keep their
21 families in our hearts. Since our last Stated
22 Meeting we've lost Captain John Machella (SP?), Fire
23 Fighter Rory M. Maze, Chief Raymond Blackus (SP?) and
24 Trooper Robert Nagle who were all taken from us in
25 the last few weeks from 9-1-1 related illnesses, may

2 they rest in peace. Finally, I want to acknowledge
3 the passing of Former President George H.W. Bush.
4 President Bush lived a life of service that inspired
5 millions of Americans, even those who disagreed with
6 them and there is no doubt that he loved our Country.
7 Rest in Peace to President Bush and our condolences
8 with his family. Now I want to ask everyone to
9 please rise and take a moment of silence for all of
10 those that we have lost and please keep.

11 LATITIA JAMES: All rise.

12 SPEAKER COREY JOHNSON: Please keep Jenny
13 Low in your thoughts and prayers. Thank you. I also
14 think it is important at this Stated Meeting as was
15 done earlier on the steps of City Hall to talk about
16 openly what transpired on Friday in Brooklyn at an
17 HRA Center. Jazmin Headley, a 23-year-old African-
18 American woman with her 1-year-old baby boy was
19 treated horrifically, violently, I am furious by what
20 I saw in that video and I feel heartbroken for that
21 mother and baby. It is a short video 2 minutes and
22 26 seconds long but it shows us so much of what is
23 wrong with our system. How disheartening it is to
24 try and receive benefits for which you are entitled,
25 childcare, that's why she was there for childcare.

2 How disheartening it is to try to receive benefits as
3 I said, how overflowing those offices are with people
4 who need help and how one incident can escalate so
5 quickly. Not escalate because of anything Ms.
6 Headley did and set off a chain reaction that sends a
7 young mother to jail and her child taken away from
8 her in 2 minutes and 26 seconds that what we saw. We
9 saw how our system criminalizes poverty,
10 disproportionately punishes petty behavior and
11 separates parents from children without considering
12 the lasting damage and trauma that it causes to these
13 parents and children. We saw it and we are all
14 disturbed by it and we are not going to forget about
15 it or stop talking about it. We have an obligation
16 to talk about it, to make our system better and to
17 fight for changes that will help families like Jazmin
18 Headley's. She should be released from Riker's
19 Island immediately. I will be meeting with the
20 Department of Social Services Commissioner,
21 Commissioner Banks and the NYPD Commissioner James
22 O'Neill to get to the bottom of this, to understand
23 how this happened and what we can do to make sure it
24 never happens again. We are compounding this tragedy
25 every single day that Jazmin Headley stays in jail

2 and is on Riker's Island. I want to apologize to
3 her. I want to say that I am sorry. I am sorry that
4 you had to go through that. I am sorry that you are
5 on Riker's Island. I am sorry that our systems are
6 set up in this way where you are criminalized for

8 sorry. And we at the Council will do our best to
9 make structural changes that deal with structural
10 racism and do not criminalize people living in
11 poverty who are just trying to live their lives. I
12 want to recognize that we have students here today
13 from the Urban Assembly School for Emergency
14 Management that are in the balcony so I want to
15 welcome them with a round of applause, thank you all
16 for being here. Now I want to jump into our docket

16 why I support single payer healthcare and I am proud

18 our system and if we are being honest, we really need

20 no question that a massive overhaul of the healthcare
21 system is urgently needed. It won't be needed but it
22 is necessary. There are tough choices that need to
23 be made for the benefit of our City and State. I
24 hope this resolution sends a strong message that this
25 City wants universal healthcare and that we want the

2 State Legislature and the Governor to sign the New
3 York Health Act. I want to thank your Health
4 Committee Chair, Mark Levine for his leadership on
5 this issue for holding a very important hearing on
6 this issue and for his long-standing advocacy for
7 single payer. Uhm thank you Chair Levine. I want to

19 Ayala, Gibson and Chin. You spoke from your hearts
20 today and that's what's going to make a difference in
21 Jazmin's live. Thank you.

22 LETITIA JAMES: Thank you.

23 CLERK: Torres?

24 RITCHIE TORRES: Aye on all.

25 CLERK: Treyger?

2 MARK TREYGER: Permission to explain my
3 vote?

4 LETITIA JAMES: Yes.

5 MARK TREYGER: Thank you Public Advocate.
6 First, I want to thank this entire body and entire
7 Council for being so supportive on the push for Fair
8 Student Funding. I want to thank the Speaker for
9 bringing us up to Albany. I will never forget,
10 confronting the Governor and not taking any answer
11 except for yes for support for our schools as an
12 answer and going to Gracie Mansion and negotiating
13 the Budget, demanding, insisting on more money for
14 our schools that Mr. Speaker is in large part to your
15 leadership and your persistence. I also want to
16 thank uhm Finance Chair Danny Dromm who has been at
17 the forefront with me from day 1. I want to thank
18 you so much Chairman Dromm for all of your support
19 and leadership, education and our Budget. Uhm my
20 colleagues today we are voting on a critical Fair
21 Student Funding Package, at this set is a vital
22 critical and most flexible source of funding that
23 could be used at a school's discretion to hire art
24 teachers, music teachers, to expand, to hire social
25 workers, guidance counselors, the folks that our

2 students need. We need to do everything possible to
3 make sure that there is true equity in our schools.
4 Introduction 1014b would require the DOE to report
5 annually on all school Budget allocations so every
6 member will get to see all of their school budgets
7 and what their FSFL location is, the majority of
8 public schools in New York City are not receiving
9 100% of their entitlement, you deserve to know what
10 your schools are receiving and what they are not
11 receiving. That is an issue of transparency and
12 fairness in our school system and also Introduction
13 1174A would create a Task Force to review and make
14 recommendations to tweak the formula because right
15 now poverty for example is only accounted for up to
16 the 3rd grade as if poverty doesn't exist beyond the
17 3rd grade. These are some of the weights and issues
18 that we have to address. The Task Force will be made
19 up of parents, of children in the school system,
20 educators, advocates, who specialize in working with
21 vulnerable student populations. We need to make sure
22 that we hear from all communities how this formula
23 should best be suited to support our kids. The
24 current formula was created under the Bloomberg

3 vote aye on all. Thank you very much for your time.

7 Did they have cigarettes? But in this case, the
8 woman had a baby and if we can't come to the
9 rationalization that a woman with a baby, we are not
10 talking about any of these other cases that we have
11 seen, the most vulnerable, then we have really failed
12 as a City at the highest level if there are no
13 repercussions brought against those who committed
14 this heinous crime against a black woman and her
15 black child who will never be the same after this
16 horrific incident. This has to be taken seriously,
17 this is not a one-day protest. This is something
18 that our City has to engage in, in a very deep way
19 and I say to all. I say to everyone involved to
20 imagine if your wife, your daughter, your mother was
21 attacked in this way. So, I thank all of my
22 colleagues for being here. This is a longer journey
23 and this is a journey that as elected leaders that we
24 have to take together. We have to leave this City
25 better than we found it and we have to leave the most

3 I vote aye on all of these Bills and I continue to

6 Resolutions which reads as follows: Resolution 470 a

8 and the Governor to sign 84738A and S4840A, a
9 Legislation that would establish the New York Help
10 Program, a single payer health plan for all New York
11 State Residence. All of those in favor say aye?

12 that I am introducing today that deals with an issue
13 all New Yorkers struggle with, that is noise. Not
14 the good kind of noise, not the good trouble that we
15 make but the noise that disturbs our sleep and
16 affects, adversely affects or quality of life. So,
17 Intro 1292 would require owners of multiple dwellings
18 to distribute a notice to new and renewing tenants
19 about their obligations under the City's Noise
20 Control Laws. So, some landlords already do this,
21 but with this Bill Landlords who fail to do so will
22 be penalized \$250. As someone who unfortunately has
23 to unfortunately deal with things like SantaCon in
24 my...

2 LETITIA JAMES: Shhh, sshh.. Excuse me
3 Council Member, can we have quiet in the Chambers we
4 are still in session. Council Member Rivera has the
5 floor.

6 CARLINA RIVERA: Thank you, as someone
7 who has to deal with a lot of noise complaints, in
8 fact my whole community board was number one for
9 many, many weeks and who has really entertaining
10 events going through her District like Santacon.
11 This is the perfect time for us to take a look at
12 noise issues and the lack of knowledge and
13 enforcement of the City's rules. This is not just a
14 lower Manhattan issue, Council Member Rodriguez, I
15 want to thank for co-sponsoring with me, this Bill is
16 tirelessly fighting to mitigate noise in his District
17 which has the highest number of complaints in the
18 City and again this is not just for Manhattan people,
19 this is all over for all of us who are trying to
20 strike a balance between a Commerce and Community,
21 between entertainment and of course quality of life.
22 I want to reiterate this is just one step that our
23 office plans to do more Legislatively working with
24 City Agencies to ensure that enforcement is completed
25 and that tenants are empowered to report noise and

2 see it stopped. So, I just want to thank all the
3 leaders in my community, in my neighborhood who have
4 fought hard just to get a good night's sleep,
5 including, specifically Dale Goodson who is on
6 Community Board 3 and who is a leader on his block
7 association. So, I am asking all of my colleagues to
8 please sign on. We like to have a good time but we
9 also deserve a good night's sleep, thanks everyone.

10 LETITIA JAMES: Thank you and now for a
11 vote. Council Member Jumaane Williams?

12 JUMAANE WILLIAMS: Thank you, aye on all
13 with the exception of LU 257 which I abstain.

14 LETITIA JAMES: Thank you, continuing
15 with General Discussion, Council Member Rose.

16 DEBORAH ROSE: Thank you, roughly 3
17 million Americans identify as members of the many
18 Native American Tribes in this Country. Sadly, our
19 Nation has a checkered past regarding the treatment
20 of the original inhabitants of this land and as a
21 direct result unemployment and poverty rates among
22 Native Americans are much higher than those of the
23 General Population. Our City has a program to help
24 remedy past disparities in economic opportunities in
25 the form of outreach and resources to minority and

2 women owned business enterprises or MWBEs. It came to
3 my attention by a constituent who is here with us
4 today that Native Americans is not a category that
5 can currently claim MWBE status. Today I am
6 introducing Intro 1293 which will add Native
7 Americans to this list, the business owner categories
8 who can register as an MWBE in New York City. This
9 Bill will also raise our targets for the amount of
10 City contracting dollars that flow to businesses
11 owned by these historically under-represented groups.
12 I want to thank Mayor de Blasio and SBS Commissioner
13 Greg Bishop for recognizing this omission and
14 proposing solutions. I want to thank Speaker Corey
15 Johnson who is not ever too big to apologize for an
16 injustice for his support for this important and much
17 needed Legislation, Staten Island Resident and
18 entrepreneur Jacqueline Takarante (SP?) who is here
19 today in the balcony with us for her advocacy on this
20 issue. My co-Sponsors C.M. Cornegy and Daniel
21 Collins for his work on bringing this Legislation to
22 life and I look forward to all of my colleagues to
23 signing on this important Legislation. Thank you.

24 LETITIA JAMES: Thank you, Council Member
25 King.

2 ANDY KING: Thank you Madam Public
3 Advocate, I rise today with a heavy heart. Uhm
4 through due to what our sister experienced Friday, I
5 say to Laurie Cumbo, a mother of a young son, I say
6 to all the parents of young children, this is nothing
7 new in America. And I am asking us as elected
8 officials to step up our game. Today, we went out on
9 the steps I thank Council Member Levine and Speaker
10 Johnson for leading the conversation but we have to
11 do more as far as policy. Two years ago, we as a
12 Council passed a piece of Legislation calling out the
13 clause in the United States Constitution. We heard
14 today in the conversation that this is the systemic
15 root of this Country of bigotry, prejudice and
16 reminding people of slavery when you say a young
17 black child being ripped from his mother. These
18 things happen 300-400 years ago and they are still
19 happening today in America. We are still getting
20 lynched in America and if we want to do something
21 about it, we got to take a hard stand as elected
22 officials, people of color coming together for my
23 Caucasian brothers, sisters standing with us. It may
24 be hard and challenging in your time and era but I
25 can tell you today with a heavy heart, not one of you

2 would change places with me to be a black man in
3 America with what we go through. I am just having a
4 real conversation today because my heart is heavy
5 with what happened to that sister. There is no
6 reason why we should still be dealing with this crap
7 in America today. So, if we really want to change
8 something, just call on the Federal Government to
9 amend that Constitution, say that all Americans are
10 equal, say that all blacks are equal because that
11 same that same piece of Legislation still allows
12 Slavery to be in the United States of America, just
13 called incarceration. So, if we are going to have a
14 real conversation, talking about real policy then
15 let's do something about it. Let's not fake it
16 because it sounds politically expedient at the time
17 and then when the cameras go away, we go back to the
18 same bigotry and prejudice that is in our
19 neighborhoods. If we are going to be true leaders,
20 then have the real conversations with the bigots that
21 are in your neighborhood. Have the true conversation
22 with the person who is prejudice. Have the true
23 conversation within yourself to know whether you can
24 stand up and take a real fight and not worry about
25 getting in the political gig. Do the human thing to

2 save lives. Are we going to be the real, the
3 generation of New Yorkers in the Council that is
4 going to lead, let's do it? Let's note Fake It Until
5 We Make It, let's do it for real. So, with that I
6 want see those squares and I am going to be praying
7 that someone gets fired, someone gets fired, someone
8 gets fired, and we free our sister today. Thank you.
9 (applause).

10 LETITIA JAMES: Council Member Barron.

11 INEZ BARRON: Thank you Madam Public
12 Advocate first I want to say that I am very pleased
13 that we have passed a Resolution that supports the
14 Legislation calling for single payer healthcare. I
15 think that is critical and I think we need to do all
16 that we can to move that forward. Secondly, I want
17 to thank all of those who organized today's press
18 events on the steps of City Hall. What we saw on the
19 video was startling but it is just another incident
20 that has happened that this one was recorded. It
21 goes back to recordings that we have seen over the
22 years, going back to I guess the most uhm public one
23 was Rodney King, when we saw him being beaten. The
24 issue becomes and I have to associate myself, well,
25 with my colleagues out in Richards. Who at the press

2 conference said until there are adequate, appropriate
3 consequences and I've said it before for the people
4 who violate the Law. The people who commit criminal
5 acts, until they are appropriately punished, we are
6 going to continue to have these kinds of events
7 happen. The racism that exists in this Country is

9 and poor people criminalized when they are the
10 victims. I couldn't believe what I was seeing, you
11 know, again so blatant, the way that this baby was
12 yanked from his mom's arms but until we say to HRA
13 and until we say to NYPD these are the people who are
14 going to be fired, these are people who perhaps need
15 to go to get a demotion or whatever it is that is
16 appropriate consequences are, we are going to
17 continue to see that. And consequences in my opinion
18 for NYPD has to go beyond a loss of vacation days
19 cause that's the only thing that has happened, even
20 when they have killed us uhm even when they have
21 brutalized us and it has been recorded. So, we've
22 got to move beyond just what we have here and get
23 consequences implemented especially with NYPD but
24 with any agency that brutalizes us. Thank you.

2 LETITIA JAMES: Thank you. Council
3 Member Chin.

4 MARGARET CHIN: Thank you, first I wanted
5 to thank all of my colleagues and thank you to
6 Speaker Corey Johnson uhm for standing with me and
7 the Borough President and the Resident of Two
8 Bridges. Through this Legal Action we are fighting
9 to defend affordability in this vibrant waterfront
10 neighborhood. We are also ending a loophole. What
11 is a minor modification that has sadly given more
12 weight to an arbitrary land use determination over
13 thousands of residents who are left voiceless in a
14 process that could decide the future of the
15 neighborhood? The Two Bridges Neighborhood is
16 already underserved by transit, affordable,
17 supermarket and open space. The environmental impact
18 statement accompanying these applications do not even
19 begin to account for primary and secondary
20 displacement that were rippled through the entire
21 neighborhood. I am also deeply concerned about one
22 application that is going to attach itself to a
23 senior building and eliminating a whole line of
24 apartments so that they could build on top of it.
25 This fight is about equity, is about fairness, and is

2 about turning the tie of luxury over-development that
3 has displays innocent tenants and destroy community.
4 From the beginning I have made my stand clear to the
5 Administration, four towers that are more than 60
6 stories high creating thousands of luxury units in an
7 area the size of a City block. They do not belong in
8 this long to mid-rise neighborhood, especially not
9 without a full public review process and that's why I
10 really am so appreciative of our Land Use Team and of
11 the General Council's Office and our speaker for
12 standing with us and with the resident of Two Bridges
13 to fight back to that their voices will be heard and
14 they get the protection they deserve. Thank you.

15 LETITIA JAMES: Thank you. Council
16 Member Levin.

17 STEPHEN LEVIN: Thank you Ma'am Public
18 Advocate, uhm I just wanted to say very briefly
19 regarding the situation with Jazmin Headley at the
20 HRA Office that in addition to examining what
21 happened in this particular instance where every step
22 of the way uhm leading up to what we all saw on this
23 terrible video and the terrible circumstances and the
24 absolutely awful way that Jazmin and her child were
25 treated, every step of the way uhm in the process a

2 bad decision was made. A bad decision from an HRA
3 Case Manager perspective, a bad decision from
4 Security Personnel in the HRA Office, uhm and how
5 they were interacting with her as a Client and as a
6 person, has a human being and a mother, a bad

8 made by police department when they came in to
9 immediately try to arrest her and now sit down and
10 talk to her like a normal person, and like a person
11 that is deserving of respect, and so we need to
12 examine every single one of those bad decisions that
13 was made, make sure that that never happens again.
14 We also have to examine what is happening at our HRA
15 Centers, make sure that we are getting clear data on
16 the wait times at HRA Offices, the role of peace
17 officers as they, as they interact with clients, uhm
18 the accommodations for people with small children.
19 If somebody is waiting there for two, three, four,
20 five hours, what accommodations are we doing for, for
21 women with one or two or three or four children and
22 how we are accommodating that. So, this needs to be
23 looked at from a bigger picture and I think that this
24 Council stands able to do that in the coming months,
25 make sure that we are allowing people are receiving

3 entitled to. Uhm that we are treating them with just
