2 [JOHN BIANDO] This is a microphone check.
3 Today's date is June 19, 2019, Committee on Finance,
4 being recorded by John Biando, City Hall Committee
5 Room. [pause]

6 CHAIRPERSON DROMM: [[gavel]] OK, good
7 afternoon, and welcome to today's Finance Committee
8 hearing, where we will be adopting the 2020 Budget.
9 I'm Council Member Daniel Dromm and I chair the
10 committee. Let me introduce my colleagues. We have
11 Council Member Farah Louis, and welcome to the
12 committee. Thank you for joining us. Let's give her
13 a welcoming round of applause [applause], Council
14 Member Mark Gjonaj, Council Member Adrienne Adams,
15 Council Member Helen Rosenthal, Council Member Jimmy
16 Van Bramer, Minority Leader Steven Matteo, Council
17 Member Barry Grodenchik, and Majority Leader Laurie
18 Cumbo. Thank you again for being here. Today the
19 council committee will take the necessary actions for
20 the City Council to adopt the fiscal 2020 budget,
21 which totals approximately 92.8 billion dollars. In
22 all, this committee will vote on 11 budget-related
23 items. In addition, we will also be voting on a
24 fiscal 2019 transparency resolution, Intro 1607, to
25 reduce the commercial motor vehicle tax for taxicab

1
2 medallions and one Article 11 property tax exemption.
3 But before we begin, I would like to take a moment to
4 recognize everyone who helped us get to today's
5 budget adoption. First and foremost, I want to thank
6 Speaker Corey Johnson for his tireless commitment to
7 advocate for a budget that represents the values of
8 this council and this city. It is because of his
9 leadership that we are passing a budget that is both
10 equitable and supportive for everyone and safeguards
11 the city's fiscal health. Today truly marks a
12 victory for us all. I also want to thank the
13 speaker's chief of staff, Jason Goldman, for all the
14 work he did during this budget process on behalf of
15 this institution and its members. Thank you to my
16 fellow finance committee members for their
17 partnership. In particular, Council Member Vanessa
18 Gibson, who chairs the Subcommittee on Capital Budget
19 and who has been with me every step of the way.
20 Thank you also to Majority Leader Laurie Cumbo,
21 Minority Leader Steven Matteo, Council Members Keith
22 Powers, Helen Rosenthal, Francisco Moya, Barry
23 Grodenchik, Rory Lancman, Jimmy Van Bramer, Adrienne
24 Adams, Robert Cornegy, Mark Gjonaj, and Farah Louis.
25 Together at the Executive Budget hearings we heard

1
2 over 60 hours of testimony from agency heads on the
3 operations and goals for the upcoming fiscal year and
4 their ability to perform core services. We also
5 heard from over 100 members of the public on the last
6 day of the executive budget hearings on how the
7 budget would affect them. We took what we learned at
8 the budget hearings back to BNT and delegations then
9 negotiated a budget that we can all be proud of. And
10 of course we must thank the staff in the finance
11 division. They are spectacular. I know that they
12 have worked long hours, answered a lot of questions
13 from members, and many reports and spreadsheets to
14 prepare. But I want to assure that your dedication
15 is recognized and very much appreciated. So thank
16 you all of the financial analysts, economists, and
17 administrative support staff who worked so hard. And
18 special thanks to the finance division's leadership
19 team who spearheaded the effort - Deputy Director
20 Regina Pareda Ryan, Deputy Director Nathan Taut,
21 Deputy Director Paul Simone, Deputy Director and
22 Chief Economist Dr. Raymond Justin, Assistant
23 Director Emra Edev, Supervising Economist Paul
24 Stromm, Unit Head Isha Wright, Dohini Sampura, Cheema
25 Obachari, Kulian Francisco, and John Russell, and

1
2 Senior Counsel Rebecca Chasson. And of course to the
3 incomparable Latanya McKenny, who leads them all. We
4 thank you very, very much. [applause] And thank you
5 to Chuck Davis and Fran Galavekia and the
6 appointments investigation team for vetting every
7 organization receiving discretionary funding, and to
8 the entire office of the General Counsel, who
9 assisted us with our disclosures. And last, but not
10 least, my staff, Robin Forst, Sebastian McGuire, Mic
11 Malan, my chief of staff, Carolyn Tran, and everyone
12 in my district office who kept everything running
13 throughout this process. Now with everyone properly
14 thanked let's adopt this budget. The fiscal 2020
15 adopted includes many significant wins for the
16 counsel and for the people of the City of New York.
17 This year we entered into budget negotiations focused
18 on securing a responsible, equitable budget for all
19 New Yorkers. The council was determined that the
20 final budget demonstrate a commitment to strengthen
21 the city's reserves and improve the quality of life
22 for all residents. I feel strongly that we have
23 negotiated the budget that accomplishes these goals
24 and incorporates initiatives that will benefit all
25 New Yorkers. As a result of our tenacity and

1
2 persistence throughout this negotiation process the
3 council 2020 budget agreement includes, among other
4 victories, a path for achieving pay parity for all
5 early childhood education employees, both teachers
6 and non-teachers alike with a commitment that
7 whatever collective bargaining agreement is reached
8 will be appropriately funded. A path towards pay
9 parity for public defense and civil legal service
10 providers with an agreement to build a four-year full
11 implementation plan to reach pay parity by March
12 2020. And support for human service providers by
13 funding individual community-based organizations'
14 request for documented indirect cost above the
15 current 10% ceiling. These investments will make a
16 real difference to the not-for-profit workers, many
17 of whom are women of color, who provide the critical
18 work and expertise that keep key services running.
19 But these are not the only investments that we are
20 making in the budget. For our youth the council
21 successfully negotiated for 30 million dollars for
22 285 new social workers, including 100 Bridging the
23 Gap social workers, 100 social workers for middle
24 schools, and 85 social workers who will focus on
25 mental health issues funded by reallocation 10

1
2 million dollars from Thrive NYC. 4000 additional
3 COMPASS slots with 14.2 million dollars in baseline
4 funding, bringing the total number of slots to
5 51,000. Seven new Title 9 coordinators with \$857,000
6 in baseline funding, and 1 million dollars for an
7 inclusive LGBTQ curriculum. These are incredible
8 wins for us all. This budget really contains
9 something for everyone. Among the other of the
10 council's priorities that will be included in the
11 budget are 43 million dollars in the city's parks to
12 support 50 new urban park rangers, 80 parks
13 enforcement patrol officers, 150 maintenance workers
14 and gardeners, forestry management, and the Green
15 Thumb program. 33 million dollars in additional
16 funding for the three library systems. 12.8 million
17 to fund foster care initiatives. 16.6 million in
18 funding for the New York Immigrant Family Unity
19 Project. 11.7 million in baseline funding for senior
20 meals. 26.7 million dollars for culture
21 institutions. 8.6 million investment to fund
22 additional trash pickups on corner litter baskets and
23 40 million for census outreach advertising and
24 community engagement to ensure that every person in
25 New York City is accounted for in the 2020 census.

1
2 Throughout the negotiations we were not only focused
3 on where spending could be most significantly have a
4 positive impact on New Yorkers' lives and protect the
5 social safety net, but we also made it a priority to
6 ensure that the city be better prepared for any
7 economic downturn that may come in the future, and
8 our persistence paid off. The adopted budget will
9 include an additional 250 million dollars for
10 reserves. This meaningful balanced package of
11 spending is a tribute to the council's commitment and
12 dedication to the people of New York City. We should
13 all be proud of what we have accomplished fiscal
14 2020. Now before we move on I'd also like to
15 acknowledge that none of this would have been
16 possible without the administration's willing to work
17 with us to get this budget done. For that I'd to
18 thank the OMB director, Melanie Harzog, and her
19 entire staff. Now with all of that good news laid
20 out, let's discuss the items that the Finance
21 Committee will vote on today. Finance Committee
22 members should have a budget package that contains
23 all budgeted related, budget-related legislation that
24 must be voted on by the committee and again by the
25 full council at the Stated Meeting. The packet also

1
2 includes supporting schedules that are not voted on
3 but filed with the committee as well as other non-
4 budget-related items that are being voted. I want to
5 strongly emphasize that Finance Committee members
6 will be only, will only be given one budget package.
7 So after you vote on the packet items you must bring
8 your packet and all of its contents to the Stated
9 Meeting to vote again. Council members who are not
10 on the Finance Committee will be given their budget
11 packet at the Stated Meeting. A description of all
12 the items were emailed to you by the senior committee
13 counsel, Rebecca Chasson, so I will simply list the
14 items that are on the agenda today that require a
15 vote. The first item is the resolution adopting the
16 fiscal 2020 expense budget. The second item is the
17 resolution adopting the fiscal 2020 contract budget.
18 The third item is a Reso A for the fiscal 2020
19 capital budget, approving the schedule of changes for
20 the capital budget since the executive budget,
21 including council discretionary allocations. The
22 fourth item is Reso B for the fiscal 2020 capital
23 budget, which is approval of the capital budget as
24 amended by Reso A. The fifth item is the resolution
25 to approve the new five-year education capital plan

1
2 for fiscal 2020 to 2024. The sixth item is the
3 resolution approving the 46th year of the Community
4 Development Program and the 45th year at
5 Reallocations. The seventh, eighth, and ninth items
6 are the three property tax fixing resolutions for
7 fiscal 2020. The tenth item is the resolution
8 approving an expense budget modification fiscal 2019.
9 The eleventh item is the resolution approving a
10 revenue budget modification for fiscal 2019. The
11 twelfth item is a transparency resolution. The
12 thirteenth item is an LU items MHANY Dumont which
13 will receive a partial 40-year Article 11 exemption
14 to preserve 45 units in Council Member Espinal and
15 Barron's districts in Brooklyn. The fourteenth item
16 is Intro 1607 which would reduce the annual
17 commercial motor vehicle tax owed by taxi medallions
18 from \$1000 to \$400. The other documents in your
19 packet which do not require a separate vote are a
20 list of the terms and conditions adopted for fiscal
21 2020, Schedule C and other supporting schedules, and
22 the borough president proposed capital changes. As a
23 reminder to members, Schedule C is a schedule of the
24 expense in contract budgets and the appropriations
25 for the organizations listed in Schedule C are in the

1
2 expense and contract budgets. Council members will
3 have to sign a disclosure form indicating whether or
4 not a conflict exists with any of the groups listed
5 in Schedule C or Reso A, which details the
6 designations of capital discretionary funds. If any
7 council member has a potential conflict of interest
8 with any of the organizations included, he or she has
9 the opportunity to disclose the conflict at the time
10 of their vote. If you have not yet signed those
11 disclosure forms staff in the general counsel's
12 office are available to guide you through the
13 process, so please see one of them before you vote.
14 As a further reminder, please disclose any conflicts
15 you may have with proposed subcontractors that are
16 used by any of the organizations sponsored. These
17 disclosures must be made before the subcontractor can
18 be approved. Similarly, the transparency resolution
19 sets forth new changes in the designation of certain
20 organizations receiving local, aging, and youth
21 discretionary funding as well as new changes in the
22 designation of certain organizations receiving
23 funding pursuant to certain initiatives in the
24 budget. Organizations appearing in the resolution
25 that have not yet completed the prequalification

1
2 process conducted by the Mayor's Office of Contract
3 Services, the council, or another entity are
4 identified in the attached charts with an asterisk.
5 As with all transparency resolutions, council members
6 will have to sign a disclosure form. As previously
7 stated, staff from the general counsel's office is
8 available to assist you with any questions or
9 concerns regarding disclosure. Those are all of the
10 items for today. We will take now, we will now take
11 questions from any members if they have them. OK.
12 Seeing none, I will now ask Billy Martin, the
13 committee clerk, to call the roll.

14 WILLIAM MARTIN: William Martin,
15 committee clerk, roll call vote, Committee on
16 Finance. All items are coupled. Chair Dromm.

17 CHAIRPERSON DROMM: Before I say my vote,
18 I want to thank assistant counsel, Noah Brick and
19 Stephanie Ruiz, who sat by my side throughout all the
20 executive budget hearings. I believe they're here.
21 Thank you, Noah, and thank you, Stephanie, over here.
22 I vote aye.

23 WILLIAM MARTIN: Gibson.

24 COUNCIL MEMBER GIBSON: Pass.

25 WILLIAM MARTIN: Cornegy.

COUNCIL MEMBER CORNEGY: With

congratulations to the finance chair, the speaker,
the entire finance staff, I proudly vote aye.

WILLIAM MARTIN: Cumbo.

MAJORITY LEADER CUMBO: I just want to
congratulate everybody here and I want to thank Chair
Dromm, Chair Gibson, and the entire finance team, and
everybody that made today possible, and I just want
to say this is such a meaningful budget for me as a
new mom. It was so exciting to see the progress that
we made for our daycare workers and pay parity. As
a mom I got to see firsthand how so many dynamic
women, particularly women of color, educate children
between the ages of zero and three, in such a
nurturing, loving, and educational environment. So I
was very proud to see that, so proud to see the work
that we're doing with our libraries as we go for
story time and to see how many parents come there for
educational opportunities and reading time, to see
one day he will grow up and have a guidance counselor
in his school, the increase of 33 million dollar to
culturals where we and so many other families go to
for educational upliftment. This is really an
exciting budget, um, for parents and families who

1
2 want to raise their children, um, with all the
3 educational opportunities that the City of New York
4 has to offer and to the entire finance division I
5 thank you for your tireless work and effort and all
6 my colleagues and to Latonya McKinney, it's so
7 inspiring to see a woman and an African American
8 woman in this position. While we all know her and
9 inside baseball she is certainly someone that I wish
10 that the entire city and nation could see a woman of
11 this caliber of, of this experience leading a body at
12 this level. So we thank all of you for all of your
13 work. I proudly vote aye, and I will just say I'm
14 disclosing on the record of the council proceedings
15 that the New York City Department of Education is
16 funded in the budget we are adopting and my sister is
17 employed by the Done. I proudly vote aye, and thank
18 you.

19 WILLIAM MARTIN: Rosenthal.

20 COUNCIL MEMBER ROSENTHAL: With gratitude
21 to everyone already named for their hard work and for
22 being patient with me, especially Chair Dromm, and
23 the speaker and Jason and Latonya and everyone on the
24 budget negotiating team I proudly vote aye on all.

25 WILLIAM MARTIN: Van Bramer.

1
2 COUNCIL MEMBER VAN BRAMER: First, I just
3 want to say thank you to everyone who had a hand in
4 this budget. As the chair of Cultural Affairs and
5 Libraries I could not be happier with this budget
6 that reflects record levels of increases in funding
7 and baseline funding for libraries and over 30
8 million dollars for culturals. This is a very, very
9 exciting budget and that doesn't even get to capital,
10 our cultural council initiatives increased
11 dramatically. It's a very, very good budget so thank
12 you to everyone involved, and I am disclosing on the
13 record that Breaking Ground is funded in the budget
14 we are adopting and I am very proud of my sister who
15 works with homeless individuals in the city and is
16 associated with this entity. With that I vote aye.
17 Thank you.

18 WILLIAM MARTIN: Grodenchik.

19 COUNCIL MEMBER GRODENCHIK: Thank you,
20 Mr. Chairman. I want to thank you first of all for
21 always being on time at every hearing and that's
22 greatly appreciated by us who travel a long distance.
23 I see Ms. Adams shaking her head in agreement,
24 nodding her head. Um, I am disclosing on the record
25 of the council proceedings that Queens College, which

1
2 is a division of the City University of New York, is
3 funded in this budget we're adopting. My son, David,
4 is a student at Queens College, um, I'm also a card-
5 carrying member of the Queensborough Public Library
6 and I'm a graduate of PS-201 Queens and I'm still
7 using that diploma. So that's all on the record now.
8 [laughter] Um, I also want to thank, Matteo, did you
9 graduate? That's the question. Ah, I also want to
10 thank the staff of finance who, as always, has done a
11 tremendous job and is always available to answer my
12 questions, because I have a lot of them. I want to
13 thank you, all of you, from the speaker on down for
14 funding the Queens County Farm Museum here again.
15 We're going to build that visitor's center for all of
16 you who are listening out in eastern Queens. This
17 was a great budget for parks also. I helped to lead
18 that charge, and I'm really excited. This is a
19 historic day for the parks system in New York City.
20 It's probably the one thing that everybody is really,
21 really happy to use. Not everybody is always
22 thrilled to go to school everyday, but everybody
23 really loves their park. So thank you. With that,
24 Mr. Chairman, I am proud to vote yes.

25 WILLIAM MARTIN: Adams.

1
2 COUNCIL MEMBER ADAMS: Thank you very
3 much, Mr. Chair. All of our hats are off to you. It
4 has been my esteemed honor and pleasure to serve for
5 the second year with you leading this amazing Finance
6 Committee, our fantastic finance division. For the
7 City Council there is no measure for the work that
8 you all do, lead by our amazing Latonya McKinney. My
9 thanks to you. My thanks also to my colleague,
10 Vanessa Gibson, for chairing the Subcommittee on
11 Capital Budget, amazing work that you've done. And
12 to our speaker, Corey Johnson, who leads this amazing
13 body of council members, we have seen historic
14 landmarks and milestones take place since his
15 leadership and to him I am very, very grateful as
16 well. This has been an amazing time for women's
17 issues and women in particular, so I am very proud to
18 vote aye on all of the items and let's adopt this
19 budget.

20 WILLIAM MARTIN: Gjonaj.

21 COUNCIL MEMBER GJONAJ: Thank you, Chair.
22 I just want to reiterate some of the committees that
23 were made about you. It's incredible to see this
24 first hand, two years in a row, your stellar
25 performance and duration for all of these hearings.

1
2 To my fellow colleagues for all of their input and
3 what they've done, to our speaker, but most of all, I
4 can't reiterate the praises that the staff deserve
5 for the long nights, the long days, they truly are
6 what makes this institution such a great place and
7 allows us to make a difference for all New Yorkers.
8 This budget is an incredible budget. I'm glad that I
9 was brought in as the lefty on the ninth inning just
10 over a month ago. I was made a part of this
11 committee and I hope that my contributions have been,
12 I hope my contributions are accepted for what they
13 are and that is to make sure that we do the right
14 thing by New Yorkers and to make sure that we spend,
15 and that we're good stewards of tax dollars. This
16 budget has some incredible and wonderful things in
17 it, some things that I'm not so sure about, but with
18 that in mind I want to first make a disclosure. It
19 says I am disclosing on the record of the City
20 Council proceedings that PS-175 is funded in the
21 budget we're adopting and my wife is associated with
22 this entity. And that CUNY is funded in the budget
23 we're adopting and my sons are and may be students of
24 CUNY. And thirdly that the Bronx Parent Housing
25 Network is funded in this budget we're adopting and

1
2 my brother may or may not be associated with this
3 entity. And this is all again to the best of my
4 knowledge and recollection. [laughter] Now with that
5 being said I vote aye on all except for Reso numbers
6 962, 963, 973, and the accompanying resolution M174.
7 And the reason for that is in my council district
8 single-family home owners have the highest effective
9 tax rate than any other district in the city. The
10 highest in the entire city. And I can't vote to put
11 a further burden on home owners, all New Yorkers, who
12 are already overburdened by real estate taxes. Thank
13 you again.

14 WILLIAM MARTIN: Matteo.

15 COUNCIL MEMBER MATTEO: Thank you. I
16 don't know how I follow may or may not but I'll try.
17 [laughter] I want to start off by thanking Chair
18 Dromm. It's obvious to everyone in this room we
19 don't always agree, but you have been a very good
20 partner to myself and to my constituents through this
21 budget process and I appreciate the bipartisanship
22 and focusing on what we do agree on. I think that's
23 what government is all about, and I thank you for
24 that, for your leadership. I thank the finance team,
25 led by Latonya, and I've worked with some of you as a

1
2 staffer, certainly worked with all of you since I've
3 been elected and, um, you are all top-notch and you
4 treat everyone's priorities as your own priority and
5 I think we are all eternally grateful for your
6 knowledge and your hard work, so thank you to our
7 extraordinary finance team. I am also voting no on
8 the tax preconsidered resolutions. I don't think
9 it's a surprise to anyone, and I know the [inaudible]
10 may not be, um, reflect the numbers that will
11 ultimately go in effect, but nonetheless they will
12 increase property taxes for Class 1 properties as is
13 now. I certainly look forward to the findings of the
14 Property Tax Commission that we empaneled and I hope
15 my colleagues will continue to fight with me for
16 property tax relief. With that said, and I certainly
17 don't agree with everything in this budget, I don't
18 think that's a surprise to everyone, I am pleased
19 that we were able to increase our reserves and
20 grateful to Speaker Johnson for working with me to
21 fund many projects and initiatives that benefit my
22 constituents in Staten Island as a whole, so I'm
23 voting no on Preconsidered Resolutions 962, 963, 973,
24 and M174, and aye on the rest. I am also disclosing
25 that my daughter attends CSI, that's in the budget.

1
2 One of my sons attends Susan Wagner High School,
3 which we are funding. Another one of my sons attends
4 PS-30, which we are funding. My sons and my daughter
5 are in Summer Youth Employment Program and UAU, and
6 that's in the budget. My brother works at Rumsey,
7 which we are fund.

8 WILLIAM MARTIN: Powers.

9 COUNCIL MEMBER POWERS: Thank you. I'm
10 proudly voting aye and I want to thank our chair,
11 Danny Dromm, who works tirelessly and puts in more
12 hours than anybody can really imagine, making sure
13 that we get to a budget that is fair and that groups
14 are heard, and that organizations' priorities are
15 attended to and met. This budget with its historic
16 investment in libraries and cultural institutions and
17 parks I know will make many New Yorkers proud and
18 will provide many new opportunities for New Yorkers
19 in places where they need it, places like libraries
20 where any New Yorker can go and take out a book or
21 learn or spend time in that space. I want to really,
22 really thank the chair for days of his life, hours,
23 weeks, that he will never get back, but it means that
24 this budget has done well and I thank our
25 subcommittee chair for capital, Vanessa Gibson, and

1
2 our tireless leader, Latonya McKinney, as well. They
3 put in just so much more work than I think anybody
4 can ever imagine and we're really lucky to have
5 everybody, this whole team in the finance division.
6 I'm proudly aye, and I'm disclosing Mount Sinai is
7 funded in this budget we are adopting. My mother is
8 associated with Mount Sinai. And with that being
9 said I proudly vote aye. Thank you.

10 WILLIAM MARTIN: Louis.

11 COUNCIL MEMBER LOUIS: Good afternoon. I
12 just want to thank you, Chairman, for your warm
13 welcome and for your leadership and for all you do.
14 Also, thank you Council Member Gibson for your
15 leadership and the finance team that always does an
16 amazing job with the budget every year. I'm very
17 happy with this budget that we have and look forward
18 to continue to working with all of you. I would like
19 to disclose on record that my sister works at York
20 Colleague. I have another sister that goes, that
21 attend Medgar Ever College. My mom works at
22 Brookdale. Another sister works at Coney Island
23 Hospital and my brother works for the MTA. We're all
24 over New York City. [laughter]

1
2 UNIDENTIFIED: We funded your whole
3 family. [laughter]

4 COUNCIL MEMBER LOUIS: The whole family.
5 Um, so I vote aye on all, except for Resos 962, 963,
6 and 973, mainly because our district, the 45th
7 Council District, has a lot of one-family, two-family
8 home owners and the tax burden has been a major issue
9 for them, and I know that it will continue to be so.
10 That's the reason I'm voting no. But I vote aye on
11 everything else. Thank you.

12 WILLIAM MARTIN: Gibson.

13 COUNCIL MEMBER GIBSON: Permission to
14 explain my vote? Thank you, Mr. Chair. Good
15 afternoon colleagues, and it's really an honor to be
16 here and I want to join collectively with the finance
17 team and with all of my colleagues in just saluting
18 you, Chair Danny Dromm, for your outstanding
19 leadership. It's been an honor and a privilege
20 working side by side with you as your colleague and
21 your partner in this process. The amount of hours
22 and the labor of love that have been invested in this
23 budget process is truly a reflection of what this
24 council speaks for, and I could not be more proud.
25 It's my second year serving as chair of the

1
2 Subcommittee on Capital in my sixth budget here and
3 we could not have done all of this great work without
4 your leadership, so I thank you for that, for the
5 hours that you have invested. It's been an honor
6 joining with you during both the preliminary budget
7 as well as executive budget and co-chairing many of
8 the hearings, as well as the last day of the hearings
9 when we heard testimony from over 200 New Yorkers and
10 we stayed until the very end, and that really speaks
11 volunteers, Chair, to your commitment, so I want to
12 thank you. I want to thank the entire council and
13 all my colleagues for their support. I want to thank
14 our own Olivia Pope, Latonya McKinney, thank you for
15 being our phenomenal director, for being an
16 incredible leader, for being patient with many of us
17 and the entire finance division. Certainly I want to
18 recognize the staff that worked closely with me,
19 Nathan Toll has been my right hand, Rebecca Chasson
20 has been my left hand. Noah Brick and Stephanie Ruiz
21 have been both my left and right hand, and Isha
22 Wright and Regina Pareda Ryan and Cheema Obichair and
23 Oheny Sampora and all of the finance division, thank
24 you, thank you, thank you. I do want to take an
25 opportunity to recognize another member of our

2 finance division. This is her last budget and she
3 formerly worked as my budget director and I could not
4 be more proud of her. If I have a question at
5 midnight she is responding to me, and that is one of
6 our senior analysts, Caitlin O'Hagan. Thank you,
7 Caitlin! [applause] I definitely wanted to put you on
8 the spot and say thank you for all the work you've
9 done and we wish you great success in your new
10 chapter continuing your higher education, and really,
11 the finance division, you deserve so much credit. We
12 could never feed you enough to show you how much we
13 love and appreciate you. Um, the investments we've
14 made in this budget in cultural, in the arts, in all
15 of our libraries, our social workers, which is
16 historic, saving Weeksville Heritage Center, all of
17 the things we've done to protect children, families,
18 older New Yorkers, you all have been so consistent,
19 and we never gave up. And I want to thank the
20 administration, Office of Management and Budget, our
21 director, Melanie Harzog, for working with us, and
22 certainly the team at OMB, and certainly on a
23 personal note I have to thank my staff. There's no
24 way I could do this without my team, my chief of
25 staff, Wendy Diegos, and completing his first year as

2 my budget director, Justin Cortez. [applause] I
3 thank you so much, and with that I vote aye on all
4 and look forward to passing the budget later on
5 today. Thank you again and thank you to our speaker,
6 Corey Johnson. I vote aye on all.

7 WILLIAM MARTIN: I vote 12 in the
8 affirmative, zero in the negative, and no
9 abstentions. All items are adopted on today's
10 finance agenda with the exception of Resolutions 962,
11 Resolution 963, and M174, with Resolution 973, are
12 adopted by a vote of 9 in the affirmative, 3 in the
13 negative, and no abstentions.

14 CHAIRPERSON DROMM: OK, thank you very
15 much, and this has been a wonderful, wonderful
16 experience. Thank you, Billy, also for always being
17 here for us and I just want to remind members to make
18 sure that you bring your envelope with you to the
19 Stated, you need to have that with you when you come
20 into the Stated Meeting. And with that, and the
21 Stated is at 3 o'clock, so we will see you all there.
22 Thank you, and with that this meeting is adjourned.
