3 afternoon. We'd like to convene this December 7
4 meeting of the Committee on Parks and Recreation.
5 I'm Council Member Melissa Mark-Viverito, the
6 Chair. Today, we'll be voting on 67 thoroughfares
7 and public places, street namings. We had a
8 hearing on this before, but today we'll be voting
9 on this item.

10 We have quorum and we don't have
11 all the members here, but we'll leave the record
12 open once we take the vote. I want to recognize
13 Danny Dromm, we have Council Member Crowley,
14 Council Member Jimmy Vacca, Council Member Gentile
15 and others will be coming shortly.

18 say on any of the street namings that are before
19 up, or if not, we can make this a very quick
20 meeting and just go to the roll call. With that,
21 we'll go to the roll call.

15 aye.

16 WILLIAM MARTIN: Vacca?

17 COUNCIL MEMBER VACCA: I vote aye.

18 WILLIAM MARTIN: Crowley?

19 COUNCIL MEMBER CROWLEY: Aye.

20 WILLIAM MARTIN: Dromm?

21 COUNCIL MEMBER DROMM: Aye.

22 WILLIAM MARTIN: By a vote of five
23 in the affirmative, zero in the negative and no
24 abstention, item is adopted. Members, please sign
25 the committee report. Thank you.


7 WILLIAM MARTIN: Council Member Van
