I want to recognize my Colleagues, 18 Council Member Marte, Narcisse, Ayala, I was like 19 what's your name, Hanif, Restler, and Stevens, and 20 Abreu on Zoom. 21 The Council recently passed legislation 22 requiring reporting on alleged incidents of sexual 23 abuse against corrections officers and Department of 24 Correction staff as well as requiring DOC to 25 implement an electronic case management system to

2	track investigations into sexual abuse in City jails.
3	These bills are intended to ensure we have an
4	accurate understanding of the scope of sexual assault
5	and harassment against people in the DOC custody as
6	well as DOC's investigations into allegations of
7	sexual assault and harassment. Proposed Introduction
8	Number 1061-A, sponsored by Council Member Louis,
9	would amend the Department of Correction's semi-
10	annual reports on alleged incidents and
11	investigations of sexual harassment and abuse to
12	require a single report on incidents and
13	investigations that includes a unique identification
14	number for each alleged incident. It would also
15	require the Department to provide a justification for
16	not reporting any substantiated allegations to a
17	District Attorney's office.
