Today's date is 4 April 10, 2025, in the Committee Room, recorded by 5 Walter Lewis. 6 SERGEANT-AT-ARMS: Good morning, and 7 welcome to the New York City Council vote of the 8 Committee on Technology. 9 At this time, can everybody please 10 silence your cell phones. 11 Chair, we are ready to begin. 12 CHAIRPERSON GUTIÉRREZ: Thank you. [GAVEL] 13 Good morning, I'm Council Member Jennifer Gutiérrez, 14 Chair of the Committee on Technology. Today we'll be 15 voting on the Supermajority Bill, Bill Intro. 978-A, 16 sponsored by Dr. Council Member Williams, in relation 17 to requiring the 3-1-1 Customer Service Center to 18 provide certain resources in response to tree pruning 19 related requests. 20 There are approximately seven million 21 trees in New York City. All trees growing in the 22 public right-of-way along streets and in parks and 23 playgrounds are under the jurisdiction of the 24 Department of Parks and Recreation. As part of their 25 services, the Department prunes trees, removes dead

2 trees and wood debris, reviews building development 3 plans for their possible effect on nearby trees and response to storms and other emergencies. The public 4 5 plays a key role in helping the Department identify trees in need of maintenance by submitting service 6 7 requests through the 3-1-1 system. Between 2020 and 2024, over 130,000 3-1-1 service requests for dying 8 trees, illegal tree damage, or overgrown branches 9 were submitted. This bill would require 3-1-1 in 10 11 coordination with the Department of Parks to provide 12 tree pruning related callers with links to the Parks 13 Department's tree inspection map, pruning schedules, informational webpages, and any available resources 14 15 on volunteer street tree pruning certification, thereby improving public access to tree maintenance, 16 17 information and encouraging greater community involvement in urban tree care. This Committee heard 18 the bill on February 19, 2025 and received and has 19 evaluated testimonies from the Administration. 20 I would like to thank the Technology 21 2.2 Committee Staff, our Policy Analyst; Eric Brown, 23 Legislative Counsel, Irene Byhovsky; and my Chief-of-

Staff, Anya Lear, for their work on this bill. I'd
