Proposed Intro No. / Title: *Int. 1347 / Enforcing violations against unlicensed commuter vans.*

Summary of Legislation: This legislation would require the Taxi and Limousine Commission (TLC), in collaboration with the New York City Police Department (NYPD) and Department of Transportation, to develop a checklist of state and local laws, rules, and regulations relating to the operation of an unlicensed commuter van, or which relate to the safety and well-being of bystanders or the unlicensed van's occupants. The bill also requires TLC enforcement personnel and NYPD officers to examine the checklist when stopping unlicensed commuter vans to determine which, if any, laws, rules, and regulations have been violated. Notices of violations must be for the maximum monetary penalty permitted by law.

Effective Date: 120 days after enactment
