Mr. Chair, we're ready to 15 begin. 16 CHAIRPERSON CORNEGY: Thank you so much. 17 Good morning, everyone, and thank you for coming. 18 I'm Council member Robert Cornegy, Chair of the 19 Councils Committee on Housing and Buildings. We are 20 here to hold the vote on a bill related to tenant 21 data privacy. We see these systems and residential 22 buildings all over the city. Key fobs, keypads, or 23 even facial recognition technology taking the place of traditional mechanical keys. While it is exciting 24 25 to see the city's housing stock come into the 21st-

2 century, improvements to the residential buildings should always be made with the tenant in mind. With 3 4 all the convenience that key fobs and other keyless 5 entry systems offer, there is a risk that tenants and 6 their guests might have their private information put 7 to use without their authorization. Currently, there are virtually no laws on the books to protect the 8 privacy of tenants and their guests data. 9 If a 10 property owner or manager wants to use the keyless entry system-- excuse me-- that collects or 11 generates data, the city should ensure that neither 12 landlord nor the companies that install or operate 13 14 these systems get to use any data collected from them 15 to harass tenants or to take other kinds of adverse 16 actions against tenants. Tenants shouldn't have to 17 compromise their privacy or security in exchange for 18 convenience. This bill is one step towards ensuring 19 that privacy and security are paramount. Proposed Intro number 1760 A, sponsored by Council member 20 Levine, would establish certain restrictions on the 21 22 collection and use of data generated or collected in 23 connection to the use of a keyless entry system in a 24 multiple dwelling and would require landlords to 25 provide tenants with a written privacy policy

2	regarding the keyless entry system. Among other				
3	things, this bill will set limits on the kinds of				
4	data that these systems are allowed to collect and				
5	would require the consent of tenants and their guests				
6	to collect this data. This bill would also establish				
7	guidelines to destroying, removing, or animal using				
8	any data collected by use in a keyless entry system.				
9	Proposed Intro 1760 A would also limit sharing data				
10	collected with third parties. I am joined today by				
11	Council members which unfortunately, I can't see				
12	the Council members that are with me. If somebody				
13	can help me in reading out those members who are				
14	present for this hearing. I know we have four can
