Introduced by Council Member Dear.

A LOCAL LAW

In relation to approval of the application of Fung Wah Transport Vans, Inc. for authorization to operate commuter van services in the Boroughs of Brooklyn and Manhattan.

Be it enacted by the Council as follows:

Section one. Notwithstanding any other provision of law, the determination of the taxi and limousine commission to authorize the operation of commuter van services in the Boroughs of Brooklyn and Manhattan, is approved as hereafter indicated.

An area in Brooklyn bounded on the north by 39th Street from 9th Avenue to Fort Hamilton Parkway, along Fort Hamilton Parkway from 39th Street to New Utrecht Avenue, along New Utrecht Avenue from Fort Hamilton Parkway to 46th Street, along 46th Street from New Utrecht Avenue to Fort Hamilton Parkway, along Fort Hamilton Parkway from 46th Street to 48th Street, along 48th Street from Fort Hamilton Parkway to 9th Avenue, along 9th Avenue from 48th Street to 46th Street, along 46th Street from 9th Avenue to 10th Avenue, along 10th Avenue from 46th Street to 44th Street, along 44th Street from 10th Avenue to 9th Avenue and along 9th Avenue from 44th Street to 39th Street to and from a central work-related area in Manhattan bounded on the north by Grand Street from Lafayette Street to Bowery, on the east by Bowery

from Grand Street to Canal Street, on the south by Canal Street from Bowery to Lafayette Street and on the west by Lafayette Street from Canal Street to Grand Street.

Hours of Operation

Twenty-Four Hours Daily

§2. In the event that any provision of section one of this local law is adjudged by a court of competent jurisdiction to be invalid, then the determination of the taxi and limousine commission to authorize the operation of commuter van services as hereafter indicated is disapproved.

An area in Brooklyn bounded on the north by 39th Street from 9th Avenue to 12th Avenue, bounded on the east by 12th Avenue from 39th Street to 54th Street, bounded on the south by 54th Street from 12th Avenue to 9th Avenue, and bounded on the west by 9th Avenue from 54th Street to 39th Street to and from a central work-related area in Manhattan bounded on the north by Grand Street from Sixth Avenue to Bowery, on the east by Bowery from Grand Street to Canal Street, on the south by Canal Street from Bowery to Sixth Avenue and on the west by Sixth Avenue from Canal Street to Grand Street.

Hours of Operation

Twenty-Four Hours Daily
