Salaam's District; Sandy Bergen in Council Member
Narcisse's District; Morningside III in Council
Member Abreu's District; TSINY in Council Member
Gennaro's District; the Rosewood Portfolio in both
Council Member Rivera's and Abreu's District; Vesta
Steinway in Council Member Cabán's District, Crotona
VI in Council Member Salamanca's District; and 345
Ovington in my District.
