Summary of Legislation: This legislation requires the Board of Correction (BOC) to investigate any death of an incarcerated person and to post a report with 180 days. If an investigation is not concluded within 180 days, the BOC must post an update on the investigation every 60 days until the investigation concludes. The report shall include any recommendations about measures the Department of Correction (DOC) or Correctional Health Services (CHS) may implement to prevent the circumstances that contributed to the individual's death. Either DOC or CHS shall respond to each recommendation and indicate whether it is being implemented or not. The legislation also authorizes BOC to create the Prison Death Review Board to investigate the death of an incarcerated individual. The Prison Death Review Board shall have representatives from BOC, DOC, CHS, the Office of Chief Medical Examiner, and the Deputy Mayor for Public Safety.

Effective Date: 90 days after enactment
