To Speaker Adams, the City Council, and my New York City neighbors,

This past year, our city has faced obstacles I thought I'd never see in this country. The return of Donald Trump and his administration to power threatened all of us, especially the communities already marginalized and underserved. By threatening our funding and our people, deploying a deportation machine and promising worse, the federal government has thrown the city into uncertainty. And throughout that time, the mayor has been at best an additional unknown, at worst an aid to this harm. In that environment, our role in the Public Advocate's office has been all the more critical.

The Office of the Public Advocate exists to give voice to New Yorkers across every borough— to connect the people to their government, to shine a light on inequities and inefficiencies, and to advocate for the systems and solutions that make this city more just, more affordable, and more humane.

Six years into my time as Public Advocate, I remain deeply proud of how our office continues to meet that goal and serve all New Yorkers—by amplifying community concerns, advancing meaningful legislation, and holding power accountable in service of the public good. The past year has tested New York's resilience yet again—with a growing need for the government to meet people where they are. Through it all, our office has worked to respond with urgency, compassion, and creativity.

In the final year of this term, our Policy and Legislative teams have worked diligently to craft and champion laws that respond directly to New Yorkers' lived experiences, while our Constituent Services team has once again served thousands of residents navigating bureaucratic barriers—from unsafe housing conditions to benefits access and disability services. Each case represents not just a number, but a neighbor we've stood beside in pursuit of justice and dignity.

Our Community Engagement division deepened partnerships with neighborhood groups and advocates, hosting roundtables, town halls, and listening sessions focused on issues ranging

from immigration rights to public health. Across every effort, we have spoken truth to power—supporting city agencies and leaders when they act in service of justice and standing firmly against them when they fall short. That dual responsibility is what defines this office, and it is what drives our team each day.

The pages ahead highlight only a fraction of the work our staff has accomplished this year. If I am lucky enough to continue to serve as Public Advocate in the coming year, that work will continue. The strength of the Office of the Public Advocate lies in our people—their dedication, their expertise, and their unwavering belief that government must work for everyone, especially those too often left behind. I am proud of the progress we have made, grateful for the partnerships that make it possible, and steadfast in my commitment to continue this work with and for all New Yorkers.


Constituent Services

The Office reported 44 cases from constituents related to Federal agencies from June 2024 to June 2025, with most cases being attributed to the Social Security Administration. The second highest number of cases involved Immigration questions or referrals, or Housing and Urban Development. There were also some cases concerning the US Postal Service and Passport Renewal. The percentage of cases closed is 90%.

The Office reported 73 cases from constituents related to State agencies from June 2024 to June 2025. The second most cases were related to the MTA and Access-A-Ride at 18 and 16, respectively. The percentage of cases closed is 94%.

The Office reported 1,439 cases from constituents related to City agencies between June 2024 to June 2025. The most cases were related to the Department of Social Services at 324 cases. The second-highest number was the New York City Housing Authority at 315 cases, followed by the Department of Housing and Preservation Department at 310 cases, and the New York City Public Schools at 81 cases. The percentage of cases closed is 91%.

The issues most constituents bring to the Office of the Public Advocate concern Housing, by far. Numbers for NYCHA, HPD, and those who are unhoused reflected here concern constituents' housing conditions. At the State and Federal level, most constituent cases continue to revolve around Immigration or difficulty receiving government benefits.



Legislation

In Fiscal Year 2025, the New York City Council enacted **one** of the Public Advocate's bills as a Local Law and did not adopt any Resolutions introduced by the Public Advocate. Below is the sole Local Law passed in Fiscal Year 2025 that encompasses the time period from July 1, 2024 to June 30, 2025. It is important to note that this is a substantial decrease from Fiscal Year 2024 where the Public Advocate passed 8 Local Laws.

Local Laws Enacted in Legislative Session 13 of Fiscal Year 2025

■ <u>Local Law 95 of 2024</u> formerly known as Int. 833-A-2024 (A Local Law In relation to requiring the installation and maintenance of an informational sign at the intersection of Wall and Pearl Streets in Manhattan to mark the site of New York's first slave market).

Included in this report are **11 bills** (two Resolutions and 9 Intros) that were laid over in committee in the new legislative session that commenced on January 1, 2024, as well as a link to all of the New York City Council hearings that the Public Advocate delivered or submitted a statement for the record.



Justice & Safety

The Justice & Safety team helps reach the Office's mission of ensuring all New York City residents are treated with dignity by holding city agencies accountable, uplifting holistic approaches to public safety, and empowering community members in order to confront institutions, drive change and achieve justice.

Events

- On July 18, 2024, Public Advocate Jumaane D. Williams participated in the Reimagining Policing Forum, contributing to the launch of strategy sessions for a citywide series of community-led conversations on public safety.
- On July 27, 2024, Public Advocate Jumaane D. Williams delivered the keynote address at the Kevin Shaw Jr. Foundation's 3rd Annual Anti-Gun Violence Event, emphasizing the office's commitment to community-led solutions and highlighting the importance of education as a means to advancement.
- On July 28, 2024, Public Advocate Jumaane D. Williams delivered the keynote address at the National Day of Mourning for Sonya Massey, standing in solidarity with our larger grieving community and amplifying their demands for justice and accountability.
- On July 31, 2024, Deputy Public Advocate for Justice & Safety Jeffrey Severe supported the Men Talk Memorial Candlelight Vigil, an ongoing initiative to create space for men to process grief and trauma related to gun violence.
- On August 6, 2024, Public Advocate Jumaane D. Williams participated in National Night Out, travelling across the city meeting with residents and community leaders in Staten Island, Chinatown, and Harlem to discuss localized approaches to public safety and strengthen community-police relations.
- Later on August 28, 2024, Public Advocate Jumaane D. Williams joined Assemblymember Monique Chandler-Waterman in convening an urgent virtual briefing with other elected officials and stakeholders to address reports of aggressive policing tactics, leading to a coordinated plan for legislative oversight and community support.

- On September 10, 2024, Public Advocate Jumaane D. Williams virtually testified at the NYC Board of Correction's September meeting. The testimony officially registered the office's opposition to the mayor's overreaching with his emergency powers to block Local Law 42. He argued it undermines the democratic process and continues a dangerous status quo on Rikers Island.
- On September 18, 2024, Public Advocate Jumaane D. Williams sat with justice-involved and at-risk youth from the Harlem based organizations Youth Justice Network and Avenues for Justice. These intimate Q&A sessions saw them sharing their experiences and discussing pathways to opportunity, deeply informing the office's work.
- On September 20, 2024, Public Advocate Jumaane D. Williams stood with the family of Gregory Delpeche at a press conference addressing the release of recent body camera footage. The Public Advocate's remarks called for full transparency from the administration and renewed the demand for accountability for questionable actions by officers.
- Later on September 20, 2024, Public Advocate Jumaane D. Williams served as a panelist at another Reimagining Policing Forum in the Bronx, contributing to a vital conversation about building new models of public safety rooted in community trust and investment.
- Later on October 2, 2024, Public Advocate Jumaane D. Williams joined with advocates to mark the 11th Annual International Wrongful Conviction Day. The Public Advocate's remarks honored the resilience of exonerees and advocated for systemic reforms to protect against future injustices.
- On October 5, 2024, Public Advocate Jumaane D. Williams was the featured virtual speaker at the Canadian Prison Law Conference. The presentation shared insights from New York City's legislative battles Local Law 42, contributing to an international dialogue on strategies for ending solitary confinement and advancing human rights.
- On October 14, 2024, Public Advocate Jumaane D. Williams delivered remarks at the Community Capacity Development Human Justice March, highlighting criminal justice reform as a fight for the dignity and well-being of all New Yorkers.
- On October 15, 2024, Public Advocate Jumaane D. Williams delivered virtual remarks at the launch of the "We Deserve to Be Safe" report by Communities United for Police Reform, reinforcing the office's commitment to using data for meaningful change in police accountability and transparency.

- On November 1, 2024, the Public Advocate Jumaane D. Williams partnered with Columbia University's Center for Justice for the *Project Restore Bed-Stuy Symposium*. He helped lead a lively discussion on developing a new "Model for Community Safety." He hailed the pilot program for taking a necessary approach that invests in our youth and emphasizes preventative resources.
- On December 3, 2024, Deputy Public Advocate for Justice & Safety Jeffrey Severe joined the Center for Justice's "Justice Ambassadors Youth Council" conferral ceremony. He was present to support and celebrate the young leaders graduating from the program, looking to empower the next generation of justice reform advocates.
- On February 24, 2025 the Public Advocate led a call, along with New York City Council sponsors of the How Many Stops Act, and Communities United for Police Reform to engage the NYPD about implementation of the law.
- On March 10, 2025 the Public Advocate joined New York City Comptroller Brad Lander at Street Corner Resources to launch a comprehensive report on Community Violence Intervention in New York City and ways to bolster the results of the Crisis Management System.
- On May 29, 2025 the Public Advocate joined Community Capacity Development and other Crisis Management System groups for their Annual Safe Summer press conference kicking off Gun Violence Awareness month. The event precedes a month of furious activities meant to raise awareness and provide resources to those most at-risk to the dangers of gun violence.

Housing & Health Equity

Housing, Health and Equity Portfolio cultivates and maintains relationships with stakeholders across specific issue area(s), including but not limited to community based organizations, advocacy groups, non-profit organizations, and community activists in housing and healthcare.

Events

- Start Loving Us TGNCB Meeting. The Office of the Public Advocate hosts this monthly meeting TGNCB for stakeholders and allies. Participants meet to discuss the reality of loving community and amplify that brown and black trans folks should not be murdered for living in their truth.
- LGBTQ and Health Coordinator Kim Watson-Benjamin represented the Office of the Public Advocate at the HIV Stigma Conference at Lincoln Hospital.
- LGBTQ and Health Coordinator Kim Watson-Benjamin at the City Council Trans Day of Remembrance (TDOR) at the City Council Chambers.
 - The OPA honored Make The Road Organization, Gia Love and Milani Polanco TDOR City wide attendance.
- Black Trans Liberation weekly Kitchen where the LGBT and Health Coordinator attends weekly events volunteering to serve the youth and homeless at the church.
- Staff from the Office of the Public Advocate joined organizers working to address the harmful resolutions against trans youth promoted by Community Education Council 2 (CEC 2).
- The Office of the Public Advocate staff joined advocates at the court hearing and for Beth Israel closure.
- The Office of the Public Advocate and the Comptroller held a first annual Pride Breakfast, honoring community members.

Education & Opportunity

Education & Opportunity team cultivates and maintains relationships with stakeholders across specific issue area(s), including but not limited to community based organizations, advocacy groups, non-profit organizations, and community activists in **education** such as those engaged in our New York City school, **bridges between education and opportunity** that provide pathways to dignified work such as the Summer Youth Employment Program (SYEP),

certification program, and **opportunity** with those engaged in workforce development, labor, workers rights and protections.

Events

- On September 17th, The Office of the Public Advocate hosted a Voter's Education and Registration Event in Partnership with York College in Queens.
- On October 15th, The Office of the Public Advocate hosted an event for Hispanic Heritage Month Event at P.S. 70 The Max Schoenfeld School to honor Hispanic communities, recognize the history, culture, and contributions. The Office brought together a diverse group of musicians, artists, community vendors and a DJ to kick off the celebration.
- On October 16th, The Office of the Public Advocate partnered with Silicon Harlem's Next Gen Tech Conference "Transforming Tomorrow: Innovations that are Re-Shaping Our Communities" to have the Office's Director of Information, Technology, and Data J.C. Brilliant who joined as a featured panelist speaker. In this 11th Annual Next Gen Tech Conference, they explored cutting-edge technologies revolutionizing industries and impacting communities worldwide and aimed to ignite conversations, spark collaborations, and drive actionable solutions to address today's most pressing challenges and opportunities.
- On November 22nd, Young Invincibles featured a keynote speech from Deputy Public Advocate of Education and Opportunity Elizabeth Kennedy at their 2024 State of the New York Young People event.
- On January 13th, The Office of the Public Advocate co-hosted a public event on Instagram Live called "Youth Civic Hub & OPA's 'Beyond Elections.'" The Office of the Public Advocate asked the public to join the Youth Civic Hub for an exciting Instagram Live event in partnership with NYC Public Advocate Jumaane Williams. Together, the event explored how young people can stay engaged in NYC's civic space year-round, even beyond elections. This inspiring conversation highlighted actionable ways to amplify your civic voice, featuring insights from NYC students, educators, and the Public Advocate himself.
- On January 28th, at Union Settlement East Harlem Community Partnership, The Office of the Public Advocate held the "Mobilize New York: Community Organizing Fair." This event was more than a fair, as we hosted grassroots partners and city agencies to share resources, build solidarity, and foster civic engagement with the public.

- On February 21st, Deputy Public Advocate for Education & Opportunity Elizabeth Kennedy partnered with Brooklyn College Professor Valerie Weisler to speak to a Brooklyn College Children's Rights Class about the work of The Office of the Public Advocate.
- On March 25th, the Office of the Public Advocate and the Office of Brooklyn Borough President Antonio Reynoso co-hosted a Women's History Month celebration to honor extraordinary women making impactful contributions to New York City. New York City Council Speaker Adrienne Adams gave a keynote and the Public Advocate presented awards to deserving individuals.
- On April 9th, The Office of the Public Advocate in partnership with New York City Public Schools (NYCPS), The Partnership for the City of New York, and ExpandEd hosted 30 students from Manhattan International High School for Discovery Career Week. The event hosted young people that were interested in a career in education. The event featured a panel discussion, an office tour with students, and engaged in fruitful discussions over lunch.
- On May 6th, the NYC Street Vendor Justice Coalition (SVJC) hosted a celebration rally/ presser to thank all the Champions of the package bills that were voted and passed that same day which included NYC Public Advocate Jumaane D. Williams, CM Sanchez, CM Farias, CM Krishnan and CM DeLaRosa for their tireless efforts and outstanding leadership to get the bills across the finish line.
- On May 19th, the NYC Youth Agenda invited the NYC Public Advocate Jumaane D. Williams to be a keynote speaker at their Dine & Policy Design event where young people shared how to strengthen the coalition impact and hold city leaders accountable.
- On June 5th, the New York City Public Advocate Jumaane D. Williams co-hosted a rally about afterschool for all with the NYC Comptroller's Office, Advocates For Children & New York Appleseed alongside those in attendance featuring Council Member Rita Joseph, Chair of the Committee on Education, Councilmember Gale Brewer, New York City parents, New York City students, New York City educators, and advocates. The rally was held to make clear that All means ALL—that educational programs are not universal if they continue to exclude students with disabilities.

Technology, Development & Data

The past fiscal year of the NYC Public Advocate's Technology, Development & Data team was highly productive, marked by significant **infrastructure improvements**, enhanced **cybersecurity posture**, and the successful **launch of a key public data project**. A major organizational milestone was also achieved with the official election of the Director of IT J.C.Brilliant to Executive Director of CoPIC.

Organizational Challenge

The primary challenge was the **resignation of the Systems Support Engineer** (April–June 2025). The resulting vacancy has placed a heavy operational burden on the Director, Deputy Director, and College Aide, creating risk of burnout and potential delays in non-critical maintenance tasks.

Infrastructure & Environmental Justice

The Infrastructure and Environmental Justice Unit is responsible for assessing the state of our infrastructure within New York City, as well as the impacts of local policy on the environment in the city and beyond. This includes agricultural and internet infrastructure.

- Riders Alliance's Campaign Launch to Improve Buses on Flatbush Avenue to partner with the Pratt Center for Community Development for a Participatory Action Research Project, which aimed to demonstrate how Better Buses along Flatbush Avenue can have a positive economic, civic engagement and health benefits for the community. This project engaged community members, businesses, community leaders, houses of worship, cultural institutions among others. The I&EJ uplifted this project and the Public Advocate attended and spoke at the rally at the launch of the project.
- I&EJ attended numerous congestion pricing rallies in support of continuing congestion pricing after Governor Hochul put a pause on it.
- On July 25th, the PA stood with Comptroller Brad Lander, plaintiffs, and disability rights, climate justice, and transit advocates to call on the Governor to reverse her indefinite hold on Congestion Pricing.
- The Public Advocate joined Uprose's (fabric scrap) FABSCRAP, a festival aimed to raise climate justice consciousness via art and connection in frontline communities.
- The Office of the Public Advocate released information via social media on how New Yorkers can do their part to help save water and prevent fires during the city's Drought Watch.
- On behalf of the Public Advocate, Deputy Public Advocate for Infrastructure and Environmental Justice Kashif Hussein testified at the Department of Buildings hearing in support of strong Local Law 97 rules and regulations.
- In response to concerns about congestion pricing cameras charging cars that are not driving within the congestion pricing zone, at the Queensboro Bridge, the Office of the Public Advocate reviewed constituent concerns in the field, which led to a press conference with the Public Advocate demanding that the MTA move the cameras to a better location.

- As a two-time CUNY grad the Public Advocate supported the launch of the NYC Climate

 Justice Hub at the Summit with Uprose, NYCEJA, The Point CDC, among others.
- Deputy Public Advocate for Infrastructure and Environmental Justice Kashif Hussein testified for the NYS Building Codes Council to adopt the standards required of them by the All-Electric Buildings Act into their 2025 NYS Building Code
- The Public Advocate gave remarks at the Brooklyn Marine Terminal Rally to advocate for a fair and just process that engages the community around the new EDC plan for redeveloping the Brooklyn Marine Terminal.
- The Public Advocate spoke at the EPA rally against the suspension of staff for speaking out on the administration's disregard of scientific consensus and dismantling EPA's Office of Research and Development, canceling environmental justice programs, rolling back key regulations, and undermining EPA's mission to protect public health and the environment.
- On behalf of the Public Advocate, Community Organizer for Infrastructure and Environmental Justice, David Kahn testified at the DEC Hearing on Greenhouse Gas Reporting Rules, and spoke at the press conference beforehand, to advocate for the immediate release of the entire Cap-and-Invest regulations required by the CLCPA Scoping Plan. The first of the Cap-and-Invest regulations released, the GHG Mandatory Reporting Rule, only mandates the reporting of GHG emissions, not limitations on emissions.

Community Affairs

The Community Affairs Unit works to build and maintain relationships across all five boroughs, amplifying the voices of New Yorkers through engagement, civic empowerment, interfaith initiatives, and cultural celebrations. Through collaboration with local leaders, elected officials, faith-based organizations, advocacy groups, and community boards, Community Affairs successfully organized and joined over a hundred events citywide.
