1 CITY COUNCIL STATED MEETING 12 2 after Denim Day. I note this, because April is Sexual 3 Assault Awareness Month and Denim Day is the last Wednesday of April, which was yesterday. It's a day 4 5 of action when we wear denim to acknowledge an Italian rape trial where the survivor was blamed, 6 because of the type of jeans she wore. 7 Pre-Covid every Denim Day the Women's 8 9 Caucus of the New York City Council gathered on the steps of City Hall to vocally show our solidarity to 10 11 combat the notion that rape and sexual violence are the fault of survivors. 12 13 We thank those who assembled yesterday 14 across the city and across the country to commemorate 15 this statement in denim to make it known that women can wear anything, including jeans, and we wish as we 16 17 wish and not be looked upon as sexual objects, so 18 again, happy day after Denim Day. 19 I also want to commemorate and thank 20 Council Member De La Rosa for remember our essential worker's today as well, those who have perished in 21 their line of duty we remember them, we remember our 2.2 23 labor workers who put themselves on the front line when many others did not. They were not able to work 24

remotely when many others were able to, so we thank

2 them and we commemorate them for they... their great 3 work.

I hope you and your families had a peaceful Passover if you celebrate and I hope you and your families had a happy Easter or Resurrection Sunday if you celebrate. And to all New Yorker's who are celebrating Ramadan I hope you continue to enjoy this blessed season with your loves ones.

Just a quick reminder that masks are 10 11 still strongly encouraged whether we like it or not, 12 strongly encouraged to be worn throughout the Stated Meeting in these Chambers. We're still in the midst 13 14 of this pandemic and the contagious BA2 omigron ... 15 omicron subvarient has resulted in an increase in 16 Covid ... Covid cases across New York, so let's continue 17 to exercise caution and let's be safe.

18 Today colleagues we are voting on two 19 bills, two resolutions and several Land Use and 20 finance items. Before I begin I'd like to honor FDNY 21 fire fighter Timothy Klein, a 60 year veteran of the department who died while bravely responding to a 2.2 23 fire in Brooklyn last weekend in Council Member Narcisse's district in Canarsie. That fire also 24 killed young Carlos Richards, the 21 year old son of 25

a retired NYPD officer and a register nurse. Our 2 3 hearts go out to the family and friends of fire 4 fighter Klein and Carlos Richards along with Ladder 5 Company 170 and the entire FDNY. As a city we're grateful for fire fighter Klein's service, his 6 7 dedication and his sacrifice to save the lives of his fellow New Yorker's. We know many other fire 8 9 fighter's risked their lives that day and were also injured and we wish them well and we wish them a 10 11 speedy recovery. May we all stand for a moment of 12 silence to remember those who have lost their lives 13 in the line of duty this week. Thank you.

On Tuesday, Mayor Adams released his 99.7 billion dollar executive budget for fiscal year 2023, the next step in the budget process for our city. Over the coming days and weeks the Council will begin examining the details of the executive budget and it's funding for every city agency including in our executive budget hearings.

We will kick off the first executive budget hearing on Friday, May 6th with the Committee on Finance along with the Committee on Fire and Emergency Management and the Committee on Parks and Recreation and we will conclude on Wednesday, May

2 25th with a hearing solely de... dedicated to public3 testimony.

While we're just beginning to dive into the finer details of the Mayor's executive budget what I will say is that this Council has made it clear that New Yorker's need a budget that will strengthen communities, expand opportunity and advance in equitable recovery to make our city safer, healthier and stronger.

We spoke with a unified voice on the needs of our communities and city in our preliminary budget response. As a result, we colleagues move the needle for our city between the preliminary and executive budgets to a greater extent than past Council sessions.

17 The Mayor's executive budget has 18 incorporated many of our funding priorities from 19 homeless services and housing assistance to summer 20 youth program and mental health emergency response and while we certainly appreciate the Mayor, that the 21 Mayor has listened to the Council in many places, we 2.2 23 know there is much more work to be done to add essential investments in certain areas and scrutinize 24 25 spending decisions in others to ensure that New York

2 City has the budget our communities need to be 3 healthy, safe and thrive.

As a unified Council I'm confident that together we can succeed in achieving this goal and I look forward to working with each of you and the stakeholders from our communities as we work towards enacting city budget with the Mayor.

9 Now, let's go ahead and dive into our agenda for the day. We will vote on the following 10 11 Land Use items, new providence redevelopment, a new 24 story building to include a medical clinic 12 approximately 171 shelter beds, 130 housing units, 79 13 supportive units and 51 affordable units in Majority 14 15 Leader's Power's district, Our Lady of Pity rezoning 16 will facilitate the construction of two new nine 17 story buildings with 205 housing units, 100% of which will be affordable in Land Use Chair Salamanca's 18 19 district, 1220 Avenue P rezoning will facilitate the 20 development of a four story approximately one ... approximately 11,000 square foot expansion to the 21 Levit Medical Center in Council Member Vernikov's 2.2 district. Sutter Avenue rezoning will facilitate the 23 development of a five story mixed use commercial and 24 25 affordable housing building with 28 units. The

2 Council is modifying the application to ensure the 3 lower income MIH options and reduce the rezoning area 4 to preserve the neighbor... the neighboring small homes in Council Member Barron's district. 3285 Fulton 5 Street rezoning will facilitate the development of a 6 7 new seven story mixed use community facility and residential building. It will include 33 affordable 8 9 senior housing units. The Council is modifying the application to ensure the lower income MIH options 10 11 and reduce the rezoning area to preserve the 12 neighboring three story mixed use buildings in 13 Council Member Nurse's district. Lastly, two rezoning 14 applications in Council Member Hudson's district. 15 1034-1042 Atlantic Avenue rezoning will facilitate the construction of two new mixed use commercial and 16 17 residential buildings. A 17 story building on 18 Atlantic Avenue and a nine story building on Pacific 19 Street, which will together include 210 housing 20 units. The Council will be modifying the application to ensure the lower income MIH options and reduce the 21 rezoning area to maintain a mix of residential and 2.2 23 industrial uses until a community-wide plan is implemented. 870 through 888 Atlantic Avenue rezoning 24 will facilitate the construction of a 17 story mixed 25

2 use commercial and residential building with 3 approximately 228 housing units. The Council will be 4 modifying the applications to ensure the lower income 5 MIH options.

We will also vote on the following 6 7 finance options, Introduction 47 would establish the Castle Hill Business Improvement District in Council 8 9 Member Farias's district Council... Council district. The proposed bid would include properties along 10 11 Castle Hill Avenue and along Westchester Avenue and is centered around the Castle Hill Avenue's six train 12 13 station. The bid projects a first year budget of 14 300,000 and proposes to offer such things marketing, 15 holiday lighting, street cleaning, graffiti removal, 16 administration and advocacy services. Intro 73 would 17 establish the West Village Business Improvement District in Council Member Bottcher's Council 18 19 District. The proposed bid would include property's 20 on five major commercial strips, 7th Avenue South, 21 Avenue of the Americas, west side only, Bleeker Street, Christopher Street and West 4th Street. The 2.2 23 bid projects a first year budget of \$600,000.00 and proposes to offer such things as marketing, holiday 24 lighting, street cleaning, graffiti removal, 25

administration and advocacy services. Reso 137 would 2 3 grant a 40 year full Article 11 property tax exemption to the 13-12 Beach Channel Drive located in 4 Far Rockaway in Majority Whip Brooks-Powers district. 5 The development would consist of a single eight story 6 7 building that would include both a 100 bed shelter and 147 units of affordable supportive housing. We 8 9 thank Noah Brick for his staffing help.

10 Moving on we will now vote on the 11 following legislation. First, we have some 12 immigration related resolutions sponsored by our 13 Immigration Committee Chair, Council Member Shahana 14 Hanif. Resolution 84A calls for the passage of 15 coverage for all, which would create a state funding essential plan for low income individuals currently 16 ineligible for insurance due to their immigration 17 18 status. The state's essential plan has provided 19 health coverage to almost 1 million enrollees at a 20 savings to New Yorker's of almost 1.5 billion dollars 21 a year, however, it currently excludes many 2.2 immigrants, because of their immigration status. The 23 State Legislation sponsored by Senator Gustavo Rivera and Assembly Member Richard Gottfried would build 24 25 build upon the success of the essential plan by

expanding coverage for health care services to 2 3 individuals whose immigration status renders them ineligible for federal financial participation. 4 Resolution 112 would call on the New York State 5 Legislature to pass the New York for All Act, which 6 7 broadly prohibits state and local officers from enforcing federal immigration laws, funneling people 8 9 into ICE custody and sharing information with federal immigration authorities. It also prohibits ICE and 10 11 Customs and Border Protection or CBP from entering non-public areas of state and local property without 12 13 a judicial warrant. The legislation ensures people in 14 custody are given notice of their rights before being 15 interviewed by ICE and finally this bill starts the process of limiting ICE and CBP access to state 16 17 information databases. 18 We thank our staff Harbani Husem (sp?),

J.C. Gunapti (sp?) and Jenny Florentine Kabore.

20 Next the Council will vote on Intro 14A 21 sponsored by Council Member Justin Brannan, which 22 would require the division of economic and financial 23 opportunity within the New York City Department of 24 Small Business Services and the Mayor's Office of 25 Contract Services to use the most recent data

available when considering revisions to city-wide
MWBE participation goals. This bill would require the
agencies to use more current data in conducting
future disparity studies in order to evaluate the
implementation and effectiveness of the MWBE program
and direct efforts to increase the capa... capacity of
MWBE.

9 We thank your staff Alex Polinov, Leah 10 Scrapiek (sp?), Michelle Lee and John Russell.

11 Finally, the Council will vote on Intro 134A, which would amend local law 32, also known as 12 13 the salary transparency law. Local law 32 makes it an 14 unlawful, discriminatory practice to post any job 15 listing that does not include the minimum and maximum 16 salary offered for the position. The purpose of that law was to bring more transparency to job seekers and 17 18 help eliminate inherit bias in setting employee 19 salaries. The law is scheduled to go into effect next 20 month. In order to improve the successful implementation of local law 32, this bill aims to 21 clarify the types of positions the law applies to, 2.2 23 limits any unintended consequences for small businesses and non-profit organizations without 24 significant back office operations and maintain 25

2 strong salary transparency requirements. Intro 134A clarifies that the salary transparency law includes 3 4 positions that are paid at an hourly wa ... wage in 5 addition to those with an annual salary. This legislation took lots of time and lots of 6 7 conversations with all stakeholders striking a 8 balance to reach agreement between pay equity 9 advocates who champion this bill and the small business community. It's an example of how the 10 11 legislative process can and should work. The Council brings both sides of an issue together to engage in 12 13 the meaningful and substantive details of a bill, 14 listens to concerns to make its assessment and 15 arrives at a better bill that everyone can support. I sincerely applaud and I'm proud of 16 17 prime sponsor and Civil and Human Rights Committee 18 Chair Nantasha Williams who led this process through 19 hearings and many deliberations with stakeholders as 20 well as her prim her co-prime sponsor Council Member 21 Justin Brannan. We thank you. We thank our staff 2.2 Gisari Gunapti (sp?), William Deyorkie (sp?), Rachel 23 Cordero, David Sitzer and Jack Kern for their help on this legislation. 24

The truth across the board is that the status quo isn't working for New Yorker's. Amid an every changing city confronted with new challenges we continue to rely on systems that neither deliver for the most vulnerable among us nor begin to consider the well-being of the millions of people living in our cities margins.

9 We're reluctant to give up a system that puts a price on our community's, rewards patronage 10 11 politics and caters to the wealthy and powerful. As a 12 result, we're forced to face new and emerging challenges while we continue to experience issues of 13 14 times past taking one step forward only to take two 15 back. This is the case for how we've sought to 16 address the housing and affordability crisis that 17 plagues New York, but today we can set a new standard 18 for private developers, flip the power dynamics that 19 have long contributed to the massive exodus of our 20 poor and working class, black and brown neighbors and 21 ensure our community's take the reins when deciding 2.2 who gets to build what and where.

23 With these two projects on Atlantic 24 Avenue we're setting the tone showing that developers 25 can stand to give much, much more than required under

2 the Mandatory Inclusionary Housing Program. We have 3 the chance to create more than 150 units at historic rates of affordability. 35% of each building's total 4 floor area will be allocated for affordable units and 5 this is without subsides. A majority of these units 6 7 will be set aside for families of two making between 38,000 and 57,000 per year or 40% and 60% of the area 8 9 median income respectively. A smaller subset of the affordable units will be set aside for families of 10 11 two making 80% AMI or \$76,000.00 per year.

12 Additionally the developers each agreed to contribute \$100,000.00 to a tenant and deed theft 13 14 protection fund. When the median household income for 15 black residents is \$40,000.00 in this community these 16 are the levels of affordability we have to set as the 17 floor and the reality that we should take into 18 account when we're considering new developments. If we're not building for those who are already living 19 20 in our community's we are complicit in the syst ... 21 systematic displacement of black residents in historically black parts of our city. Across our city 2.2 23 developers can stand to give much, much more. They must provide greater quantities of affordable housing 24 at deeper levels of affordability and must commit to 25

25	and step with the community.

2	After listening carefully to feedback
3	from advocates in the business community on April 5th
4	regarding Intro 134, an action which considers
5	provisions for small business owners that may have
6	not had the ability to carry out employee and salary
7	actions in advance. As their big business
8	counterparts, we have worked to reach an end that
9	reflects the needs of everyone.
10	Mirroring the spirit of some of our
11	champions around equal equal pay including Reverend
12	Addie Wyatt, Betty Dukes, Kangela Moore, my former
13	community board member and confidant and the Queen of
14	the Beehive Beyonce, here are a few of the
15	adjustments we have incorporated. We have clarified
16	that jobs paid an hourly wage be subject to the
17	salary transparency requirement, which was intended,
18	but not indicated in prior language. We have also
19	removed general notices that state em that state
20	employees can hire without reference to a particular
21	position. We ensure that nearly all virtual jobs
22	performed in New York City or for New York City
23	employee can be covered under the bill. Lastly, we
24	have worked to keep an extension to allow for viable
25

2	time for small businesses and the agency charged with
3	enforcing to be in compliance with this new law.
4	With this expansive work we are carrying
5	out to strengthen our paid equity measures here are a
6	few things I want us all to keep in mind. Research
7	included with our power advocate showed that women
8	earn approximately \$10,157.00 less than their male
9	counterparts annually. According to the New York City
10	Commission on Gender Equity in New York City a white
11	woman earns \$.84 for every dollar a white man earns
12	while a Hispanic woman working full time earns \$.46,
13	an African woman earns \$.55 and an Asian woman earns
14	about \$.63.
15	We are now living in 2022 and thinking
16	about these statistics is rather startling, but it is
17	my hope that this body will continue to refine
18	measures to break down barriers like this and ensure
19	that everyone has a seat at the table when it comes
20	to pay equity. As a black woman
21	MAJORITY LEADER POWERS: Thank you

This will 5 simply require additional words in an advertisement 6 7 and it won't do what I believe we think it will do to 8 create pay equity and without that direct attachment 9 from the act of this body to the result that it is intended its unconstitutional compelling of speech. 10 11 This violates the First Amendment and that's why I voted no in the last session, I'm voting no in this 12 session as well. 13

14 I will also vote no on Intro's 47 and 73, 15 not gonna make a whole bit spiel about it, but as I said in the past I appreciate very much the work of 16 17 my colleagues to bring services into their districts 18 where they are desperately needed, because the 19 streets are dirty, because the services are not 20 coming from the government. People who live there and 21 the people who own businesses there are paying for 2.2 those services, so if we're going to create a bid and 23 the bid is going to do assessments on those property owners, those property owners oughta receive a credit 24 back from the property taxes that they're paying for 25

13	introduction and reading of bills.
14	SPEAKER ADAMS: All bills have been
15	referred to Committee's as indicated on today's
16	agenda.
17	MAJORITY LEADER POWERS: Thank you, Madam
18	Speaker. We'll now move into discussion Resolutions.
19	We have two members signed up on today's Resolutions
20	that we're voting on. We first will hear from Council
21	Member Hanif.

2 this Council's commitment to immigrant rights in a 3 sanctuary city.

4 The first is Resolution 84 in support of the Coverage for All Act, which I was proud to 5 introduce alongside Council Members Abreu, Moya, 6 7 Schulman and Lee. Coverage for All would end the exclusion of undocumented New Yorker's from the New 8 9 York State Essential Plan, which provides health coverage for those of low incomes. This exclusion has 10 11 immense consequences, an estimate 2,000 undocumented New Yorker's have died preventable death of Covid 12 solely due to their lack of health coverage. 13

In the fiscal year '23 enacted budget the state took an important first step by expanding essential plan access to undocumented seniors. The state can and must go further by passing the act in full to cover all New Yorker's.

19 The second is Reso 112 in support of the 20 New York for All Act, which I introduced with our 21 Public Advocate Jumaane Williams. This act would 22 significantly reduce state and local government's 23 collaboration with ICE through a number of mechanisms 24 including prohibiting law... local law enforcement from 25 inquiring about immigration status. This would

5	MAJORITY LEADER POWERS: Thank you, and
6	now we're gonna hear from Council Member Cabàn

8	COUNCIL MEMBER CABAN: Thank you. I'm
9	speaking in support of the Reso on HR2070. This bill
10	and like the statehood bill that imposes a particular
11	status on Puerto Rico is a bill that uniquely
12	acknowledges the history of colonization and is the
13	only bill clearly and deeply committed to a
14	democratic process, puts all options on the table,
15	lays out a process for education and engagement and
16	what that means for the island's future, self-
17	determination as a human right.
18	I'm a proud Nuyorican with family on the
19	island and across the U.S. and yesterday I spent the
20	day in D.C. with Puerto Ricans living and organizing
21	on the island and the message was clear, things are
22	getting worse and this is a matter of life and death.
23	Puerto Ricans have survived every manner
24	of disasters, hurricanes, earthquakes, La Promesa,
25	imperialism, austerity, political corruption. In

2	Puerto Rico we call it la brega, the perpetual
3	struggle. Our people are tired and we deserve the
4	right to chart our own path forward.

5 I urge city leaders to support Deputy 6 Speaker Ayala's Reso supporting Congressman Nydia 7 Velazquez's self-determination bill and finally for 8 mi familia... (inaudible) and to everyone and that I 9 ask for many of whom call New York City home... 10 (inaudible) we got us, so thank you.

MAJORITY LEADER POWERS: Thank you. And now we're gonna hear from Council Member Barron.

13 COUNCIL MEMBER BARRON: I stand to support 14 both of these Resolution's, you know I'm sure all 15 Resolutions can be made better or whatever, but I 16 support both ... both of these Resolution's, 17 particularly the independence of Puerto Rico. I have 18 been constantly in support of that, Don Pedro, Albizu 19 Campos, Lolita Lebron, these were giants in our 20 movement for liberation and for the independence and self-determination of Puerto Rico, so we have to 21 support those who fight against imperialism, fight 2.2 23 against multi-national corporate exploitation and who are fighting against capitalism as it raise ... reaches 24 its tentacles to continue a Colonial economy across 25

this world, so a blow against imperialism and 2 3 capitalism in Puerto Rico is a blow against it in Africa and the Carribean and other countries around 4 5 the world, I support this Resolution. And also I was raising my hand, 'cause I was trying to find out how 6 7 do we get on the ... the list, I was wanting to get on the list for... if you could put me on the list for 8 9 the open discussion I'd appreciate it. Thank you.

10 MAJORITY LEADER POWERS: Thank you, is 11 anyone else signed up to speak on the resolutions? 12 Okay, thank you. And now we'll have a voice vote on today's Resolution's. If you wish to vote against or 13 14 abstain from either of today's Resolution's, please 15 notify the legislative documents unit by e-mail or 16 approaching the day before the vote. If anybody wants 17 to come up now we will ... I will now read today's 18 Resolution's into the record.

19 Resolution 84A calls on the state 20 legislature to pass and the Governor to sign Assembly 21 Bill number 880A and Senate Bill 1572A to provide 22 coverage for health care services under the basic 23 health program for individuals whose immigration 24 status renders them inel... ineligible for federal

Resolution 112 calls on New York 10 state legislature to pass and the Governor to sign 11 the New York for All Act, Assembly Bill number 230 ... 12 2328A and Senate Bill number 3076A, which would 13 prohibit and regulate discovery and disclosure of 14 immigration status by New York state and local 15 government entities. Will all those in favor say aye? 16 COUNCIL MEMBERES: Aye. 17 MAJORITY LEADER POWERS: All opposed say 18 nay. 19 COUNCIL MEMBERS: Nay. MAJORITY LEADER POWERS: Any abstentions? 20 COUNCIL MEMBER KAGAN: Abstain. 21 2.2 MAJORITY LEADER POWERS: Council Member 23 Kagan. The aye's have it. We are now going to move into general discussion, before we do that I just 24 25 wanna note we have almost 25 people signed up today

for general discussion. 11 Today I'm going to speak about Intro 210, 12 which I'm co-prime sponsoring with my colleague, 13 Majority Whip and Council Member in the 31st Council 14 District, Selvena Brooks-Powers. For decades the 15 waters around New York City were viewed by many as 16 little more than a dumping ground clogged with 17 derelict vessels and littered with debris. Our 18 waterways, in Jamaica Bay in particular, were 19 transformed into floating junkyards where 20 unscrupulous boat owners would abandon their property 21 without fear of repercussion. 2.2 In recent years thanks to the hard work

an dedication of groups like the Jamaica BayEcowatchers and the American Literal Society, many

2 others, we've begun to see a renaissance in our 3 waters.

Water quality is better than it has been at any point in living memory. Marine life is returning and the residence and visitors alike are able to engage with our bays and rivers in ways previously thought impossible.

9 This bill would seek to build upon this rebirth of New York's waterways and ensure that we 10 11 can continue moving forward to make this city a 12 better, cleaner place for us to enjoy. This bill would create a brand new office of marine debris 13 14 disposal and vessels surrendering, which would be 15 responsible for coordinating cleanup efforts across 16 the city, removing abandoned boats and marine debris 17 from our beaches and shorelines.

Additionally, this office would develop programs to encourage boat owners to dispose of their vessels responsibly through city programs rather than abandon them as they had in the past. I ask my colleagues to support and sign onto this bill, so that our waterways can continue its ecological renaissance. Thank you.

2 MAJORITY LEADER POWERS: Thank you Council 3 Member. Now Council Member Gutiérrez, Council Member 4 De La Rosa and just remember that we have two 5 minutes, thanks.

COUNCIL MEMBER GUTIÉRREZ: Thank you 6 7 Majority Leader. I'm excited to introduce my first pieces of legislation today, finally, Amen. As a new 8 9 mom I'm excited to move the work forward in improving New York City for mother's and caregiver's and 10 11 strengthening educational opportunities for children through these bills in coordination with Council 12 Members mom... new mom Council Member Julie Won who's 13 here and Council Member, mom to be, Council Member 14 15 Pierina Sanchez. Intro 242 would establish a martial 16 plan for mom's task force to develop and issue 17 recommendations on how to support working mothers and 18 caregivers. It's always been difficult to be a 19 working mom, but particularly in light of issues that 20 have become more acute during the pandemic it's critical to create a new frame work of support as we 21 2.2 enter a new normal both in the work place and in our 23 daily lives.

Intro 241 provide... will provide publicschool students with mobile hot spot devices as saw

2 throughout the past two years. The digital divide is 3 a huge barrier for students throughout the five 4 boroughs and their ability to join classes remotely and do school work hinges on their access to internet 5 connectivity. Guaranteeing mobile hot spots to public 6 7 school students would enable more opportunities for 8 learning and begin to address the disparities and 9 educational attainment in our city.

With a minute to spare, finally, I'm 10 11 introducing Intro 240 to enable 311 to be able to 12 update complaint types and more accurately categorize the more than 40 million customer contacts that 311 13 14 receives annually. As a city agency with their finger 15 on the pulse of what is occurring throughout each 16 community, the kinds of complaints received evolve 17 over the years and this bill would require 311 to 18 incorporate those changes. I would be honored to have 19 you join me as a sponsor on all of these bill. Muchas 20 gracias.

21 MAJORITY LEADER POWERS: Very good. We'll 22 go to Council Member... thank you. Okay, we'll go to 23 Council Member De La Rosa followed by Council Member 24 Williams and then Council Member Riley.

2 COUNCIL MEMBER DE LA ROSA: Thank you Mr. 3 Majority Leader. I wanna thank Madam Speaker and our 4 colleagues for joining us this afternoon as we commemorate Worker's Memorial Day on April 28th. 5 Across the world we recognize the sacrifices made by 6 7 workers and we commit to renewing our fight for strong safety and health protections for all working 8 9 people here in our city and across the globe. I will soon be introducing legislation to address the lack 10 11 of reporting on city work place fatalities and look 12 forward to having all of your support. 13 Like many of our colleagues today I'm also introducing several pieces of legislation and 14 15 I'm asking for your support. The first Intro 231 is a

16 local law that I'm introducing with Borough President 17 Mark Levine that calls for the creation of a 18 residential parking permit in Northern Manhattan. The 19 issues of parking are often controversial. Many local 20 residents who have made the decision to own a vehicle 21 have historically complained about the lack of street

parking available to them and others have argued for 23 the reduction and reliance on personal use vehicles

and call for investment in our transportation 24

alternatives. This legislation takes into account 25

2 both of these realities with a pilot that will 3 generate needed revenue that can be invested right 4 back into our city's street infrastructure.

The second, Intro 232, jointly with 5 Council Member Farias, establishes a task force to 6 7 study gender pay disparity and economic self-8 sufficiency among the labor force in New York City. 9 We must work hard to eliminate the gender pay gap once and for all and this task force will review the 10 11 labor force and all its sectors to determine the best 12 methods to measure the gender pay disparity across 13 our city.

14 And then finally, we have Resolution 131, 15 which calls on Wendy's to join the Fair Food Program, 16 which supports farm workers in the fast ... working in 17 fast food corporation's by address issues of unfair 18 wages, abusive work conditions and access to breaks 19 and safe transportation to work. Many individuals 20 that work in the fields are immigrants that ensure 21 that our... the food we eat is safe and we are asking 2.2 Wendy's to join other corporation in the Fair Food 23 Program, so that these workers can have dignity. Thank you so much. 24

3	industry. Welcoming cannabis to New York City creates
4	an opportunity to encourage vital and economic
5	recovery, secure job opportunities and creates
6	successfully businesses in successful businesses,
7	excuse me, is evident that the industry had the
8	ability to expand our economic recovery as it has in
9	other major cities throughout the country.

Today I'm proud to lead with Council 10 Members Williams, Stevens, Farias and Nurse to 11 12 reintroduce Intro 285, which would establish a New York City Office of Cannabis Business Services. Not 13 only would this bill be a key factor in expanding 14 15 outreach and participation to create a successful 16 cannabis economy for our city, this office is 17 centered in security equitable resources and supportive services to communities of color who have 18 19 been long been targeted while others have thrived in this industry. 20

An Office of Cannabis Business Services will align with the state's cannabis agenda to serve the people at the local level. With the commitment from Mayor Adams to provide significant investments to make New York City the nation's most equitable

2 cannabis industry this piece of legislation would 3 support the vision.

I'm also introducing Reso 135. Many New
York families rely on safe transport of our school
busses to guide our children to and from school.
Securing their safety is always top priority and
updating legislation that calls to enhance those
efforts should be an easy decision.

10 Reso 135 will require all New York State 11 school busses to have two functioning stop arms on 12 each side of the bus for safe operations. This is a vi... this is vital to increase our children's safety 13 14 in creating higher visibility for driver's to 15 exercise caution and come to a complete stop. Any bus 16 that does not have both functioning stop arms will be 17 deemed unfit to keep children safe and thus have no 18 place on our streets.

I encourage Governor Hochul and New York State Legislative to sign LS7814, a similar piece of legislation that will go a long way in saving many children's lives. Thank you.

23 MAJORITY LEADER POWERS: Thank you Council 24 Member Riley. We'll now go to Council Member Joseph

2 followed by Council Member Ossé followed by Council3 Member Cabàn.

4 COUNCIL MEMBER JOSEPH: Thank you Majority 5 Leader. Today I'm introducing my first bill along 6 with Borough President Mark Levine mandating that the 7 Department of Parks and Department of Transportation 8 identify locations where the city can install public 9 bathrooms.

Introduction 258 will specifically 10 11 require these two agencies to find public bathroom sites in every zip code across the five boroughs. We 12 13 need more than one per zip code, but this is 14 certainly a step in the right direction. The lack of 15 public restrooms hurt everyone. I'm sure every single 16 person can think of a time when they were stranded 17 and had to search for a business that had a bathroom 18 they could use.

When we don't have public bathrooms we smell human waste in public parks, in our subway stations, in our neighborhoods, no one wants to see that. We can prevent this by providing public bathrooms that the city will clean and maintain for everyone. Everyone needs a place... a safe place to use the restroom, this will improve the quality of life

for every New Yorker, it will keep our neighborhoods clean and sanitary. It is good business, it just makes sense. I hope that my colleagues will consider signing onto this bill. Thank you.

6 MAJORITY LEADER POWERS: Thank you. We're 7 gonna go to Council Member Ossé followed by Council 8 Member Cabàn.

9 COUNCIL MEMBER OSSÉ: Thank you Majority Leader. Today I will be introducing three pieces of 10 11 legislation. The first bill Intro 278, which I introduced on behalf of Brooklyn Borough President ... 12 13 President Antonio Reynoso takes on a plight that too many New Yorker's know too well, package theft. It 14 15 will require all new residential developments to have 16 a secure delivery storage room.

Decades ago thieves declared open season on our lobbies. Every day 90,000 packages are stolen in this city depriving our neighbors of everything from prescriptions to Christmas presents. The Covid surge in home deliveries assigns greater urgency to the issue, it's time to act.

The second bill, Intro 275, one I am copriming with Council Member Avilés, Bottcher and Narcisse, will require the Department of Homeland

Services to provide trainings on cultural 2 3 sensitivity, de-escalation tactics and trauma 4 informed approaches for their staff and public facing 5 contractors. Requiring these trainings will ensure that those serve the unhoused do so with respect and 6 7 care. Homelessness is trauma and serving those who 8 face it we must prioritize the universal human right 9 to dignity.

And finally the third bill, Intro 277, 10 11 one I am co-priming with Council Member Althea 12 Stevens, is deeply personal to me. It will prohibit 13 the use of the NYPD strategic response group to 14 respond to protests. Prior to entering the Council I 15 organized with the Black Lives Matter movement. We 16 marched and fought for safety, justice and dignity 17 for black folks in New York City and beyond. 18 Although, our right to assemble and protest is 19 protected by the United States Constitution, my 20 fellow organizers and I were met with fleets of 21 militarized NYPD forces on the streets who beat and 2.2 brutalized peaceful protestors while trampling on our 23 nation's founding document.

The summer of 2020 proved once and forall that the matter in which the SRG exists and

8	Having seen what we've seen and knowing		
9	what we know this legislation is common sense and I		
10	hope all co-sponsor. Thank you.		
11	MAJORITY LEADER POWERS: Thank you Council		
12	Member Ossé. We'll go to Council Member Cabàn		
13	followed by Council Member Menin.		
14	COUNCIL MEMBER OSSÉ: I'll get you that		
15	pen. Thank you. HRA's utility allowance rule means		
16	that CityFEPS is not functioning the way the Council		
17	originally envisioned it, that our neighbors are		
18	experiencing homelessness that are experiencing		
19	homelessness are faced with unnecessary barriers to		
20	finding the housing that they are entitle to.		
21	So Intro 229, which I'm introducing today		
22	is a simple piece of legislation that will eliminate		
23	that technicality, shorten stays at homeless		
24	shelters, lift bureaucratic red tape, save the city

3	is to say a safer and healthier city.
4	I wanna thank you my colleague Deputy
5	Speaker Ayala for her partnership on this vital rule
6	change and I urge all of my colleagues all to… to
7	sign on as co-sponsors. Thank you.
8	MAJORITY LEADER POWERS: Thank you. We'll
9	go to Council Member Menin followed by Council Member
10	Kagan.
11	COUNCIL MEMBER MENIN: Thank you so much
12	Majority Leader Powers. Today I am proud to introduce
13	along with Council Member's Won and Council Member
14	Williams Intro 262, which would require the
15	Department of Small Business Services to establish a
16	letter grading system for MWBE's. It is far time for
17	the city of New York to actually do the work that's
18	needed to give our MWBE's vital resources in terms of
19	contracts. MWBE's are falling incredibly short in
20	obtaining New York City contracts.
21	In fiscal year '21 only around 4% of city
22	contracts went to MWBE's. This is honestly
23	unconscionable. I've seen first-hand the city does
24	little to try to promote economic opportunities for
25	MWBE's and this bill would require SBS to letter

2 grade all city agencies and would finally create 3 accountability and transparency, so I urge my 4 colleagues to please sign on. Thank you.

5 MAJORITY LEADER POWERS: Thank you. Now 6 we'll go to Council Member Kagan followed by Council 7 Member Nurse.

8 COUNCIL MEMBER KAGAN: Thank you. Next 9 year we will celebrate 100th Anniversary for famed internationally recognized landmark Coney Island 10 11 Boardwalk. In the last 10 years a lot of parts of our 12 boardwalk have become dangerous to walk for both local residents and visitors. According to New York 13 14 City controller city paid millions of dollars in settlements for claims for ... for victims of boardwalk 15 16 who ... who were hurt, injured or seriously wounded just 17 by walking and they were hurt by holes, nails and 18 broken planks. I'm looking forward to working this 19 administration particularly the Parks Department, 20 Economic Development Corporation and other city 21 agencies to restore the glory of Coney Island Boardwalk using city funds as well as federal 2.2 23 assistance from federal infrastructure funds. Communities of Southern Brooklyn deserve our own 24 beautiful and hospitable boardwalk as a place for 25

Now we're going to Council Member Nurse followed by 5 Council Member Dinowitz. 6 7 COUNCIL MEMBER NURSE: Good afternoon again colleagues. Thank you all for your support on 8 9 the resolution for Puerto Rico on behalf of my family members. 10 11 Today is a great day for the war on trash and I'm so excited that New York City potentially can 12 recommit to a serious and aggressive path towards 13 14 zero waste to landfills or incinerators by 2030 and 15 universal curbsi... curbside organics is the clearest, 16 fastest way to get there. I'm so excited to be re-17 introducing a number of bills with CM's Bottcher, 18 Ossé, Menin, Gutiérrez, Hanif, Powers and Cabàn, 19 which will require New York City to establish a goal 20 of achieving zero waste by 2030 and for the city to 21 report on meeting that goal. I am also so proud to stand with my dear 2.2 23 colleague Hanif and other members as a co-prime on universal curbside organics for every neighborhood in 24

New York City. I believe New York City has a real

1 CITY COUNCIL STATED MEETING 74 2 chance to be a national and global leader on this 3 issue and what an achievement it will be when we get it done. 4 And lastly, 420 month is not yet over, so 5 I am very excited to be a co-prime on CM Riley's bill 6 7 that will bring much needed technical assistance and support to our legacy folks and communities. The 8 9 current law as written is already stacked with barriers against those who need to be first to 10 11 benefit, so we need to urgently get our legacy folks up to date, equipped and prepared to benefit first 12 13 from this new law, so thank you. 14 MAJORITY LEADER POWERS: Thank you. We'll 15 now hear from Council Member Dinowitz followed by 16 Council Member Stevens. 17 COUNCIL MEMBER DINOWITZ: Thank you Majority Leader. Colleagues, friends, today is Yom 18 19 Hashoah, a day where we remember the Holocaust. One 20 of the things that we say on Yom Hashoah is ... is never 21 again. Never again will we as a ... as a people collectively suffer, never will there be another 2.2 23 genocide, never will a people's babies be ripped from their arms and people dig their own graves and watch 24 each other into the gas chambers, but as time passes 25

2 since the Holocaust and as more and more of our 3 survivors leave this earth the phrase never again is 4 losing meaning and we are seeing significant 5 increases and anti-sematic acts of hate, anti-sematic 6 hate crimes here in New York City.

7 ADL just released a report two days ago, 8 Wiesenthal Center released a report today, violence 9 against our Jewish brothers and sisters is up over 200% since last year, harassment in K through 12 10 11 schools is up over 100% in the... in the past year and this our city. This is the city where my wife and I 12 13 are raising our boys who are descendants of 14 survivors. So as time moves on and as we see this 15 increase in hate there is a heavy burden I think upon 16 all of us to make sure that when we say never again 17 we mean it and I ... I implore you all ... there are two 18 things we can all do. One is to speak out anytime 19 there is an act, anytime you could be an ally, don't 20 be silent, 'cause there is no such thing as an 21 innocent bystander and the second I would ask that 2.2 you use your platform, your time, your energy, your 23 resources to ensure that all of our communities, all of our schools are educating in history and the 24 history of the Holocaust, because studying the ... the 25

Holocaust isn't about... isn't about looking back at the darkest chapter in our history, it's about looking forward and providing meaning and power to those words never again. Thank you.

MAJORITY LEADER POWERS: Thank you Council
Member Dinowitz. We're now gonna hear from Council
Member Stevens followed by Council Member Barron.

9 COUNCIL MEMBER STEVENS: Thank you 10 Majority Leader and sending love and light to the 11 Jewish community at this time.

But it's my pleasure to introduce my 12 13 first piece of legislation today, it's local law to 14 amend the administrative code of the city of New York 15 in relation to requiring Department of Transportation 16 to establish a program allowing community centers, 17 schools and arts and cultural institution and 18 religious institutions to use adjournment outside 19 space. By introducing this piece of legislation young 20 people across the city will have access to space to 21 play, learn and grow and community institutions will be able to step out from their buildings onto the 2.2 23 streets to give neighbors access to their resources. I often say that our strength is in our 24

25 unity and utilizing space in our neighborhoods will

2 build community and it is a key and vital to the 3 success of building unity.

I am extremely happy to also be copriming three pieces of legislation, first with Council Member Riley, Williams, Farias and Nurse on establishing the Office of Cannabis Services. This is another step to reversing the devastating causes... cause in black and brown communities and provide a pathway to generational wealth.

11 Second piece of legislation was Council 12 Member Ossé as we are electives and our 13 responsibility as electives is to protect the rights 14 of our constituents and their safety while exercising 15 their rights to protect their constitution... their 16 constitutional rights.

And my third and last one piece of legislation will be with Council Member Farias as it is important that the youth of our city have... have equitable access to New York City ferry services as I continue to advocate for ferry access throughout our city for all communities. And I'm under two minutes, thank you.

24 MAJORITY LEADER POWERS: Very, very25 impressive. Thank you Council Member Stevens. We'll

2 go to Council Member Barron followed by Council 3 Member Holden.

4 COUNCIL MEMBER BARRON: Thank you very 5 much. First and foremost I would like to express my 6 condolences to fire fighter Timothy Klein, that fire 7 house he worked out of is right on the borderline of 8 my district in Canarsie and my condolences.

9 And secondly, I'm presenting two pieces 10 of legislation, one for the wrongfully convicted. 11 There are those who are wrongfully convicted and they 12 were let out and then they just say, "Sorry," no, 13 this bill would assure them social services to be 14 provided for them and their families.

My other bill that I'm introducing is the Slavery Disclosure Act. All corporations are vetted before they get contracts to see if they're good corporate citizens and some of them have... have corruption in the past and they have to list that. Well we want them to list if they ever were involved in the slave trade or the institution of slavery.

Finally, the budget. My colleagues, I'm gonna keep reminding you, this budget is not about the 400 million that you got the Mayor to agree to out of your 1 point some odd billion in the executive

2 budget. This budget is 99.7 billion dollars. This 3 budget had a deficit of 2.9 billion, but it had a budget surplus of 1.6 billion and budget reserves of 4 6.1 billion for rainy days that's included. Well it's 5 raining today Mayor and we need to use some of that 6 7 to cut out the peg of nearly 2 billion from every 8 city agency, your seniors, your youth, your health, 9 housing, everything was cut and we sittin' here with a surplus plus money in the reserve. You can't just 10 11 put it all for the other years and then finally the 12 police budget is bloated. 11 billion dollars, 513 13 million in overtime and I agree with Council Member 14 Ossé, we need to disband that unit, the unit and 15 strategic response group it went from 13 million to 16 90 million. Their overtime is 513 million, take care 17 of the people, not politicians.

18 MAJORITY LEADER POWERS: Thank you Council 19 Member. We'll now go to Council Member Holden then 20 Council Member Won.

COUNCIL MEMBER HOLDEN: Thank you Majority Leader Powers. I'm proudly introducing another package of bills today presenting common sense solutions to quality of life issues and many other topics. These bills will help address parking

2	problems, restrict disturbances caused by
3	unreasonably bright lights in residential areas,
4	crackdown on illegal party's that cause various
5	issues and improve notification for community boards
6	to protect the privacy of New Yorker's who have the
7	victims of violent crime, create a better
8	installation and maintenance process for tree guards
9	on our streets, ratchet up fines for quality of life
10	offenses and require, listen to this, require a super
11	majority vote by the Council to raise our taxes and
12	and more.
13	These bills offer real solutions to non-

These bills offer real solutions to nonpartisan issues that New Yorker's in my district and throughout the city are frustrated by every day. I look forward to bipartisan support of these measures from my colleagues that will help our city move forward. Please review the proposed legislation and I would appreciate your support, thank you very much and under two minutes.

21 MAJORTY LEADER POWERS: Not bad Council 22 Member Holden, appreciate you and I got like 12 23 bills. We're going now to Council... Council Member Won 24 and then Council Member Hanif.

2 COUNCIL MEMBER WON: Thank you so much. 3 Today I'm introducing three bills that have been 4 adopted from former Council Members Rosenthal and 5 Kallos who served as Chairs of Contract Committee 6 before me. I'm grateful for their work and I will 7 continue to focus on transparency and accountability 8 for our city contracts.

9 Intro 299 would add an option to question the passport questionnaire asking perspectives to the 10 11 vendors to voluntarily disclose the gender and race of their Directors and Senior Executives. This data 12 13 would help us understand who leads the organizations, who we work with to execute our city's goals and help 14 15 us work towards more equity in the organizations that 16 we contract with.

17 Intro 300 would require Commissioner of 18 Investigation to appoint a Special Inspector to 19 monitor the emergency procurement contracts entered 20 into the city's response of Covid-19. This is really 21 important, 'cause we saw that during Covid-19 that the contracts that were given did not have a lot of 2.2 23 qualifications or a lot of things that we were using to make sure that our city dollars, city tax payer 24 25 dollars were going to use, so we want to make sure

2 that we're holding bad actors accountable and 3 learning how to move forward with more 4 responsibility.

And finally, Intro 301 would apply to a ... 5 apply to a contractor and a city agency or the 6 7 Council that our party's city contracts valued in excess of \$100,000.00 to establish standards for 8 9 conflicts of interests that may arise as result of entering into contracts with organizations. I know 10 11 that contracts is not the most exciting, but I just 12 want everyone to sign on, because this will bring 13 more transparency and accountability, so I urge my 14 colleagues to sign on and I am really excited today 15 to be here as a co-prime sponsor for bringing back 16 and making it mandatory for curbside composting with 17 Council Member Hanif, so I hope that you will support 18 us on that as well. Thank you so much.

COUNCIL MEMBER HANIF: Thank you, just wanted to chime in here with some trash talking. I am super excited to introduce universal composting. This will phase us out of the opt-in model and make it mandatory. It's a public utility and I hope that we're gonna get there. I urge my colleagues to not be rubbish and to sign onto this exciting piece of

2	legislation Intro 244. Thank you to the 11 co-
3	sponsors including Speaker Adams, I appreciate you
4	all for moving us in the direction that we absolutely
5	must and urgently should move towards a greener,

8	And I would like to make a pitch for
9	Intro's 281, the Core Act sponsored by Council Member
10	Powers, which would expand drop off compost drop off
11	services and sites and then of course Intro 274 by
12	Council Member Nurse for us to adequately achieve our
13	zero waste goals in New York City by 2030. Thank you
14	all so much.
15	MAJORITY LEADER POWERS: Thank you and I
16	appreciate your trash puns today.
17	COUNCIL MEMBER HANIF: Appreciate that.
18	MAJORITY LEADER POWERS: We'll now go to
19	Council Member Brewer followed by Council Member
20	Rivera.
21	COUNCIL MEMBER BREWER: Thank you very
22	much. I do wanna congratulate Council Member Williams
23	on the wage legislation and certainly everybody who
24	is working on curbside organic organic pick up what
25	does need to be mandatory, we tried it before
ļ	

otherwise and I think the only way to go is mandatory and I too read names this morning at the Holocaust Remembrance Day, today is also Worker's Remembrance Day as we know and also I really appreciate the Speaker mentioning Denim Day yesterday, these are really important celebrations that we don't want to forget.

9 So couple issues in terms of legislation, really important for me is our history and one way is 10 11 to have cultural markers. We've never been able to 12 pull this off on different buildings, some owner's don't want them, some people, but I do think we 13 14 should have a cultural marker process, so that in 15 addition to we all know we have street co-naming's 16 but some of these buildings get lost, they... people 17 don't remember who lived there or what their 18 significance is.

Second, we've never been able to figure out whether it goes on the Mayor's site, City Council site for those all the way from the beginning who is that person up on the street sign who is a co-namer. Many of the people who were 9-11, who died in 9-11, nobody knows who they are, because they're not... they don't have their bio's in a place that is visible to

2	the public. I know the City Council has done those
3	that they have recently co-named, but it needs to be
4	codified and and clear to the public and such.
5	I also wanna hope that people sign on
6	where I know there's a letter circulating, but I my
7	husband's a veteran of Vietnam, I feel very strongly
8	about the hospitals staying open. The idea that the

9 Federal Government closed Brooklyn and Manhattan 10 Veteran's Hospital is inconceivable and I too wanna 11 just thank everyone who's working with us on either 12 curbside organics or recycling, thank you very much.

MAJORITY LEADER POWERS: Thank you Council
Member Brewer. We'll go to Council Member Rivera
followed by Council Member Farias.

16 COUNCIL MEMBER RIVERA: Thank you. This 17 city is powered by its people and today I am 18 introducing a package of legislation that centers 19 their needs and champions people powered mobility to 20 compliment a comprehensive effort to address 21 environmental and climate issues.

The bills in this package to codify a greenway master plan for the 21st century cosponsored by Transportation Chair Council Member Selvena Brooks-Powers to establish an Office of

Active Transportation along with an Office of
Pedestrians and creating a first of its kind bicycle
infrastructure map. All will address systemic gaps
and support an infrastructure for open spaces and
green transportation in communities city-wide.

Historically low income neighborhoods and communities of colors have... have seen the least investment in green infrastructure. This package sets forth a vision for a future where New Yorker's of all backgrounds, ages, and abilities from every neighborhood in every borough can easily find open space and safely utilize active transportation.

More New Yorker's than ever before are 14 15 relying on active transportation to get where they 16 need to go whether it's on foot, on a bike, I've even 17 seen rollerblades out there, love the 90's, every 18 single one of us in this room today represents 19 countless New Yorker's who want safe protected open 20 spaces to enjoy active transportation for everything 21 from their daily commutes to errands to recreation.

I urge you to do the right thing for the future of our city, join me in signing onto these bills, which will equip New York with the tools necessary to promote equitable access to open spaces

2 and people… people powered modes of transportation 3 while furthering efforts towards climate justice and 4 resiliency.

I'm also introducing my bill to alleviate 5 noise pollution related to police, fire, ambulance 6 7 and other emergency service vehicle sirens and I'm joined by Council Member Farah... Farah Louis in 8 9 introducing our bill creating a Climate Migrant Services Coordinator to provide support and guidance 10 11 to those who have relocated here after being 12 displaced by a climate event, which our city has already experienced and as Louis and I can attest to 13 14 post devastating disasters in Haiti and Puerto Rico. 15 I wanna just say thank you to ... MAJORITY LEADER POWERS: Thank you. 16 17 COUNCIL MEMBER RIVERA: My colleagues for 18 the municipal fleet zero emission vehicles 19 legislation and of course our goals for zero waste. 20 Thank you so much everyone. 21 MAJORITY LEADER POWERS: Thank you. We'll now go to Council Member Farias followed by Council 2.2 23 Member Yeger followed Council Member Hanks. COUNCIL MEMBER FARIAS: I have a lot of 24 great pieces of legislation being introduced today, 25

2 five to be exact, including some with colleagues,
3 Council Members De La Rose, Menin, Stevens and Riley.
4 I urge my colleagues to look them up themselves and
5 sign on.

I'm proud to reintroduce Intro 285 with 6 7 my colleagues to establish a New York City Office of Cannabis Business Services. Our city needs to 8 9 streamline all of the resources it has to offer by providing legal and technical advice, loan programs, 10 11 help finding affordable locations and more, we are 12 ensuring that our newest economy has solid ground to 13 stand on and able to thrive. This is proactive and 14 protective. It prioritizes the importance of safe and 15 tested products that collect tax revenue for direct community reinvestments. This bill also calls for the 16 17 office to provide oversight on what is and isn't 18 working in the industry by submitting a bi-annual 19 report to the Mayor and Council related to the status 20 of the commercial cannabis industry.

As local leaders we have to continue to prioritize pro-active measures like this that center the healing of our black and brown communities by promoting resources for economic wellness and I urge

2 all my colleagues to sign onto this critical 3 legislation.

Lastly, Intro 236, I'd like to highlight 4 as well as what Council Member Althea Stevens did, 5 accessibility is to have freedom of choice by letting 6 7 our young people take advantage of our waterway transit allows for them to have choices they don't 8 9 have right now. By only having reduce cost train and bus passes we are not accounting for the students who 10 11 could get to their communities a lot safer, healthier and even faster with the option of a ferry and I'll 12 13 give you back 18 seconds Majority Leader.

MAJORITY LEADER POWERS: We will take it,
thank you Council Member. We'll now go to Council
Member Yeger followed by Council Member Hanks.

17 COUNCIL MEMBER YEGER: Thank you Mr. 18 President. I wanna begin just very briefly thanking 19 my colleague Councilman Dinowitz whose incredible 20 eloquence and passion on today's very quiet 21 remembrance, 'cause you don't really see it going on 2.2 in New York, but it is important nonetheless and I 23 think it should be mentioned, Yom Hashoah is... is the Holocaust and Heroism Remembrance Day and it's 24 scheduled to fall out on different days in the 25

2 English Calendar, because it's tied to the Hebrew 3 calendar and it's today and it's commemorates the 4 loss of 6 million members of my family, not just broadly speaking members of my family, but four Great 5 Grandparents, every single Great Aunt and Uncle, 6 7 except for one, my Grandfather's younger sister and hundreds and hundreds of cousins and millions of 8 9 others who are all related to me and to others in this chamber and to many people in this city. It's 10 11 often been said you know there is other 12 commemorations, one is called Yom HaZikaron, which is 13 essentially the memorial day, kind of like what we 14 have here in the United States, it's to thank and 15 remember the members of the army, the military who defend Israel and it's been said very frequently I 16 17 think, I'm not the first one to say it that Yom 18 HaZikaron is to remember the cost of Israel existing, 19 Yom Hashoah is to remember the cost of Israel not 20 existing. My Grandfather was able to make his way to 21 what had not yet been called Israel in modern times, although it had been called Israel for thousands of 2.2 23 years before, before his parents were taken away and killed, his siblings were taken away and killed. My 24 other Grandfather was able to make his way through 25

2	Europe over to Russia onto a boat to make his way to
3	Japan and into China where he was able to live out
4	the war before finding out that his family was all
5	killed. 34% increase in anti-Semitism in United
6	States last year, don't have to go to other states to
7	see it, just have to walk around the streets of this
8	city. People who look like me who wear a Yamaka are
9	beaten and attacked every single day in this city,
10	every single day, and at the same time at the same
11	time there's a movement that we frequently hear
12	about, Globalize the Intifada, it's just fancy
13	language for Globalize Killing Jews. Not a word is
14	said in public about it.

15 I've talked on this floor before in the last session about the responsibility that those in 16 17 government and those of us in the military, Mr. President, I ask for additional time, thank you, are 18 19 responsible for the language that we fear. When we hear attacks on Yeshiva's for example, because they 20 21 don't provide good education and the same people who make those attacks have not a word to say about the 2.2 23 public school system, which I think something very similar could be said, that's anti-Semitism. Very 24 25 strange anti-Semitism, because it's not I hate Jews,

2	how can I hate Jews? I am a Jew myself. We have
3	elected officials in this city who are Jewish who are
4	anti-Semites, it's okay, some of the biggest enemies
5	of the Jewish people over time have been Jewish, but
6	it has to be recognized and when we ignore the
7	subtleties, the tinkering at the fringes of anti-
8	Semitism, it leads to the Jew walking down the
9	streets in Councilman Ossé's district and other
10	districts and around the cities getting beaten up.
11	MAJORITY LEADER POWERS: Thank you, we
12	need you
13	COUNCIL MEMBER YEGER: Getting beaten up
14	because they look Jewish. It's not enough once a year
15	to stand next to a Menorah and say, "I'm here to
16	celebrate Jews," and it's not enough once a year to
17	say, "We remember the Holocaust," it's important
18	every single day to remember that the reason that we
19	have these days is not just so that we can have a day
20	to talk about, but that never again actually has to
21	mean something. Thank you very much Mr. President.
22	MAJORITY LEADER POWERS: Thank you.
23	COUNCIL MEMBER YEGER: Thank you Madam
24	Speaker.

3 Member. Now I'll go to Council Member Hanks.

4 COUNCIL MEMBER HANKS: Thank you so much 5 Majority Leader. I hear you. Thank you so much to my 6 colleagues Yeger and Dinowitz who spoke so eloquently 7 and all my other colleagues who are introducing 8 legislation for the first time and bills for the 9 first time, I congratulate you.

Today I rise as a prime... a primary ... a 10 11 proud primary co-sponsor in Intro 273 along with the 12 Council Members Narcisse and Council Member Mealy in 13 relation to requiring police officers to receive 14 training related to recognizing and interacting with 15 individuals with autism. We know the rate of autism diagnosis is on the rise and especially in Staten 16 17 Island we have an especially high rate of autism ... 18 autistic New Yorker's. Many of us, including myself, 19 have members, friends and neighbors and colleagues 20 who are autistic and it is a priority of mine to 21 ensure the safety and the well-being of the 2.2 individuals. I look forward to working with my 23 colleagues, NYPD and our commun... community based organization to ensure the NYPD training provides 24

2	tools to maximize safety and respect for all autistic
3	New Yorker's as well as our police officer's.
4	I also would like to shout out and take a
5	moment to congratulate Amazon Labor Union led by
6	Union President and fellow Staten Islander and friend
7	Chris Smalls for his tremendous victory in being the
8	first nation first in the nation to unionize at
9	Amazon. The Amazon Labor Union puts Staten Island on
10	the map as a labor pioneer and I could not be more
11	proud. Thank you so much.
12	MAJORITY LEADER POWERS: Thank you Council
13	Member. That is the last person signed up, are there
14	any other hands or any other people signed up?
15	Council Member Narcisse had raised her hand.
16	COUNCIL MEMBER NARCISSE: Thank you. Thank
17	you Madam Speaker and Leader. I rise to ask my
18	colleagues to join me in supporting three
19	Introductions, which I believe will benefit the
20	people of New York City and make our city a safer and
21	more equitable place for all.
22	Studies show approximately like just my
23	colleague mentioned, it's difficult in New York City,
24	one out of five young adults with autism with
25	interact with a police officer before the age of 21.

2 Community services including interaction with police 3 are essential at times for New Yorker's and families 4 with autism. When a parent, caretaker or person with autism requires police help we should not have to be 5 concerned that their ... their call for help could lead 6 7 to situation where their own lives could be placed in 8 dangerous from the officer's came to help. Therefore, 9 along with Councilwoman Hanks and Mealy, I have sponsored into 273 requiring police officer's to 10 11 receive training related to recognize and interacting with individuals with autism. I believe this will be 12 13 a great benefit to autistic New Yorker's, but also NYPD officer will now be better educated and equipped 14 15 on how to deal with individual with autism.

16 If we want to stop the revolving door in 17 our jails we must endeavor to nurture a correctional 18 system that truly corrects the previous wrong done by 19 this incarcerated individual and provide them with 20 services needed to get back on ... on the right track 21 and help them stay out of jail and be productive 2.2 citizens. That is why along with public advocate 23 Jumaane Williams, I am sponsor Intro 284 to place social workers in city correctional facilities. I 24 believe having this advocates working with 25

incarcerate... incarcerated New Yorker's will have
reduced the rate of recidivism and support the mental
and emotional well-being of incarcerated people while
preparing them for release. So this is important, I
won't take any further and I'm proud to be co-sponsor
276 with Councilman Ossé. Thank you for the
opportunity.

9 MAJORITY LEADER POWERS: Thank you Council 10 Member. Seeing no any... Council Member Marte.

11 COUNCIL MEMBER MARTE: I'll keep this short. This Sunday there'll be 32,000 New Yorker's 12 13 cycling through the streets across the five borough's 14 with the five borough bike tour and so if you're not 15 joining us on Sunday you know go outside, cheer them on, because this is the future and motto that we 16 17 should all want in this city, one that prioritize 18 pedestrian and bikes than vehicles and traffic and so 19 it's gonna be a sunny day, so go out with some pots 20 and pans and cheer on your New Yorker's as they ride for 40 miles. Thank you. 21

22 MAJORITY LEADER POWERS: Thank you Council 23 Member Marte. With that we… with that I'm now gonna 24 call on Speaker Adrienne Adams to close out today's 25 Stated Meeting. Guys, please let us finish. Thanks.
