## LOCAL LAWS OF THE CITY OF NEW YORK FOR THE YEAR 1993

No. 84

Introduced by Council Members Leffler, Freed and Pagan (by the request of the Mayor); also Council Members Eisland, Michels, O'Donovan, Rivera, Robles, Marshall and Povman. Amended October 25, 1993. (Passed under a Message of Necessity from the Mayor).

## A LOCAL LAW

To amend the administrative code of the City of New York, in relation to the use of compressed natural gas as a fuel for motor vehicles.

Be it enacted by the Council as follows:

Section 1. Subdivision 26 of section 27-4002 of the administrative code of the city of New York is amended to read as follows:

- 26. Motor vehicle, a vehicle or other conveyance having more than two running wheels and using [Diesel] diesel fuel oil, flammable gas or [a] volatile flammable oil as a fuel for generating motive power, except such vehicles as have a storage tank [or] with a maximum capacity [of] for less than two gallons [() of [a] volatile flammable oil or diesel fuel oil [)] or a container with a maximum capacity limited to a quantity of flammable gas that generates energy that is equivalent to the energy generated by two gallons of volatile flammable oil.
- §2. Section 27-4100 of the administrative code of the city of New York is amended by adding a new subdivision g to read as follows:
- g. Notwithstanding any other provision of this subchapter, no permit shall be required (1) for the use of compressed natural gas as a fuel for generating motive power for a motor vehicle or (2) for the storage for such use in a container mounted on such vehicle.
- §3. Nothing in this local law shall affect the rules of the department setting standards for the conversion of motor vehicles using compressed natural gas as a fuel for generating motive power. Such rules shall remain in full force and effect unless and until amended or repealed by the department in accordance with the provisions of the city administrative procedure act.
  - §4. This local law shall take effect 30 days after it shall be enacted into law.
