AN ACT to amend chapter 544 of the laws of 2022, authorizing the city of New York to discontinue a portion of real property in the county of the Bronx as parkland and to grant easements for improvements to the railroad right-of-way to bring Metro-North railroad service to four new stations in the Bronx and to Pennsylvania Station in the county of New York, in relation to discontinuing additional parkland and granting additional easements

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1 of chapter 544 of the laws of 2022, authorizing the city of New York to discontinue a portion of real property in the county of the Bronx as parkland and to grant easements for improvements to the railroad right-of-way to bring Metro-North railroad service to four new stations in the Bronx and to Pennsylvania Station in the county of New York, as amended by chapter 231 of the laws of 2023, is amended to read as follows:

Section 1. Subject to the provisions of this act, but notwithstanding 9 any provision of law to the contrary, the city of New York is hereby 10 authorized to discontinue the use as parklands the lands described in 11 sections three [and], three-a and three-b of this act and to grant ease-12 ments affecting such lands to the metropolitan transportation authority, upon such terms and conditions as the city of New York shall determine, 14 to enable the metropolitan transportation authority and Metro-North commuter railroad company, a subsidiary of the metropolitan transporta-15 tion authority, to construct improvements and gain ingress and egress to 17 and from railroad equipment, stations and right-of-way on such former parkland, in order to bring Metro-North commuter railroad company service to four new stations in the Bronx and to Pennsylvania Station in 20 the county of New York in connection with the capital project known as 21 Penn Station Access.

§ 2. Section 4 of chapter 544 of the laws of 2022, authorizing the 23 city of New York to discontinue a portion of real property in the county 24 of the Bronx as parkland and to grant easements for improvements to the railroad right-of-way to bring Metro-North railroad service to four new stations in the Bronx and to Pennsylvania Station in the county of New

York, as amended by chapter 231 of the laws of 2023, is amended to read 1 2 as follows:

- § 4. In the event that the city of New York received any funding, support or assistance from the federal government for the purchase, maintenance or improvement of the parklands set forth in sections three [and], three-a and three-b of this act, the discontinuance and alienation of such parkland authorized by the provisions of this act shall not occur until the city of New York has complied with any federal requirements pertaining to the alienation or conversion of such park-10 lands, including satisfying the secretary of the interior that the alienation or conversion complies with all conditions which the secre-12 tary of the interior deems necessary to assure the substitution of other 13 lands shall be equivalent in fair market value and recreational useful-14 ness to the lands being alienated or converted.
  - § 3. Chapter 544 of the laws of 2022, authorizing the city of New York to discontinue a portion of real property in the county of the Bronx as parkland and to grant easements for improvements to the railroad rightof-way to bring Metro-North railroad service to four new stations in the Bronx and to Pennsylvania Station in the county of New York, is amended by adding a new section 3-b to read as follows:
  - § 3-b. The lands hereby authorized to be discontinued as parklands and for which easements may be granted to the metropolitan transportation authority are located in the county of the Bronx, city and state of New York, and are bounded and described as follows:
  - Easement 9 on BLOCK 3861, PART OF LOT 14: ALL THAT CERTAIN LOT, PIECE OR PARCEL OF LAND SITUATED, LYING AND BEING IN THE BOROUGH OF THE BRONX, COUNTY OF BRONX, CITY, AND STATE OF NEW YORK BOUNDED AND DESCRIBED AS

AREA (ACCESS EASEMENT OVER AN EXISTING PATH) HORIZONTAL LIMITS

- Commencing at the corner formed by the intersection of the northerly side of East 172nd Street (60 feet wide) with the westerly side of Bronx River Avenue (100 feet wide), as depicted on Bronx Record Map Section 38, as amended and corrected on 1/20/1947, last revised on 8/8/2001, and recorded at the Topographic Bureau of the Bronx Borough President's Office, running thence the following four courses and distances:
- 1. Along the northerly side of East 172nd Street, and crossing Bronx Tax Block 3861, Lot 8R, as depicted to National Railroad Passenger Corporation (Amtrak), North 65°38'24" West, a distance of 242.23 feet to a point, said point being the southeast corner of Bronx Tax Block 3861, Lot 14, as shown on the current Tax Map of the City of New York, Borough and County of the Bronx, thence;
- 2. Along the line common between said Lot 8R, and said Lot 14, North 30°54'49" East, a distance of 62.89 feet to a point, thence;
- 3. Leaving said common line, crossing said Lot 14, North 59°05'51" West, a distance of 23.66 feet to a point, thence;
- 4. Continuing across said Lot 14, North 10°27'28" West, a distance of 16.51 feet to the Point or Place of Beginning, having coordinates N: 242,393.095, E: 1,016,735.795, and running thence;
- 49 Continuing across said Lot 14, North 10°27'23" West, a distance of 50 19.39 feet to a point, thence;
- 51 Continuing across said Lot 14, along an arc of a curve bearing to the 52 left, having a radius of 75.00 feet, an arc length of 17.53 feet, an internal angle of 13°23'34", a chord bearing of North 69°29'16" East, 53 and a distance of 17.49 feet to a point, thence; 54
- 55 Continuing across said Lot 14, along an arc of a curve bearing to the 56 left, having a radius of 159.00 feet, an arc length of 49.27 feet, an

- 1 internal angle of 17°45'19", a chord bearing of North 48°22'09" East,
  2 and a distance of 49.08 feet to a point, thence;
- 3 Continuing across said Lot 14, North 29°00'40" East, a distance of 4 96.68 feet to a point, thence;
- Continuing across said Lot 14, South 59°05'11" East, a distance of 24.97 feet to a point, said point being on the common line between said Lot 14 and said Lot 8R, thence;
- 8 Continuing along said common line, South 30°54'50" West, a distance of

- Continuing across said Lot 14, along an arc of a curve bearing to the left, having a radius of 114.00 feet, an arc length of 58.17 feet, an internal angle of 29° 14' 05", a chord bearing of North 58° 49' 28" East, and a distance of 57.54 feet to a point, thence;
- 47 Continuing across said Lot 14, South 59° 05' 14" East, a distance of 48 7.65 feet to a point, said point being on the common line between said 49 Lot 14 and said Lot 8, thence;
- 50 Continuing along said common line, South 30° 54' 52" West, a distance 51 of 63.23 feet to the Point or Place of Beginning and containing 1,292 52 square feet (0.030 Ac.) more or less.
- 53 § 4. This act shall take effect immediately.
