17 the city. Co-naming bills are the result of the
18 Council's periodic process where we seek to honor
19 individuals and organizations that have made lasting
20 contributions to our city. Some of these include co-
21 names for active community members, heroic New
22 Yorkers who sacrificed their lives for others, people
23 who committed their lives to public service, or those
24 who greatly enriched the city's cultural landscape.
