COMMITTEE ON CULTURAL AFFAIRS, LIBRARIES AND 1 INTERNATIONAL INTERGROUP RELATIONS 2 Remembrance Day in the City of New York to honor the 3 memories of the over one million Jews and tens of thousands of others who died brutally there at the 4 hands of Nazis during World War II 5 Now I want to ask Council Member Dinowitz if he 6 7 would provide some remarks. 8 COUNCIL MEMBER DINOWITZ: Sure thank you, Chair. 9 Today, we pass Resolution 713, recognizing 10 January 27th as the 80th anniversary of the 11 anniversary of the liberation, the Auschwitz-Birkenau concentration extermination camps, commemorating 12 13 January 27th annually as Auschwitz Remembrance Day in 14 the city of New York. 15 And I think it's an important notion to remember 16 something and not just acknowledge an historical 17 event, because to remember something means to have 18 experienced it, to have a memory of something. To 19 remember it is to have this memory as if it had 20 happened to you. 21 And at this time of rising hate, rising antisemitism, here in the City, and throughout the 2.2 23 world, it's important to remember that which came before us, and live with it, and sit with it, so 24 going forward, we're not experiencing that again. 25

2 When we remember something, it's part of who we 3 are, and it informs our actions. It informs what we 4 do and how we live our life.

5 And with this resolution passing today, we are 6 acknowledging, and we are saying that New York City 7 remembers Auschwitz, that New York City remembers the 8 Holocaust. And that remembering something isn't 9 passive. Remembering something is to go forward and 10 recognize how it impacts your life, and now how it 11 impacts the life of everyone here in New York City.

So I want to thank you, Chair, for bringing this resolution forward so that we in New York City can remember and make it part of our DNA, the 80th anniversary of the liberation from Auschwitz, and every year going forward that we remember and have it part of our DNA here in the city, Auschwitz and the Holocaust. Thank you, Chair.
