**Proposed Intro No. / Title:** *Int 1234 / Executive budget process* 

**Sponsors:** Brannan **Committee:** Finance

**Summary of Legislation:** This legislation amends New York City's Charter by requiring the Director of the Independent Budget Office to publish a report analyzing the Mayor's executive budget for the ensuing fiscal year no later than May 20 each year. Additionally, this bill requires that between May 10 and May 31 each year, the Council must hold public hearings on the Mayor's executive budget.

Effective Date: Immediately upon enactment, except that if it becomes law after May 10, 2025, it is retroactive to and deemed to have been in full force and effect as of May 10, 2025.
