On May 12, 2022 the Land Use Committee of the City Council, by a vote of 11-0-0 for Applications **C 210312 ZMK** and **N 210313 ZRK** recommended modifications of the City Planning Commission's decisions in the above-referenced matters.

Pursuant to Section 197-d(d) of the City Charter I hereby file the proposed modifications with the Commission:

The Zoning Resolution of the City of New York, effective as of December 15, 1961, and as subsequently amended, is further amended by changing the Zoning Map, Section 12d:

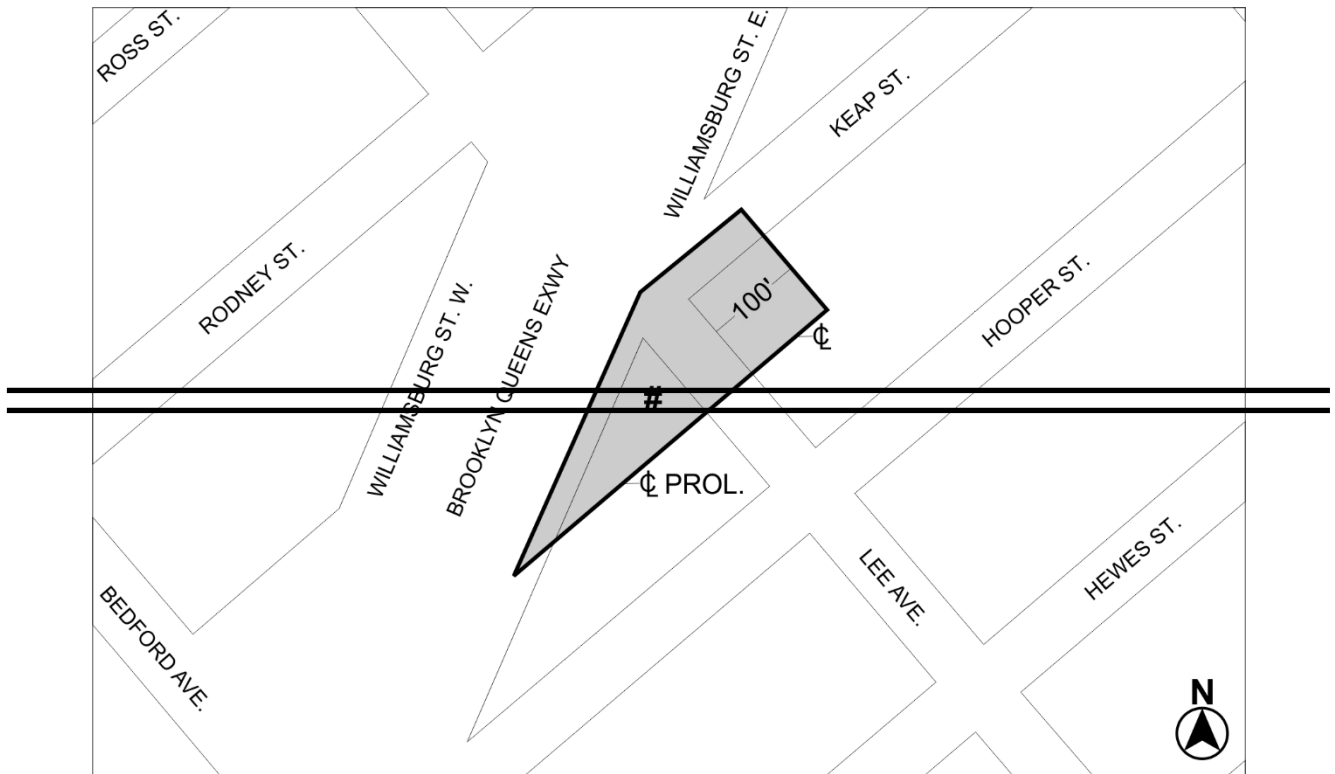

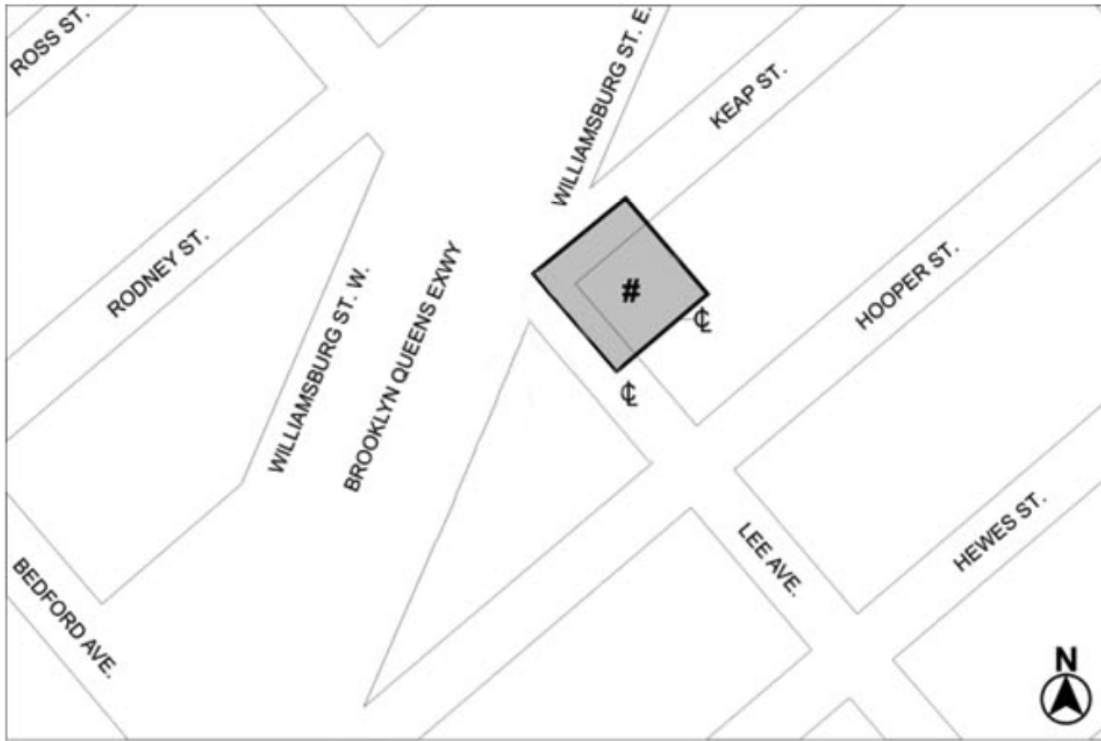
