### REPORT OF THE COMMITTEE ON FINANCE

#### RESOLUTION APPROVING THE NEW DESIGNATION AND CHANGES IN THE DESIGNATION OF CERTAIN ORGANIZATIONS TO RECEIVE FUNDING IN THE FISCAL 2009 EXPENSE BUDGET

The Committee on Finance, to which was referred the above-captioned resolution, respectfully submits to The Council of the City of New York the following

#### REPORT

Introduction. The Council of the City of New York (the "Council") annually adopts the City's budget covering expenditures other than for capital projects (the "expense budget") pursuant to Section 254 of the Charter. On June 29, 2008, the Council adopted the expense budget for fiscal year 2009 with various programs and initiatives (the "Fiscal 2009 Expense Budget").

Analysis. This Resolution, dated February 11, 2009, sets forth a new purpose of funds for the Provider's Choice Initiative. The Fiscal 2009 Expense Budget included \$1,200,000 for the Provider's Choice Initiative within the budget for the Administration for Children Services (ACS). The language within the Fiscal 2009 Expense Budget with regard to the Designation Method read: "The agency will recommend the organizations to receive funding from this initiative post-adoption. The City Council will approve these recommendations by Council Resolution." This Resolution now changes the Designation Method to read: "Funding will be provided directly to the agency. ACS shall report to the Council a list of Providers receiving funding pursuant to this Initiative no later than June 30, 2009."

In addition, the Fiscal 2009 Expense Budget included \$5,000,000 for the Jobs to Build On Initiative within the budget for the City University of New York. The language within the Fiscal 2009 Expense Budget with regard to the Description/Scope of Services read: "To recruit and transition low-skilled, long-term unemployed and under-employed individuals, prepare them for entry into union and non-union jobs, attain credentials enabling them to meet general employer standards, and place participating participants in training with real job and career prospects at a living wage". This Resolution now changes the Description/Scope of Services to read: "To recruit and transition low-skilled, long-term unemployed and under-employed individuals, prepare them for entry into union and non-union jobs, attain credentials enabling them to meet general employer standards, place participating participants in training with real job and career prospects at a living wage, and to study and research relevant data."

Additionally, this Resolution approves new designations and changes in the designation of certain organizations receiving local, aging, and youth discretionary funding in accordance with the Fiscal 2009 Expense Budget. This Resolution also approves the new designations and changes in the designation of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2009 Expense Budget.

Finally, this Resolution sets forth an Initiative Fund Transfer between the Space Costs for Senior Centers Initiative and the Food Cost for Senior Centers/Meals on Wheels Initiative within the budget for the Department for the Aging. The amount of the transfer is \$550,000, and the net effect of such transfer is zero.

In an effort to continue to make the budget process more transparent, the Council is providing a list setting forth new designation and/or changes in the designation of certain organizations receiving local, aging, and youth discretionary funding (or Council discretionary funding); new designations and/or changes in the designation of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2009 Expense Budget; and a funding transfer between initiatives within the Department for the Aging.

This Resolution sets forth new designations and specific changes in the designation of certain organizations receiving local initiative funding, as described in Chart 1, attached hereto as Exhibit A; sets forth new designations and changes in aging discretionary funding, as described in Chart 2 attached thereto as Exhibit B; sets forth new designations and specific changes in the designation of certain organizations receiving youth discretionary funding, as described in Chart 3, attached thereto as Exhibit C; sets forth the new designations and changes in the designations of certain organizations that will receive funding pursuant to certain initiatives in the Fiscal 2009 Expense Budget, as described in Charts 4-18, attached hereto as reflected in Exhibits D-R; and sets forth an Initiative Fund Transfer between the Space Costs for Senior Centers Initiative and the Food Cost for Senior Centers/Meals on Wheels Initiative within the Department for the Aging, as described in Chart 19, attached hereto as Exhibit S.

The charts, attached to the resolution, contain the following information: name of the council member(s) designating the organization to receive funding or name of the initiative, as set forth in Adjustments Summary/Schedule C/ Fiscal 2009 Expense Budget, dated June 29, 2008; name of the organization; organization's Employer Identification Number (EIN), if applicable; agency name; increase or decrease in funding; name of fiscal conduit, if applicable; and the EIN of the fiscal conduit, if applicable.

Specifically, Chart 1 sets forth the new designation and changes in the designation of certain organizations receiving local discretionary funding.

Chart 2 sets forth the new designation and changes in the designation of certain organizations receiving aging discretionary funding.

Chart 3 sets forth the new designation and changes in the designation of certain organizations receiving youth discretionary funding.

Chart 4 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Cultural After School Adventure Initiative.

Chart 5 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Adult Literacy Initiative. As indicated in Chart 5, funding in the amount of \$30,952.38 for St. George's Episcopal Church has been withdrawn. This amount will be used to fund the Flushing Jewish Community Council.

Chart 6 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Immigrant Opportunity Initiative.

Chart 7 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the After-Three Corporation Initiative. Chart 7 indicates a name correction. Funding in the amount of \$3,800,000 was designated to the After-Three Corporation. The correct name of the organization is the After School Corporation, The. Chart 7 reflects the proper designation of the \$3,800,000 to the After School Corporation, The.

Chart 8 sets forth the new designation of a certain organization receiving funding pursuant to the Shelter Beds for At Risk/LGBT Youth Initiative. Chart 8 indicates an Employer Identification Number (EIN) correction. EIN 13-272516 was provided to the Council as the EIN for the Covenant House organization in the Fiscal 2009 Expense Budget. The correct EIN for this organization is 13-3076376. Chart 8 reflects the proper designation of funding to the Covenant House with EIN 13-3076376.

Chart 9 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to Children Under Five Initiative. Chart 9 indicates a name correction. Funding in the amount of \$506,665 was designated to the Rose F. Kennedy organization. The correct name of the organization is the Yeshiva University-Albert Einstein College of Medicine/Rose F. Kennedy Center for Research in Mental Retardation and Developmental Disabilities. Chart 9 reflects the proper designation of the \$506,665 to the Yeshiva University-Albert Einstein College of Medicine/Rose F. Kennedy Center for Research in Mental Retardation and Developmental Disabilities.

Chart 10 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to Dropout Prevention and Intervention Initiative. As indicated in Chart 10, funding in the amount of \$75,000 for the El Puente

de Williamsburg has been withdrawn. This amount will be used to fund Asociacion Tepeyac De New York.

Chart 11 sets forth the new designation and changes in the designation of a certain organization receiving funding pursuant to the Young Women's Leadership Foundation Initiative. The Fiscal 2009 Expense Budget provided funding in the amount of \$300,000 for the Young Women's Leadership Foundation. Subsequent to adoption of the Fiscal 2009 Expense Budget, this organization changed its name to Young Women's Leadership Network. Chart 11 reflects a name change and the proper designation of the \$300,000 to the Young Women's Leadership Network.

Chart 12 sets forth the new designation of certain organizations receiving funding pursuant to the Discharge Planning/In-Detention Services Initiative. The Fiscal 2009 Expense Budget provided \$640,000 for the Discharge Planning/In-Detention Services Initiative within the budget for the Department of Juvenile Justice. As indicated in Chart 12, funding in the amount of \$478,777 will be used to fund several organizations. The remaining balance, \$161,223 will be used to fund organizations to be designated by the Department of Juvenile Justice, and approved by the Council, at a later date.

Chart 13 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Infant Mortality Reduction Initiative. As indicated in Chart 13, funding in the amount of \$19,586.25 for Healthy Families of Staten Island has been withdrawn. This amount will be divided evenly and used to fund the Richmond University Medical College and the Staten Island University Hospital.

Chart 14 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Alcoholism/Substance Abuse Initiative. As indicated in Chart 14, funding in the amount of \$50,000 for La Bodega De La Familia has been withdrawn. This amount will be used to fund Inwood Community Services.

Chart 15 sets forth the new designation and changes in the designation of a certain organization receiving funding pursuant to the Food Pantries-HRA Initiative. Funding in the amount of \$100,000 to FoodChange, Inc. has been withdrawn. This amount will now be used to fund the Food Bank for New York City, The.

Chart 16 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Mental Health Contracts Initiative. As indicated in Chart 16, funding in the amount of \$100,000 for Project for Psychiatric Outreach to Homeless has been withdrawn. This amount will be used to fund Center for Urban and Community Services, Inc

Chart 17 sets forth the new designation of certain organizations receiving funding pursuant to the Space Costs for Senior Centers Initiative. As indicated in Chart 17, funding for the new designation of certain organizations receiving funding pursuant to the Space Costs for Senior Centers Initiative total \$1,950,000.

Chart 18 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Healthy Aging Initiative. Funding in the amount of \$200,000 to Wayside Out-Reach Development, Inc.-Brevoort Senior Center has been withdrawn. This amount will now be used to fund the Fort Greene Senior Citizens Council, Inc.-C. Blenman Senior Center.

Chart 19 sets forth an Initiative Fund Transfer between the Space Costs for Senior Centers Initiative and the Food Cost for Senior Centers/Meals on Wheels Initiative within the budget for the Department for the Aging. As indicated in Chart 19, the funding for the Space Costs for Senior Centers Initiative in the amount of \$550,000 has been withdrawn. This money will be used to fund Food Cost for the Senior Centers/Meals on Wheels Initiative. The net effect of the Initiative Fund Transfer is zero.

It is to be noted that organizations identified in the attached charts with an asterisk (\*) have not yet completed or began the prequalification process conducted by the Mayor's Office of Contract Services (for organizations receiving more than \$10,000) or by the Council (for organizations receiving \$10,000 or less total). Organizations identified without an asterisk have completed the appropriate prequalification review.

Description of Above-captioned Resolution. In the above-captioned resolution, the Council would approve the new designation and changes in the designation of certain organizations to receive funding in the Fiscal 2009 Expense Budget. Such resolution would take effect as of the date of adoption.
