Proposed Intro No. / Title: Int. 1061 / Department of Correction report on sexual abuse

Sponsors: Louis, Narcisse, and Farias

Committee: Criminal Justice

Summary of Legislation: Requires that a unique identification number for each alleged incident of sexual harassment and abuse in Department of Correction (DOC) facilities, and a unique identification number for each alleged victim, be included in reporting. Additionally, if DOC did not refer any substantiated allegations to a District Attorney's office they must include the justification for such decision in the report. The report must also include any updates to DOC's prevention, detection, and response policies concerning sexual harassment and abuse of people in custody.
