**Proposed Intro No. / Title:** *Int. 955 / Requiring annual reports on afterschool programs*

**Sponsors:** Riley, Hanks, Restler, Brannan, Ossé, Banks, Williams, Narcisse and Louis

**Committee:** Education

**Summary of Legislation:** This legislation requires the Department of Education (DOE) to provide annual reports on afterschool programs. DOE must submit a report within 120 days of the law's passage, and annually thereafter, and shall include the following information for each afterschool program: location, total available seats, total enrollment, student participant demographic data, and average daily percentage of enrolled students in attendance at the afterschool program.

**Effective Date:** Immediately upon enactment

**First Fiscal Year Legislation Takes Effect:** Fiscal Year 2026

**First Fiscal Year with Full Impact:** Fiscal Year 2026

**Agencies Impacted:** Department of Education, Department of Youth and Community Development
