**Summary of Legislation:** This legislation requires the establishment of a sleep apnea screening pilot program, where appropriate services must be offered to participating patients with sleep apnea or showing a risk of sleep apnea. A sleep apnea screening report must be submitted to city council and posted on the implementing agency's website no later than 1 year following the end of the pilot program. Such report must detail the total number of patients screen and total number of patients referred or connected to services following the screening. An outreach and education campaign shall be implemented utilizing social media, digital kiosks, and other appropriate mediums.
