2	Chair, we are ready to begin.
3	CHAIRPERSON KRISHNAN: Good morning. Thank
4	you so much, Sergeant. [GAVEL] I am Shekar Krishnan,
5	Chair of the Committee on Parks and Recreation.
6	Today, the Committee will vote on a pre-considered
7	bill that would ceremonially co-name 109
8	thoroughfares and public places throughout the city.
9	Co-naming bills are the result of the Council's
10	periodic process where we seek to honor individuals
11	and organizations that have made lasting
12	contributions to our city. I always say it's far more
13	than just a street naming, but we are permanently
14	changing the landscape of New York City to recognize
15	individuals for their contributions to their
16	community and to our city, or to communities that
17	have made historic contributions to our city. Some of
18	these individuals include co-names for active
19	community members, heroic New Yorkers who sacrificed
20	their lives for others, people who committed their
21	lives to public service, or those who greatly
22	enriched the city's cultural landscape. It is only
23	fitting that their names and their legacies
24	permanently become a part of the history and the
25	geography of New York City.

2 Of the many honorees proposed by this 3 piece of legislation, I'd like to call attention to a 4 couple of co-namings that I am proud to have sponsored. My first nomination is to co-name an area 5 in my District as Patty G Way after Patrick Patty 6 7 Gilmartin. Patty started a career in the bar business in the early 1970s, attended Bishop DuBois, an All 8 9 Boys Catholic High School in Harlem, before deciding to put college on hold to serve in the Vietnam War 10 11 where he was wounded and received a Purple Heart. He 12 established Patty G's and created a welcoming and 13 inclusive environment that became a community hub for 46 years. I was proud to go there and meet with him 14 15 too. His dedication extended beyond his business with 16 providing free home-cooked meals during the holidays 17 for those in need. After his death, he was honored 18 with the United States Army Honor Guard Funeral, and 19 his bar continues to operate under the care of his 20 children, ensuring the legacy of this neighborhood institution. 21

22 My other nomination is for Cathedral Prep 23 Way, which will commemorate Cathedral Preparatory 24 School and Seminary, which has served as a Catholic

I'd like to welcome all who have come to 4 participate in today's hearing, and I urge all of my 5 Colleagues to vote in favor of this legislation 6 7 before us. I just want to announce the Council 8 Members we have so far. We are joined by Council 9 Member Holden, Council Member Narcisse, Council Member Lee, and on Zoom virtually we have Council 10 11 Members Menin and Ung. While we wait just a bit longer for 12 13 quorum to take the actual vote, we do have witnesses 14 who are here today to testify about the special 15 namings that we have with today's legislation so I'd like to call up first Raphael Lopez to testify. 16 17 We're also joined by Council Member Palladino. Welcome. 18 19 You may testify. 20 RAPHAEL LOPEZ: My name is Raphael Lopez. I moved to 84th Street in Amsterdam in 1984 and 21 2.2 immediately was greeted into the neighborhood. We 23 have two parks. We have the Brandeis Yard and we have the PS9 yard right there so I was in there playing 24 basketball. Ended up meeting Ms. Linda Carter-Cooper, 25

2	who was very involved in the community and with the
3	children and was kind of like a second mother while
4	our mothers were at home or busy doing other stuff.
5	She was out there watching us all day and really
6	creating that sense of community that's really
7	important because there's edifices and there's
8	businesses, but it's the people that make the
9	community, and she created that sense of community
10	where you could always come to her or she would come
11	to you to check to see if you were doing all right in
12	school, how is your family doing at home, is
13	everything going all right with rent, stuff like
14	that. A lot of our families were getting pushed out
15	at that time so she helped a lot of us switch into
16	Mitchell-Lama so a lot of us are apartment owners as
17	opposed to renters and that's only because of her.
18	She was very involved with getting ESL so that a lot
19	of the Spanish-speaking families could get jobs, even
20	in education, which they thought would be impossible,
21	but they became ESL teachers so she created a lot of
22	lasting legacies in the neighborhood. We are reeling
23	since she has left us. We have a huge hole. She is
24	still here in our hearts, but we would love to have
25	her up there on that street so we could still have

2	her there watching over us. Community was huge to	
3	her. The other people will speak on how big religion	
4	and the community inside the church was, how big her	
5	family was with her. She had a large family. I'm just	
6	here to speak about the neighborhood and how much she	
7	was beloved. And people will say she needled us, but	
8	only when she needed to and it was always lovingly,	
9	and it was always because she knew what was best for	
10	us, and as we wonder now what to do, we only need to	
11	think about what she told us before, and that's how	
12	we carry on. I don't want to take up too much of your	
13	time.	
14	CHAIRPERSON KRISHNAN: Thank you so much	
15	for your testimony. I'm sorry for your loss, but I'm	
16	glad that someone, an incredible New Yorker like her,	
17	will now be part of our streets in New York City to	
18	remember her legacy. Thank you for your testimony.	
19	We now have James Robert, Jr.	
20	We've also been joined by Council Members	
21	Menin and Paladino and Carr.	
22	JAMES ROBERT, JR.: Good morning. I met	
23	Linda Carter Cooper about 30 years ago when I became	
24	involved with St. Matthew's and St. Timothy's, and I	
25	quickly became a youth leader, and I had three of her	

2 four kids with me and I noticed something with these 3 children. They behaved, and they just didn't get in 4 trouble, although they could have. They didn't get in 5 trouble because of Linda, and so that worked for dozens and dozens, hundreds of children, with Linda 6 7 helping them out, helping to keep them straight, 8 through her work at Brandeis School, through her work 9 in the church down the block at 26 West 84th Street but, more importantly, from her work on the street. 10 11 She would hold court, we joke, on the corner of 84th 12 and Amsterdam by the garden that she helped to get 13 put open after they took the garden that she built, 14 almost with her own hands, next to her building on 15 84th Street, and everybody, everybody loved Linda 16 because they knew that they could come to her and 17 say, we got this problem, we got this, this landlord 18 has given us a hard time, or we can't get Con Ed to 19 work with us. Linda would find a way. Dozens and 20 dozens and dozens and dozens of families have 21 benefited from her presence on 84th Street, as I did 2.2 too. I implore you to allow the neighborhood to 23 remember her. Thank you.

2	I'd next like to call up Gary Cooper.
3	GARY COOPER: Good morning. I lost it. I
4	lost it.
5	CHAIRPERSON KRISHNAN: If you'd like, we
6	could call up another witness in the meantime while
7	you look for your testimony.
8	GARY COOPER: I'm there, I'm sorry.
9	CHAIRPERSON KRISHNAN: Sure, don't worry,
10	take your time, but didn't want to rush you either.
11	GARY COOPER: Okay. I'm sorry about that.
12	CHAIRPERSON KRISHNAN: Don't worry.
13	GARY COOPER: Linda Carter Cooper was born
14	in West Palm Beach, Florida. She and her husband
15	migrated to New York in the early '70s. At that time,
16	the Upper West Side was not a very safe place for
17	families to live. Seniors in the area was often shut
18	in and was fearful. Linda somehow gained their trust
19	and confidence. She would bring them outside into the
20	garden in the middle of the block on 84th Street
21	between Amsterdam and Columbus. There, they would
22	garden and sit around and enjoy the outdoor. Linda
23	Carter Cooper became a dedicated advocate for the
24	seniors and ensuring they received all the necessary
25	services, including legal and medical support. Every

2	holiday, she and her family would prepare food for	
3	all the seniors that she knew in the community before	
4	sitting down to her own family meal. They trusted her	
5	and relied on her. She served as their spokesperson.	
6	Linda Carter Cooper became an advocate for the youth	
7	in the community, creating opportunities and outlets	
8	for them through programs in tennis, basketball,	
9	baseball, football, which she and her family	
10	organized. She was deeply involved in supporting the	
11	educational needs of the youth, visiting schools	
12	wherever she was needed, advocating on behalf of the	
13	children in the community. She even hung an extension	
14	cord out of her apartment window to power basketball	
15	tournaments held in PS9 Yard next to her home.	
16	Together with her husband, she organized sports	
17	teams, social gatherings for all the kids in the	
18	area. Linda also advocated the legal [TIMER CHIME]	
19	CHAIRPERSON KRISHNAN: That's okay, you	
20	may finish.	
21	GARY COOPER: Can I continue? She also	
22	organized legal services for the youth, keeping	
23	lawyers on speed dial due to the frequent unjust	
24	profiling of the local kids. She educated the	
25	parents, accompanied them to court, and sought legal

2	advice and political support to counteract this
3	unfair treatment. She would also take the children to
4	the museum, introduce them to different aspects of
5	the city, always emphasizing it's not where you
6	start, it's where you finish. In addition to her work
7	with the seniors and the youth, Linda Carter Cooper
8	was a political activist in the community. She
9	educated people about the power of their vote and
10	worked for the Board of Elections for 40 years as a
11	coordinator. She canvassed the neighborhood, knocking
12	on doors to encourage people to vote, starting in the
13	early '80s with City Council Member Ruud Messinger
14	continuing to support all the local politicians, such
15	as Jerry Nadler, Scott Stringer, Mark Landis, and of
16	course, my heart, Gale Brewer. Linda and her husband
17	created an Angels program, a mentoring program that
18	has been running for over 30 years. This organization
19	used basketball and other activities to keep kids off
20	the street and involved in positive community
21	engagement. Every year, college graduates come back
22	to thank her for the pivotal role she played in their
23	life. Linda was married to Gary Cooper and had four
24	children, Taniqua, Gary, Shafiq, and Sanaa Cooper, as
25	well as a grandson. She worked and lived on the Upper

2	West Side her entire life. Sitting on the corner of
3	the northeast corner of 84th Street after mass, there
4	she would listen to the residents' concern, always
5	keeping her finger on the pulse of the community.
6	Besides being a devoted wife and mother, Linda was a
7	community activist, deeply religious and spiritually,
8	and dedicated to bettering the lives of everyone
9	around her. Her family and friends continue her
10	legacy to this day. This is just a small glimpse of
11	Linda's life. Linda usually had a saying, if you
12	don't know, ask somebody. This morning, I'm asking
13	each and every one of you to pass this petition for
14	my wife. Thank you very much.
15	CHAIRPERSON KRISHNAN: Well, thank you so
16	much, Mr. Cooper. Your wife sounds like an incredible
17	woman. I know we'd be honored to move this
18	legislation forward today in her honor and on behalf
19	of you all.
20	I'd like to also recognize that we've
21	been joined by the sponsor of this incredibly
22	meaningful street naming today, Council Member Gale
23	Brewer.
24	We have two more witnesses to call. The
25	next one is Judith Gorsuch.

2 JUDITH GORSUCH: My name is Judith 3 Gorsuch. Linda was a guiding light to countless young 4 people in our neighborhood. She devoted many hours to the Angels basketball program at the Church of St. 5 Matthew and St. Timothy. This program was open to all 6 7 the children in the neighborhood. She provided a 8 listening ear to many of the program's participants. 9 Students felt comfortable approaching her with their school issues and sometimes came to the Cooper home 10 11 for moral support and encouragement. Linda, along 12 with Tony, stressed the importance of education and 13 encouraged young people to do their best in school, and they were fortunate enough to see many of these 14 15 young people grow up, graduate from college, and in 16 graduate school and come back and let them know about 17 it. Linda often went to bat for program participants 18 and neighborhood youngsters who were falsely accused 19 of wrongdoing. She was a caring figure for many young 20 people in the community, and they reached out to her 21 when they were frightened. She was tough, and they knew that she would not be afraid to take a stand for 2.2 23 them. She was also a trusted friend to her neighbors and served the community for years. She was on the 24 Board of Elections, active in many tenants' 25

2	associations, and as you've already heard, stood up
3	for many people who were in need of housing. She was
4	the eyes and ears of the neighborhood, keeping track
5	of the ups and downs of neighborhood lives. There
6	were always small gifts for new babies and birthdays.
7	There were meals, emergency cash at times, and above
8	all, a listening ear and encouraging word when a
9	neighbor was in need. When you walked down the street
10	with Linda, so many people, young and old, would call
11	out to check with her. She was a wonderful mentor and
12	protector for our neighborhood, young people, and she
13	was an official mother, aunt, and sister to the
14	entire neighborhood. It would be a fitting tribute to
15	name the corner of West 84th Street and Amsterdam
16	Avenue in honor of Linda Carter Cooper, recognizing
17	her years of work in the neighborhood and her
18	dedication to the surrounding community. Thank you.
19	CHAIRPERSON KRISHNAN: Thank you so much,
20	Ms. Gorsuch.
21	And our final witness is Lyndie Callan
22	for Monnie Callan Way.
23	LYNDIE CALLAN: Good morning.
24	CHAIRPERSON KRISHNAN: Good morning.
25	
l	I

2 LYNDIE CALLAN: When I undertook this 3 project, I was thinking small but, once I got going, 4 searching the farmer's market in the neighborhood for people to sign a petition, folks who knew and 5 respected my mother came out of the woodwork. I got a 6 7 letter of support from George Gresham, president of 1199 SEIU Health and Hospital Workers, a union of 8 9 450,000 strong. How did I do it? I asked. Monnie had worked to get George elected many years ago. They 10 11 knew one another, Natch. I did not seek a letter from 12 Jerry Nadler, but he knew Monnie, as did Gale Brewer, Ruth Messinger, and the former executive director of 13 14 Goddard Riverside Community Center, Stephan Russo. 15 Monnie was part of the fabric of the old guard that 16 made the Upper West Side great. Often after a long 17 day's work, she would head out to a meeting on 18 tenants' rights or to strategize with others 19 dedicated to ending the war in Vietnam. This was all 20 in addition to her paid job as a social worker, which 21 she took seriously. She seemed to have boundless 2.2 energy, rallying, marching, striking alongside local 23 politicians and neighbors to make the Upper West Side, the United States, the world a better place. At 24 an advanced age, she accompanied retirees from her 25

2	union to Washington to meet with First Lady Michelle
3	Obama to discuss health care and challenges facing
4	seniors. In her 90s, when Monnie had dementia, and I
5	told her I was writing postcards to encourage people
6	to vote, she said, I want to help. It took me many
7	years to understand how important she was and how
8	many people genuinely loved and respected her and the
9	work she did. Co-naming a street in her honor will
10	give credence to the expression, because of them, we
11	can. Thank you.
12	CHAIRPERSON KRISHNAN: Thank you so much,
13	Ms. Callan, and I couldn't think of a more fitting
14	way to remember your mother's legacy than today's
15	street naming legislation.
16	Before we call the vote, I wanted to see
17	if Council Member Brewer had any remarks.
18	COUNCIL MEMBER BREWER: No, I knew both
19	people, both terrific, wonderful representatives, and
20	we look forward to seeing their sign up on the
21	lampshade posted. I'm really excited because in
22	addition to all of these votes, you know that the
23	City's municipal library now has a website which
24	lists every single person who's ever been up on this
25	co-naming, and I'm excited that people will remember.

2	and we're trying to get Google to include it in
3	Google Maps and then people could look up and see the
4	name so these two, everyone I'm sure here is equally
5	important, but these two individuals, known to me,
6	will add to this great array of New York City's
7	history. Thank you.
8	CHAIRPERSON KRISHNAN: Thank you so much,
9	Council Member Brewer.
10	This is a perfect example of why our
11	street namings are, as I said, so much more than
12	naming the streets, but leaving a permanent imprint
13	on the landscape of New York City for these great
14	individuals.
15	With that, I call on the Clerk now to
