SERGEANT-AT-ARMS: Good morning. This is a microphone check for the Committee on Governmental Operations, State and Federal Legislation. Today's date is November 12, 2025. Location is Hearing Room 3, recorded by Ginelle Yearwood.

CHAIRPERSON RESTLER: [GAVEL] Thank you very much, and good morning to all. Still good morning, but just barely. My name is Lincoln Restler, and I have the privilege of chairing the Committee on Governmental Operations, State and Federal Legislation, at least for 45 more days.

I'd like to start off by thanking all of those who've joined us at today's hearing. Council Member Schulman of Queens, Council Member Brewer of Manhattan, former Chair of this fine Committee, Brooklyn's own David Carr, our newest Member of our

Committee, Frank Morano from Staten Island, and Jim Gennaro is here in the flesh. Good to see you all.

Thank you, guys, for being here.

We will be voting on Intro. 1250, sponsored by Brooklyn's own David Carr. This bill will require every single community board, borough board, or advisory board to publish its bylaws online. It will also require those entities to regular update their published bylaws after making any changes to them. This bill will ensure public awareness about the functions and operations of government entities. As a co-prime sponsor of Intro. 1250, David, I've been with you since day one on this one, I believe it is a necessary good government practice to help ensure community and government meetings are accessible to all. This is such a simple but critical reform. There are too many community boards and other institutions out there that do not post their bylaws online, and it creates confusion where there shouldn't be.

I'd like to invite Council Member Carr to offer some remarks.

COUNCIL MEMBER CARR: Thank you, Chair.

This is an important piece of legislation, as the

Chair was just outlining, and I want to thank him in particular for signing on as a prime co-sponsor and really championing this, a long-time advocate for government reform and transparency even before your tenure in the Council, so I thank you for that and your support in this legislation. Because it's true that a lot of people find the institutions that should be closest to them difficult to navigate, and that's our community boards, our borough boards, and other institutions. And we've been very fortunate in this city that we have a lot of long-time members of those boards who probably know things by rote. But when members of the public come for the first time as a concerned citizen advocating on behalf of a cause that's important to them, when we have new members who are joining those institutions, everyone should be on an even playing field when it comes to knowing the rules, the rules that govern the way those institutions work. And oftentimes that has not been the case. And I think it's even more critical when we keep in mind that in 2027 and 2028, community board term limits will come into actual effect for the first time and members who have served for decades will be leaving those boards. So, this is an
