**Summary of Legislation:** This legislation requires that the Department of Social Services (DSS) make all benefits and cash assistance applications available via a web form, provided that such online access complies with state and federal law.

**Effective Date:** 120 days after enactment

**First Fiscal Year with Full Impact:** Fiscal Year 2026

**Agencies Impacted:** Department of Social Services
