FISCAL IMPACT STATEMENT

PROPOSED INT. NO.: 794-A

COMMITTEE: Children and Youth

TITLE: A Local Law to amend the New York city charter, in relation to the composition of the youth board

SPONSORS: Council Member Stevens, Banks, Louis, Salaam, Brewer, Brooks-Powers, Narcisse, Hanks, Hanif, and the Public Advocate (Mr. Williams)

SUMMARY OF LEGISLATION: Proposed Int. No. 794-A would require that the mayor and the council make efforts to appoint members to the youth board who have demonstrated relevant experience in the area of youth welfare. Additionally, this bill would require at least 1 member of the board to be between the ages of 16-24, in order to ensure actual youth representation.
