voucher # 0458621 was illegally  
terminated or given to someone  
after requesting <sup>to be</sup> port out to  
California.

We are currently homeless  
and in shelter. But we have been  
denied shelters here in New York  
from 2018 to 2019.

My 26 year old has Type 2  
and severe mental disease



we have no income to afford housing  
because of identity theft that  
resulted ~~with~~ my children  
social security benefit stolen  
~~or being~~ by a third party who  
has no relationship or contact  
with any 2 children.

My 18 year has never attended  
school since age 13 years old due  
to homelessness and moving him  
around from state to state, continent  
to continent.

We have at times been sleeping  
on the streets, for the past 2 years.  
~~For~~ For example we moved to Utah 54  
last year after 9 months in shelter  
without any housing assistance. ~~We~~  
I ~~were~~ spend sleeping on the streets.
