Int 1095-2013 A Local Law to amend the administrative code of the city of New York, in relation to creating a manual on flood construction and protection standards.

A Local Law to amend the administrative code of the city of New York, the New York city building code, the New York city mechanical code and the New York city fire code, in relation to relocating and protecting building systems in flood-prone areas.

Int 1097-2013 A Local Law to amend the administrative code of the city of New York, in relation to requiring backup power sources for

fire and life safety communications systems.

A Local Law to amend the administrative code of the city of New York, in relation to improving hazardous materials storage pursuant to the New York city community right-to-know law.

Int 1105-2013 A Local Law to amend the New York city charter, in relation to planning for resiliency to climate change as a responsibility of the office of long-term planning and sustainability.

Res 1708-2013 Resolution calling upon the United States Congress to enact and the President to sign the Flood Victim Premium Relief Act of 2013.

Res 1771-2013 Resolution calling upon the New York State Legislature to pass and the Governor to sign S.3942/A.4380, the "Engineers', Architects', Landscape Architects' and Land Surveyors' Good Samaritan Act" which would protect from liability professional engineers, architects, landscape architects and land surveyors

who render voluntary services at the scene of a natural disaster or catastrophe.

Res 1808-2013

Resolution calling upon the United States Congress to amend the Biggert-Waters Flood Insurance Reform Act of 2012.

Jointly with the Committee on Housing and Buildings the Committee on Parks and Recreation the Committee on Transportation and the Committee on Waterfronts
