3	enjoyed it our collaboration throughout the whole
4	budget process and the negotiations and,
5	particularly, in the area of capital funding,
6	something that is difficult to understand. You
7	certainly had a grasp of all of it and I'm most
8	grateful to you, Council member Rosenthal. And also
9	to Council member Gibson, I saw her. I don't know if
10	she's presently in the room here, but okay. Okay.
11	That's right. She's not. Yeah. Okay. So thank you
12	to all of you. Together we work hand in hand to get
13	the work that needed to be done. I'd also like to
14	thank the incredible hard working staff of the
15	Council's Finance Division. Your dedication is
16	recognized and very, very much appreciated. And, of
17	course, a very special thank you to the entire staff
18	of the Finance Division for supporting us over these
19	past four years with a special thank you to the

2 CHAIRPERSON DROMM: Thank you, Latonya. 3 It's been amazing. This is that and this is where that money is 16 and this is where this money is. And, of course, 17 we've maintained that relationship over the last 12 18 years. 8	the Finance Committee in the previous eight years,
9	but due to the staff and, in particular, Nathan and
10	others, I got to learn it quick. So, thank you,
11	Nathan, for that. I also want to say thank you to
12	our sergeants who are here. Thank you, sergeants,
13	for your work always protecting us.

15	CHAIRPERSON DROMM: There was a time,
16	sergeants, when somebody approached the dais rather
17	aggressively and you had to get me off the dais
18	rather quickly and into the other room and I will
19	never forget it and I am most grateful to you for
20	that protection. Thank you very much. Of course, to
21	Carl Dalva who is here. Carl, thank you. What a
22	great director of our security team

24	CHAIRPERSON DROMM: here and our
25	sergeants. Thank you, Carl, for everything, also.

2 You are a fantastic friend. You're more than just a 3 colleague. You're a friend. Thank you so much. And 4 to everybody that I have interacted with here in the Council, my colleagues who are here today--5 of course, Council member Koslowitz, Council member 6 7 Cornegy, Council member Cumbo, Rosenthal, Council 8 member Grodenchik, Adams, Ampry-Samuel, Ayala, 9 Powers, Louis, Diaz, and Brook-Powers, thank you all for working so closely with me, as well, and for 10 11 being on our BNT and making sure that our budget 12 priorities are correct and that we really serve the 13 most needy in New York City. And I think that, over 14 the last four years, we have ensured that that 15 happens here on this committee and I'm most grateful to all of you. I know a number of you are going to 16 17 be leaving and going on to better and greener 18 pastures and I wish you luck in all the things that 19 you're going to do and I just want to say how 20 grateful I am to have served with such a wonderful 21 team on this committee. Thank you very much. 2.2 [applause] 23 CHAIRPERSON DROMM: There are other members who I did not mention who are not here, but I 24 thank them, as well. Just because they're not 25

2 present, I'm not going to say their names, but I want 3 to thank them. They are included in that group. 4 So, now turning to today's business, the committee will be voting on four items: an expense 5 budget modification, a revenue budget modification, 6 Intro 2470, a transparency resolution, and a pre-7 8 considered resolution relating to the Taxi Medallion 9 Relief Program. Let's start with the budget modifications. The first modification is an expense 10 11 budget modification that represents movements of 12 approximately \$1 billion of funding between and 13 within city agencies to implement expense budget 14 changes which are reflected in the November Financial 15 Plan and the Council previous transparency 16 resolutions. The second is a revenue budget 17 modification that recognizes \$895 million a new revenues and in additional 69.7 million from the 18 19 general reserve implementing changes reflected in the 20 November Plan. Of these funds, the total amount of 21 \$964.7 million is added to the Budget Stabilization Account which will prepay debt services for fiscal 2.2 23 2023. The third item in is Introduction 2470 which would, among other things, extend the date by which 24 the fiscal 2023 preliminary budget must be released 25

from January 16th, 2022 to February 16th, 2022. 2 3 Next, we have the transparency resolution. The 4 transparency resolution sets forth in the new designation and changes in the designation of certain 5 organizations receiving local, aging, anti-poverty, 6 7 and youth discretionary funding and funding pursuant 8 to certain initiatives in the budget. As with all 9 transparency resolutions, Council members will have to sign a disclosure form indicating whether or not a 10 11 conflict exists with any of the groups on the 12 attached list. If any Council member has a potential conflict of interest with any of the organizations 13 14 listed, he or she has the opportunity to disclose that conflict at the time of their vote. As a 15 reminder, please disclose any conflicts you may have 16 17 with proposed subcontractors used by organizations 18 sponsored by discretionary funding. These 19 disclosures must be made before the subcontractor can 20 be approved. Disclosure forms must be completed and 21 submitted prior to the vote on the transparency resolution and may be emailed to Charles Davis. 2.2 23 Lastly, we have the pre-considered resolution, sponsored by Council member Lander, to support future 24 additional funding for the Taxi Medallion Relief 25

On November 3rd, the Mayor and Senator 2 Program. 3 Schumer announced a city funded equity contribution 4 of \$30,000 permit Dalian and a \$50 million city 5 funded deficiency guaranteeing for loans that were restructured as part of the program with the aim us 6 reducing interest rates and capping debt service 7 8 payments. The \$50 million will be dispersed to a 9 third-party entity to provide the guarantee. The Council recognizes the public importance of 10 11 supporting medallion owners and helping them to 12 restructure their loans. To strengthen the 13 deficiency guaranteeing, this resolution expresses 14 the Councils support for the deficiency guaranteeing 15 the subject to future appropriations to the extent 16 that any future shortfall in loan payment by taxi 17 medallion owners with restructured loans is not 18 covered by the sale of medallions following such 19 defaults or funds available from previous 20 appropriations of the Council for said purpose. And 21 this is an issue that is particularly important to 2.2 me. I represent a number of medallion owners in 23 Jackson Heights Queens and I am really glad to see that we have been able to resolve this issue in favor 24 of our medallion owners. So, with that, I am going 25

2	to ask are there any questions on any of the items?
3	Okay. Seeing none, I also want to take a moment to
4	thank Billy Martin, who is not here today, but Matt
5	DeStephano is. And the committee clerks for their

So, I thank you for all 6 7 of the work, the time, the energy, the hours with us, 8 but also, particularly, with the public because 9 you've been an open voice for the public to be able to share their views, their concerns and taking those 10 11 views and concerns and shaping them into policy. So 12 I thank you so much. I thank the entire finance 13 Definitely my sister girl-Sister Pope as we team. always call her, Latonya, and happy birthday to you. 14 15 Rebecca, thank you for keeping on top of me and making sure that I'm always on time and present and 16 17 here as best as you can. Nathan, thank you so much 18 for always taking my calls, particularly as it 19 relates to capital issues. Regina, shoutout to you, 20 as well. And the whole team. You all have been 21 really phenomenal and fantastic and I proudly vote 2.2 aye. Thank you. 23 CHAIRPERSON DROMM: Thank you, Madam Majority Leader. 24

2 COUNCIL MEMBER ROSENTHAL: Permission to very quickly explain my vote? 3 4 CHAIRPERSON DROMM: Yes. 5 COUNCIL MEMBER ROSENTHAL: I vote aye on all and, again, congratulations, Chair. You have 6 7 been a badass Finance Chair leading us very 8 thoughtfully and with real wisdom. I appreciate 9 that. I also want to send congratulations and appreciation to the staff. Latonya, Regina, Rebecca, 10 Nathan-- Nathan, in particular. You have really 11 12 helped me understand the capital budget and come up 13 with some great zinger questions that actually have 14 changed the way the city does business. CHAIRPERSON DROMM: Thank you, Council 6 7 member Koslowitz. And it is true. I was asked to serve and convinced to serve by you and it has been a 8 9 wonderful and it has been the honor of my life to serve as the Chair of the Finance Committee. I mean, 10 11 just to serve in the City Council, but as Chair of 12 the Finance Committee, in particular. So thank you for convincing me to take this position. Thank you 13 very much. And I believe we have our vote tally is 14 15 done and I don't think there's anybody else coming to 16 vote. No. Okay. So, with that, this meeting is adjourned at 11:20 in the morning.
